He stated, as we are in the final quarter of 2024 and approaching the new community board appointment cycle for 2025. Our office wants to remind the board to be diligent on attendance and applying for reappointment. As we get closer to 2025, we will provide more information to the board, general public and all those interested in the application process. He acknowledged the Community Boards and the local civic organizations for their assistance and support in helping us ID overgrown medians in need of maintenance and sanitation services. The Borough President held a press conference in August, urging Parks, Transportation, and Sanitation to get together and address these overgrown and trash-strewn medians across Queens. The QBP's office submitted over 205 locations to the city agencies to address the neglected medians throughout the borough. Since then, the city has made efforts by addressing several sites but there is plenty of work to be done.

Captain Mo Tsang - 107th Police Precinct Commander

There was a shooting on Friday, October 4, 2024 at Parsons Boulevard in Flushing. A warrant has been issued for the suspect. There is an uptick in car thefts. Most of the thieves are coming from other boroughs into our command and stealing cars.

He announced the Trunk or Treat Event to be held on October 26th from 11 a.m. to 3 p.m. at Cunningham Park, the upper lot.

NYC Public Advocate Jumaane Williams

He introduced himself and stated he was happy to be able to attend our meeting. He spoke briefly on how crime is going down in the city. He also mentioned that he will be walking in the Halloween Parade on October 31, 2024.

The "City of Yes" – He stated that it was a very complex issue. He will attend one of the City Council's public hearings to give his input. The City of Yes proposal that was presented by the mayor will not be the final one. There will be changes made. When asked about the migrant crisis causing the need for housing and The City of Yes, he stated that the city had over 65,000 homeless New Yorkers prior to a single migrant coming to our city. The administration found funding in the budget to pay to house the migrants while they wouldn't use these same funds to help our own homeless New Yorkers.

The Honorable James F. Gennaro

He spoke about the proposed 50-story buildings going up at 71-12 Park Avenue. It is expected to have 850 units and an underground garage featuring 60 parking spaces. Although, the work hasn't been approved at this site, work is going on. He, along with the community, is not happy with this project. He is in contact with the Department of Buildings as this is unacceptable. He is also in contact with Jimmy Otto, Buildings Commissioner. Mr. Otto will gather all the information and get back to him.

Anthony Whitaker, Assistant Director of Community Affairs at Sanitation

Businesses must currently containerize their garbage. The fines for not doing so or for putting garbage out early are: \$50 for the first offense, \$300 for the second and \$500 for the third. If you see this violation happening, file a 311 complaint and/or reach out to the community board. Enforcement will go out.

Residential Containerization - Starting **November 12, 2024** all residents of single-family homes, two family homes and residential buildings with up to 9 units will be required to containerize their trash. The department will remove your garbage from the curb only if it is in a bin with a secured lid. Whatever trash bin you are currently using is fine as long as it is no bigger than 55 gallons and has a lid that fits securely on top. There is a warning period from November 12, 2024 to January 1, 2025. Starting on January 2, 2025 you may receive a summons for failure to use a container with a secured lid to put out your trash.

The **NYC Trash Cans** are available for purchase now; however, you are not required to have those yet. If you do, great. Nevertheless, you will be **required** to have them by June 2026.

Health Minute – by *Dr. Penny Stern*

(The following information comes from the Health.gov website.)

Health Literacy Month. This has been recognized for the past 25 years. What is health literacy exactly? It's been defined in 2 ways: personal health literacy and organizational health literacy. According to Healthy People 2030, personal health literacy means the degree to which individuals have the ability to find, understand, and use information and services to inform health-related decisions for themselves and for others while organization health literacy is the degree to which organizations equitably enable individuals to find, understand, and use information and services to make health-related decisions and actions for themselves and others. When people have limited personal health literacy, they are at greater risk for misunderstanding important information that is vital to their health. They may also have trouble navigating our complex health system. Similarly, living in communities served by organizations that lack organization health literacy can affect the quality of health care people receive and, therefore, their outcomes. A national action plan has been put into place to improve health literacy.

Then, we have National Breast Cancer Awareness Month, when we try to raise awareness of the importance of early diagnosis of this very prevalent disease. Encouraging people to be screened via mammography is a key component in this awareness initiative.

October is also National Domestic Violence Awareness Month. Everyone needs to be educated about domestic violence, also known as intimate partner violence and its destructive power on individuals, families, and the community as a whole.

We've just recognized National Youth Sports Week when we celebrate the positive and physical and mental impact of sports participation for young people while striving to ensure that all young people will have the opportunity, motivation and access to play sports.

October is also Eye Injury Prevention Month, and Mental Health Awareness Month, National Check your Meds Day on October 21. The list goes on and on so please take a few minutes to see what observances are set for this month.

Do you operate a mobile car wash in New York City?

Here are some important DOs & DON'Ts



DO

✓ Have a valid Car Wash license

You must have a Car Wash license from the NYC Department of Consumer and Worker Protection (DCWP) if you engage in car wash activity (washing, detailing, drying, polishing, vacuuming, or other cosmetic care of vehicles).

The penalty for operating an unlicensed mobile car wash is \$100 per day. For more information about car wash penalties, visit nyc.gov/DCWPPenalties and see 6 RCNY section 6-67.

Exception: You do not need a Car Wash license if you operate a self-service facility, wash vehicles intermittently to raise funds for a nonprofit, or wash vehicles only as an ancillary service to a main service—for example, repair shop, car dealership, leasing agent—and do not offer car washing directly to the public.

✓ Obey all federal, state, and City laws and regulations

City laws and regulations include those enforced by DCWP, the NYC Departments of Environmental Protection (DEP), Transportation (DOT), Health and Mental Hygiene (DOHMH), and the New York Police Department (NYPD).

✗ Operate on private property without the permission of property owners

✗ Operate in the street, on highways, or in municipal parking facilities

✗ Park illegally or wash cars that are parked illegally

✗ Obstruct traffic in any way or violate other traffic laws
