The Minutes of December 11, 2019 Board Meeting were approved by 30 members.

<u>Chairperson Martha Taylor</u> – Marleah DesRuisseaux, our part-time staffer recently left to join the NYPD. The part-time Community Assistant position will be posted on DCAS, on our website and in the local papers. CB8 was not notified of the Queens Advisory meeting for the Queens Borough Jail. We emailed and explicitly asked to be notified in the future.

Rabbi Manes Kogan – He spoke at the rally against hatred and anti-Semitism. He asked for invites from the community so he can answer questions about his religion.

<u>Deputy Inspector Henry – 107th Precinct</u> – Last week Chief Barrere chaired a meeting with all the Jewish Community Leaders about hate crimes. He asked that if someone sees something to give them a call and they will do their best to address it.

<u>State Senator Leroy Comrie</u> – He attended the rally against hate in Foley Square. He gave a synopsis of issues he is working on in Albany. They passed a law allowing adopted children to find their birth parents.

A Word from the District Manager...

Dear Community Board 8 Resident:

According to the Coalition for the homeless, thousands of people stay in the streets of New York City. Additionally, there is one item that is most needed by them; however, it is seldom received through donation drives - socks!

How can we make a difference as a community? Community Board 8 Queens will be collecting brand new socks at our office now and until February 14th and at our next monthly meeting on February 12th at the Hillcrest Jewish Center. These socks will be distributed to the homeless through a not-for-profit organization - Hungry Monk. This is being done in conjunction with Borough President Sharon Lee's Queens Week of Service. Here are ten facts about socks and health [from www.thejoyofsox.org]:

- 1. According to the Mayo Clinic, in cold enough conditions, frostbite can occur in 30 minutes or less! Warm, well-fitting socks can prevent this for many people.
- **2.** Moisture-wicking socks are especially important for those facing the summer heat and humidity. By pulling sweat away from the skin, conditions such as infections and blisters can be prevented.
- 3. Many bacteria and fungi thrive in warm, moist environments. Access to clean, dry socks can go a long way in avoiding foot infections.
- **4.** Those with **diabetes especially need well fitting socks**, preferably Diabetic socks without seams that can rub and cause blisters.
- 5. Did you know that diabetic socks usually have invisible seams, and cause less friction on the skin? This can prevent skin injury, infection and even amputations.
- 6. One million Americans had Type 2 Diabetes in 2012. (American Diabetes Assoc.) Part of proper Diabetic foot care is access to appropriate sock wear.
- 7. Poor circulation puts feet at risk every day. Proper socks can provide a simple, but important layer of protection between these feet and limb threatening conditions.
- 8. Clean, well-fitting socks are a vital part of keeping feet healthy! The impact is immediate and ongoing!
- 9. Wearing the right socks for the right activity can go a long way towards foot health. Those struggling with homelessness don't have that option. But we can help!
- 10. Clean and well-fitting socks can be just as important as medication or insulin for those that deal with diabetes.

Please share this information with your friends and neighbors.

It takes more than City Hall to make New York City great, it takes us all!

<u>Department of Buildings – Anthony Iuliano</u> – He spoke about DOB's Homeowner's Night that is held every Tuesday night from 4-7 p.m. Some of the complaints received by DOB are converting garages into apartments and homes being rented to a large number of students. The Department hired additional inspectors for facades and additional staff to enforce inspections. Department of Small Business Services is working with the DOB and the City Council to create new commercial signage.

<u>Borough President Sharon Lee</u> – She will be acting Borough President until the special elections [3/24]; reminded the public of the importance to respond to the Census questionnaire; and the Queens Borough President's Budget Hearing. She also reminded the public that all Board Member applications will be accepted until January 31st.

Committee Reports:

<u>Health Minute with Dr. Penny Stern, Health Committee Chair</u>: Dr. Stern informed everyone about "Burnout" and the need for everyone to find ways to relieve stress.

Bhitihara Martha Fulton, Parks Committee Chair: In December the committee reviewed plans for upgrading the Redwood Upper Playground. The Board will send a letter of support.

<u>Queens Complete Count Committee (QCCC) - Kevin Forrestal</u>: Census 2020 – All Board Members received an email outlining what occurred at the last QCCC. In the report there is a timetable that outlines how the Census will roll out between March 12th and April 27th.



Hyloh, a NYC-based woman-owned materials consulting group, in collaboration with Bard College's MBA in Sustainability program received a small grant from the Citizens Committee for NYC to work on a research project regarding local reuse and repair are interested to hear from you!

Queens Botanical Garden is an urban oasis where people, plants and cultures are celebrated through inspiring gardens, innovative educational programs and demonstrations of environmental stewardship.


Queens Botanical Garden (QBG) is a private non-profit cultural institution located on 39 acres of New York City public land in Flushing, New York. In FY19, the Garden served over 263,000 visitors, including 34,856 schoolchildren. A recently completed visitor survey reveals that 45% of visitors speak a language other than English at home. This fact underscores the importance of the mission and the challenges and opportunities QBG faces daily in creating programs, exhibits and landscapes that serve the needs of people who live in and visit one of the most ethnically diverse counties in the nation. The Garden has committed itself to addressing the complex and ever changing needs of its diverse community and to being the place where people, plants and cultures meet.

We are seeking individuals with an interest in public horticulture to assist with gardening work during the 2020 growing season. Duties and responsibilities include assisting horticulture staff in the planting, cultivating, and care of trees, shrubs, flowers and other flora as well as leading a group of 5-6 student youth in these same tasks for 6 weeks in July and August.

Duties include:

- Preparing soil, planting, weeding and mulching.
- Fertilizing and watering.
- Pruning and grooming trees, shrubs and plants.
- Mowing Lawns.
- Operating and caring for hand and power gardening tools and equipment. Sharpening and general upkeep of grounds tools.
- Garden Assistants must be available to supervise teens as part of the City's Summer Youth Employment Program (SYEP) in July and August.
- Under the supervision of QBG horticulture staff, Garden Assistants will be expected to work with volunteers who may come to us as individuals or as part of a group.

Positions are available for up to 28 hours per week from mid-March through mid-October with possible extension into November and include some weekend work. A flexible schedule may be worked out to accommodate school or other needs.

 Forms W-2, 1098, 1099, or income and expense records if you are self-employed (Go to nyc.gov/taxprep for a list.)



Other

- 2018 tax return or transcript (if available)
 To request a transcript, call the Internal Revenue Service (IRS) at 1-800-908-9946
- or visit irs.gov and search "Get Transcript."


 □ Proof of health insurance coverage or Health Insurance Exemption Certificate for you, your spouse, and your dependents
- Payment records for child care, including the provider's name, address, and Employer Identification Number, Taxpayer Identification Number, or Social Security number
- Records of educational expenses such as Form 1098-T for tuition payments to attend a university or technical college or Form 1098-E if you paid student loan interest
- Account and routing numbers for direct deposit of your refund

If you are filing a joint return, both spouses must be present.
