October's Virtual Community Board Meeting Re-cap

The Minutes of the September 14, 2021 Board Meeting were unanimously approved by 40 members.

Due to technical difficulties Chairperson Martha Taylor was unable to chair the meeting. 1st Vice Chair Michael Hannibal led the meeting on her behalf.

Chairperson's Report – 1st Vice-Chair Michael Hannibal:

The issue raised by Kevin Forrestal on behalf of the Queens Civic Congress (QCC) should be addressed by the Buildings and Housing Committee chaired by Florence Fisher.

We received notice that Project #HWS2020Q2 started this month to repair the sidewalks damaged by Storm Isaiah last year. Our office has been in contact with Christy Germain, the DDC Liaison for the project. While she has not submitted a detailed work schedule for us are yet, she assured us that DDC is scheduled to complete work at 147 locations in Queens by Thanksgiving. This includes 38 locations in CB8. They are working in several community districts simultaneously. They are currently working in CBs 14, 13 and 12. We expect a schedule by the end of next week.

Elected Officials' Announcements:

<u>Honorable Senator John Liu</u> – They finally got all the educational funding in place to all public schools throughout the state. The funds are available, but tax rates had to be increased. [*Due to technical difficulties Sate Senator John Liu was unable to complete his presentation*]

Commanding Officer Kevin Chan – 107th Precinct

They had a homicide back on October 2nd. It was the first one of the years in the 107th Precinct. It was also the first one since January 2019. Unfortunately, this happened late Saturday night on this day around 11:45 p.m. on 165th Street and 85th Avenue, north of Captain Tilly Park.. EMS responded and the victim was pronounced dead at the scene. Investigation is still ongoing.

The agency's biggest concern right now is grand larceny of autos. He suggested to everyone not to leave their cars on, not even for a one minute, turn it off to prevent this from happening. Phishing Attacks – Scams are happening more than often now. They are happening via email. He asked everyone to verify where the email is coming from and do not reply, make payments, or forward any suspicious emails. He also suggested all homeowners to have security cameras on the outside of the property for security purposes. In case of an emergency, there is footage to show the occurrence.

Guest Speaker:

Harold Miller, Deputy Executive Director of External Affairs – NYC Racial Justice Commission

Mr. Miller spoke about the Charter Revision. These are some of the main highlights of the presentation:

- The Racial Justice Commission was founded earlier this year by the Mayor on March 23rd. It is empowered as a Charter Revision Commission and appoints 11 Commissioners including Chair Jennifer Jones Austin and Vice Chair Henry Garrido.
- The NYC Charter sets out the structure, powers, and responsibilities of New York City's government.
- The Charter Revision Commission conducts comprehensive review of the Charter, report son findings, recommends proposal to amend, draft proposed amendments to the Charter for consideration by voters.
- Their vision for racial equity is to make sure that worth, talents, and contributions of all people in society are valued and recognized; race is not determinant of economic, political, social, or psychological outcomes, as it neither confers privilege nor denies opportunities.

They will have public engagement in October-November 2021. Their final report and ballot proposals will be issued in December 2021. To learn more about the Commission's work, you can visit their website at: www.nyc.gov.racialjustice.

FY'2023 Capital & Expense Budget Priorities:

Budget Director presented the budget items to be submitted for the Capital & Expense Budget for FY'2023:

Capital Budget Priorities were approved by 40 members with 0 opposition. Expense Budget Priorities were approved by 40 members with 0 opposition.

Committee Reports:

Health Committee – Health Minute with **Dr. Penny M. Stern**, Health Committee Chair Dr. Stern spoke about the FDA was asked by Merck, the drug company, to authorize emergency use for its pill called Molnupiravir for COVID-19 treatment in adults who are at risk for either severe disease, hospitalization, or both. If approved, it will be a very effective use with the vaccine since the vaccine is for prevention and the pill will be for treatment. It will be the first pill to be used as treatment. She reminded everyone that there is still about 68 million in the United States who are eligible to be vaccinated who have not gotten vaccinated, which makes it really essential to have effective drugs to control the future waves of infections that are yet to come. The case load in the U.S. has dropped below 100,000 on average for the first time in over two months. Death are now down from about being 2,000 a day to 1,700. It is still not where we want it to be, but it is certainly looking brighter. She asked everyone to take care of themselves and wished them well!

Additional Clean-up in Council District 24

As part of his ongoing effort to boost the quality of life in the community, Council Member James F. Gennaro revealed a series of clean-up initiatives throughout the district. Gennaro was joined by DSNY Commissioner Edward Grayson and community leaders to announce new partnerships with DSNY, the Wildcat Service Corporation, and The Doe Fund. The Council Member allocated a total of \$430,000 in this year's budget cycle for clean-up efforts targeting litter and graffiti – including \$185,000 to Wildcat, \$150,000 to the Doe Fund, and \$95,000 to the New York City Department of Sanitation (DSNY).

"I am thrilled to partner with DSNY, Wildcat and The Doe Fund to offer much-needed supplemental sanitation services throughout the district," Council Member Gennaro said. "I am confident that these partnerships will make a visible difference in our communities, and I remain committed to making this district the cleanest it has ever been. I would like to thank all of our stakeholders here today for their hard work to keep our city clean."

Council Member Gennaro's partnership with DSNY will add sanitation services along Union Turnpike from 164th Street to 188th Street; and Main Street from Melbourne Avenue to 77th Avenue. There will be two additional service days, including basket and road servicing, as well as cleaning and maintaining the median along Union Turnpike. The partnership with DSNY will also add sanitation services along Main Street, from Grand Central Parkway to Queens Boulevard, with two additional service days for street trash pick-up and road servicing along this route.

Gennaro's partnership with the Wildcat Service Corporation will regularly target trash-prone areas, including Hillside Avenue – from Sutphin Boulevard to 173rd Street – three times a week year-round; as well as the Grand Central Parkway Service Road – between 188th Street and Utopia Parkway – once every two weeks. Additionally, Wildcat will provide clean-up services for public spaces in his entire district upon request. Notable services include graffiti removal, snow removal, and cutting up/bagging large tree limbs and grass for DSNY to later pick-up.

The Council Member's partnership with The Doe Fund will regularly service trash-prone areas, including the Main Street Business Corridor – more specifically Main Street between Melbourne Avenue and 77th Avenue (twice a week); and Queens Boulevard, from Main Street to Hillside Avenue (twice a week).

The Department of Transportation, our elected representatives and community leaders joined to announced the completion of the 73rd Avenue Roadway safety improvement project on October 22, 2021.

These improvements include:

- Install standard bicycle lanes and shared bike lanes. Install curb-adjacent bike lanes where feasible.
- New lane markings
- Left turning lane on 73rd Avenue and Francis Lewis Boulevard
- Bicycle connection from Cunningham Park to Alley pond Park
- Upgrade existing crosswalks to high-visibility crosswalks

These improvements' major goal is to make the road safer for all New Yorkers - motorists, cyclists and pedestrians alike.

It takes two...


As the COVID-19 pandemic enters another winter, physicians and other health care experts are again concerned with a possible "twindemic." The combination of the current surge in COVID-19 cases driven by the Delta variant has pushed the health care system to its—breaking point. This means that patients who are seeking treatment for other ailments,—including influenza, may not be able to find the care they need. That is why it is more—important than ever for every patient who is eligible to be vaccinated both against the flu and COVID-19.

These vaccines can be administered at the same visit, as recommended by the Centers for Disease Control and Prevention (CDC) and its Advisory Committee on Immunizations Practices (ACIP). The COVID-19 vaccines—including those made by Johnson & Johnson, Moderna and Pfizer-BioNTech—and flu vaccines have been shown to reduce illness, hospitalizations and deaths.

Can be given with other vaccines

COVID-19 vaccines may be administered without regard to timing of other vaccines. This means COVID-19 vaccines can be co-administered with the influenza vaccine during the same visit. Giving all vaccines for which a person is eligible at the same visit is a best practice as it increases the probability people will be up to date on recommended vaccines.

But there are a few rare exceptions to the allowance of simultaneous vaccination. These instances generally involve children who have conditions such as asplenia, complement component deficiency or HIV infection. This is limited to PCV13 and Menactra vaccines, according to the CDC COCA webinar.
