Variances Pending Community Board 8 Q's Review/Vote

BSA Calendar No.: 2019-262-BZ Block 6628 Lot 84 141-55 77th Avenue Kew Gardens Hills, NY 11367

This application seeks a <u>variance</u> for the proposed enlargement of the existing synagogue [Young Israel of Queens Valley] from a two-story plus cellar to a three-story plus cellar:

- The proposed Floor Area exceeds the maximum permitted.
- ♦ The proposed Lot Coverage exceeds the maximum permitted.
- The proposed Side Yard is less than the minimum required.
- ♦ The proposed Rear Yard is less than the minimum required.
- ♦ The proposed Height and Setback are contrary to the applicable provisions.

BSA Calendar No.: 2019-277-BZ Block 7248 Lot 44 81-04 166th Street Jamaica, NY 11432

This application seeks a <u>variance</u> to build a house of worship whereby:

- ♦ The proposed Floor Area Ratio (FAR) exceeds the maximum permitted.
- ♦ The proposed Front Yard and Setback is less than the required 15'.
- ♦ The proposed Height exceeds 25'.
- ♦ The proposed minimum required Side Yard is less than the required 11".

BSA Calendar No.: 23-08-BZ Block 7248 Lot 44 182-69 80th Rd. a/k/a 80-14 Chevy Chase St. Jamaica Estates, NY 11432

This application seeks an amendment of a previously issued <u>variance</u> under BSA Cal. No. 23-08-BZ (the "Prior Variance"), to permit modification of the previously-approved plans. This would legalize the existing Synagogue by allowing a larger assembly space in the cellar with an accessory kitchen.

Honorable Council Member Barry Grodenchik (cont.)

He received a request from the representatives of the owners of the old Klein Farm to have it converted into a 6-story building. He explained to the applicants that he is against this project and suggested that this piece of land be donated to the City instead to have an outpost for the Queens County Farm Museum to serve the historic nature of this property. He will speak to the Mayor to see if they can receive funding to see what can be done.

Redwood Playground will be open very soon. They will be working on the Upper Playground and they will start construction on the Vanderbilt Motor Parkway.

Chairperson Taylor introduced Deputy Inspector Scott Henry and invited him to address the attendees.

<u>Deputy Inspector Scott Henry – 107th Precinct:</u>

He introduced the new Neighborhood Coordination Officers (NCOs) for Sector B: NCO Anna Golembiowski and NCO Christopher Ward.

Sergeant Burke is starting a project at John Bowne High School. They are working with the students educating them on how to react in dangerous situations.

D.I. Henry is working with the Precinct in coming up with an app to deal with crimes that happen near schools for students' safety. It was an idea illustrated to the D.I. from the students from Thomas Edison High School.

Committee Reports:

Dr. Penny Stern, Health Committee Chair

Influenza (flu) and the Flu Vaccine:

Dr. Stern spoke about the flu; the common symptoms and how it spreads. It is important to note that if you are infected with the virus, you are contagious even before you notice any of the symptoms. She encouraged everyone to get the flu vaccine. This can help prevent the flu and limit its complications. There are different types of vaccines (i.e. for those who are allergic to eggs, and those for seniors etc.) You should consult your Primary Care Practitioner (PCP) for more information.

Marc A. Haken, Budget Director

FY'2021 Capital & Expense Budget Priorities:

Budget Director presented the budget items to be submitted for the Capital & Expense Budget for FY'2021:

- Capital Budget Priorities were unanimously approved with four (4) new budget requests from the FDNY by 33 members with no opposition.
- Expense Budget Priorities were unanimously approved by 33 members with no opposition.

Michael Hannibal, Census Committee Co- Chair

AD Hoc Census Committee:

Discussed the importance of the upcoming Census. Many organizations, corporations are doing outreach to educate the public and make sure they are counted. The census is safe to fill out and it is federally prohibited from disclosing information to anyone.

Guest Speaker- Honorable John Liu, New York State Senator thanked the Community Board 8 Members, the Chairperson and District Manager for all their engagement and the work they do for the community. He informed the attendees that many legislations have been passed at the Senate that will set the course of New York State in the right direction. He spoke about the importance of voting and announced that since October 26th early voting has started. There is no excuse. Everyone should go and cast their ballot.

Vehicle Theft.

Safeguard your vehicle.

Vehicles are stolen for a variety of reasons, including theft for parts, insurance fraud, retagging, exporting, and joy riding. Help prevent theft and damage to your vehicle.

What Can I Do?



Lock

Always lock and secure your vehicle. Always activate your alarm every time you leave your vehicle. Consider locking lug nuts to deter rim theft.



Keys

Never leave the keys in the ignition when you exit the vehicle -- even for a



Never leave property in your vehicle. Items such as loose change, shopping bags, GPS, cell phones, laptops, tablets and the charging chords are targeted by thieves.



Parking

Park in high traffic or well lit areas, when possible.

Smell Gas. Act Fast.

- 1. Smell Natural gas smells like rotten eggs.
- 2. Gas If gas is in the air, a spark could cause an explosion. Don't light a match, smoke, flip a switch, ring a doorbell, or touch appliances or electronics, including phones.
- 3. Run If you suspect a gas leak, get everyone out immediately.
- 4. Call When you're safe, call 911, Con Edison (1-800-75-CONED), or National Grid (1-718-643-4050).

Don't assume someone else has already called. You can report leaks anonymously.

YouthBuild Queens

What:

- YouthBuild Queens is a program that assists young adults (18 to 24) in attaining their High School Equivalency Diploma and preparing for entry into the field of skilled trades.
- In addition to HSE instruction, participants will take part in regularly scheduled construction skills training.
- Upon completion of said training, participants will attain their OSHA 30 Certification and entry into the National Center for Construction Education and Research (NCCER), a nationally recognized construction certification database.
- Participants will be expected to commit to 500 hours of construction projects/activities in order to complete the program.

- Youthbuild Queens classes began September 2019
- Classes run from 9am to 4pm (hours may vary slightly depending on special projects and activities)

As New York City Residents we must obey a gamut of regulations. We realize that most residents want to do the right thing and obey the rules. However, they often break them, as they are **unaware** of their existence. So...



Did you know???



Littering, sweeping, throwing, or casting any material such as ashes, garbage, paper, dust, or other garbage or rubbish into or upon any street or public place, vacant lot, air shaft, areaway, backyard, court, or alley is illegal. Throwing garbage out of windows (for example, from buildings or vehicles) is also a violation. In addition, no person may allow anyone under his/her control (agent or employee) to commit a littering, sweepout, or throw-out violation. Merchants must put all sweepings into suitable garbage receptacles for pickup by a private carter. Residential units must put sweepings into suitable garbage receptacles for pick up by DSNY. Sanitation litter baskets may not be used for this purpose.

NOTE: When using a "blower," grass, leaves, litter, etc., must be blown into a pile and properly disposed of with other sweepings.

§16-118(1)......FINE:.....\$100 - \$450 .. 1st Offense

\$250 - 450....2nd Offense within 12 months

\$350 - 450....3rd+ Offense within 12 months


Queens, compost your fall leaves!

Set out your leaves in paper lawn & leaf bags, in open, unlined containers, or in your brown bin for curbside collection. Learn more at nyc.gov/leafcollection.

- No Plastic bags
- Branches & yard clippings from hired professionals. Landscapers must dispose of yard waste at a permitted composting facility.



EMPLOYMENT OPPORTUNITIES



School Safety Employment Requirements

- Candidates must be at least 21 years of age at time of appointment.
- Candidates must have a High School Diploma or GED.
- Candidates must pass a character and background investigation.
- Candidates must pass a drug screening.
- Candidates must meet certain medical and psychological requirements.
- Candidates must reside in one of the five boroughs of New York City.
- Candidates must pay a \$75 fee for fingerprinting as part of the investigation process.
- Candidates must be eligible to obtain NYC Special Patrolman status upon appointment and become certified as a NYC Special Patrolman within three (3) months of appointment. Special Patrolman certification must be maintained for the duration of employment in this title.
- Candidates must be a United States Citizen at time of hire.

Traffic Enforcement Employment Requirements

- Be at least 18 years of age at time of appointment.
- Have a high school diploma or GED.
- Pass a character and background investigation.
- Pass a drug screening.
- Be NYC residents (5 boroughs) within 90 days of appointment if you are a new city hire.
- Pay a \$75 fee for fingerprinting as part of the investigation process.
- Possess a valid New York State driver license.
 Candidates for assignment Level III must possess a towing endorsement in addition to regular license.


