MINUTES: THURSDAY, APRIL 26, 2018

I. PRESENTATION DOT:

- A. Update: 188th St. Pedestrian Safety Improvement Project Horace Harding Expressway to 73rd Ave. by NYCDOT.
- B. The Problem
 - 1. 77 injuries reported from 2012-2016 (51 car, 2 bike, 24 pedestrian with 2 severe and 1 fatality)
 - 2. Over 100 pedestrians cross 64th Ave. Circle during peak hours at uncontrolled intersection.
 - 3. Lane confusion for drivers and missing crosswalk markings for pedestrians.
 - 4. Buses often block right turning traffic onto 64th Ave.
 - 5. Parking lot exit from strip mall is near 73rd Ave. which complicates vehicle exit from lot.
 - 6. High traffic volume; frequent vehicle turns at the corner at 73rd Ave. blocks moving traffic while the intersection is to narrow to add dedicated turning lanes.

C. Proposed Solution

- 1. Add traffic signals, concrete medians, additional street, crosswalk and lane markings, bollards to improve turning cars and change parking regulations at the 64th Ave. Circle.
- 2. Bus stop will be moved 35 feet back on northbound 188th St. to facilitate cars making right turns.
- 3. 8 metered parking spaces will be removed to widen car lanes.
- 4. 23 on-metered spaces will be added 64th Ave. and Oak Grove Park.
- 5. On 73 Ave. and 188th St. a total of 13 parking spaces will be removed to facilitate turning vehicles. This will facilitate a left turn lane northbound on 188th St.
- 6. Bollard/"Quick Curbs" will be installed to prevent left turns at the strip mall exit.
- D. Transportation Committee Recommendations
 - 1. Bollards or fencing at the north exit to the strip mall to discourage pedestrians from crossing 188th St. midblock.
 - 2. Investigate the feasibility of installing Bollard/"Quick Curbs" at the Chase Bank exit on 188th St. near Union Turnpike to prevent vehicles from crossing southbound traffic lane.

TRANSPORTATION COMMITTEE VOTED UNANIMOUSLY TO SEND A LETTER OF ENDORSEMENT TO APPROVE THE SAFETY RECOMMENDATIONS CITED ABOVE WITH THE PROVISION THAT TWO PROPOSED RECOMMENDATIONS ARE INVESTIGATED

II. CORRESPONDENCE

- A. Request co-naming one block of 169th St. from Highland to Hillside Aves. to KALI AVENUE after Ramesh Kalicharran who passed away on December 3, 2017.
 - 1. Name change has been endorsed by NYS Assemblyman David Weprin; NYC Councilman Rory Lancman; Mid-Queens Community Council (MQCC) President Florence Fisher; Indian Diaspora Council International.
 - 2. He was a businessman and philanthropist who started a travel business and driving school on 169th St. while contributing substantial funds to humanitarian goals.
 - 3. He founded Global Organization of People of Indian Origin (GOPIO), Gyaann Bhakti Satshangh (GBS) Mandir now called Prem Bhakti Satshangh (PBS) Mandir. He mobilized umbrella organization of Hindu priests called Pandit's Parishad, founded Liberty Avenue Phagwah Parade, founding member of Indo-Caribbean Federation of North America, the Lakshmi Mandir, the Caribbean Voice Magazine, and served as director of the Indian Festival Committee.
 - 4. Queens Borough President Shulman stated: His achievements are "as an outstanding civic and business leader of the Guyanese Community of Queens." Contributing to the "cultural richness and vitality of our borough."
 - 5. Two additional pages of achievements and awards were enclosed.

PRESENTATION MADE BY THE INDIAN DIASPORA COUNCIL (IDC) INTERNATIONAL. HIGHLIGHTS OF THE PRESENTATION LISTED ABOVE. ADDITIONAL INFORMATION PACKETS ARE AVAILABLE IN THE CB#8 OFFICE.

TRANSPORTATION COMMITTEE UNANIMOUSLY APPROVED THE CO-NAMING 169TH STREET FROM HIGHLAND AVENUE TO WHERE HOMELAWN ST. INTERSECTS WITH 169TH (APPROXIMATELY 6 STORES FROM HILLSIDE AVE.) AS RAMESH D. KALICHARRAN "KALI" WAY. THE NAME AND LOCATION OUTLINED ARE ACCEPTABLE TO ALL PARTIES.

- B. NYS Senator Tony Avella 2018 presentation to Queens Civic Congress Feb. 15, 2018. Transportation Committee affected bills include: Traffic Control Studies; Study propose the extension of LI Motor Parkway; Reasonable Effort to Clear Motor Vehicles of Snow and Ice; Removal of Liability for Sidewalk Maintenance for Co-ops, Condos, and Non-profit Houses of Worship; and Senate Bill #1299-2018 where Senator Avella proposed legislation that would mandate DOT to install a speed hump or one-way conversion if DOT traffic study finds that feasible.
 - 1. DOT responded to the Senator in a letter dated 12/29/17 that one-way conversion studies are initiated at the request of the Community Board. A copy of the letter was sent to the Community Board.
 - 2. If approved, this Bill would bypass CB input for speed hump and one-way conversions

KEVIN FORRESTAL, AREA 3 CHAIR AND A MEMBER OF THE TRANSPORTATION COMMITTEE HAS AGREED TO MEET WITH THE SENATOR AND EXPLAIN WHY INPUT FROM THIS COMMITTEE AS WELL AS INDIVIDUAL PARTICIPATION AT PUBLIC HEARINGS SHOULD NOT BE BY-PASSED. REPORT WILL BE SUBMITTED AT OUR NEXT MEETING.

C. NYC Safety Improvement Workshop as part of Mayor's Vision Zero Initiative for Queens Blvd. between Yellowstone Blvd. & Union Tpke. was held on 1/23/2018. As per input from CBs, flyers were printed in English, Spanish, Russian, and Chinese

- D. MTA Presentation for SELECT BUS SERVICE (SBS) and other bus improvements was held on 1/8/18.
 - 1. Woodhaven SBS was launched 11/12/17. Program includes:
 - a) 3 traffic lanes & 1 bus lane in each direction
 - b) Roadway re-configuration
 - c) Median bus stations
 - d) Signal timing optimalization
 - e) Pedestrian safety treatment
 - f) Parking restored where possible
- E. MTA Bus Schedule Changes effective April, 2018. Fifty-two changes in service levels and 44 running time changes on 44 bus routes. Nineteen of 52 bus schedule revisions have increased in peak service frequency, and 27 in reduction. These changes reflect increases in congestion and decreases in traffic speed through commercial corridor. Expected net savings of \$529,000. For schedule of changes, contact CB8 office.
- F. MTA Upgrade and repairs of E & M subway lines. Work scheduled for completion December 2017.
- G. NYS DOT LIE Construction Project for Rehabilitation of Three Bridges on the LIE Over the GCP Interchange: work was scheduled for completion February 2018.

CONSTRUCTION OF ENTRANCE AND SPEED UP LANES AT THIS LOCATION IS NOT YET COMPLETED.

- H. DOT Final Technical Advisory Committee (TAC) Meeting for Downtown Jamaica Transportation Study was held on March 22, 2018.
 - 1. NYC DOT update was presented by Carren Simpson Project Manager.
 - 2. Primary study area includes west boundary at Austin St. and 193rd St. as the east boundary. Union Turnpike is the north boundary and Linden Blvd. is the south boundary.
 - 3. Scope of this project is limited in CB#8. DOT addressed the major areas of concern which are 168th Pl. and 169th St. from the Grand Central Parkway to 90th Ave. and McLaughlin Ave. as it intersects 188th St.
 - 4. DOT is studying 17 intersections north of Hillside Ave. to change the current poor "Level of Service" (LOS) status. The goal is to improve traffic flow and travel speeds at these intersections. Currently, there is traffic congestion due to vehicles that must wait for multiple traffic signal cycles at these intersections.
 - 5. Currently 168th St. and 168th Pl. run north bound from 90th Ave. to Gothic Dr. and then turn into two-way operation. While 169th St. runs southbound from the Grand Central Service Rd. to 90th Ave.
 - 6. DOT proposes to turn 168th Pl. to one-way operation southbound from the Grand Central Service Rd. to 90th Ave.
 - 7. DOT proposes to turn 169th St. to one-way operation northbound from Highland Ave. to the Grand Central Service Rd. and to one-way operation southbound from Highland Ave. to Hillside Ave.

TRANSPORTATION COMMITTEE CANNOT ENDORSE THIS PROPOSAL AS IT IS BELIEVED THAT THIS PLAN WILL NOT DECREASE CONGESTION AND WILL FORCE THROUGH TRAFFIC ONTO RESIDENTIAL SIDE STREETS. IT WAS RECOMMENDED THAT DOT CONSIDERS THE FEASIBILITY OF ADDITONAL TWO-WAY STREETS. ELIMINATING PARKING ON ONE SIDE OF THE STREET SHOULD BE CONSIDERED IN ORDER TO WIDEN THE STREET IF NECESSARY. AN UPDATED REPORT IS REQUESTED AT THE NEXT TRANSPORTATION COMMITTEE MEETING BEFORE ANY PLAN IMPLEMENTATION TAKES PLACE.

- 8. DOT proposes pedestrian crossing safety changes at the intersection of 188th St. and McLaughlin Ave./Grand Central Service Rd.
- 9. It was recommended that Pedestrian Refuge Islands and Curb Extension to shorten crossing distances be installed and that missing crosswalks be replaced.

TRANSPORTATION COMMITTEE CANNOT ENDORSE THIS PROPOSAL, AS IT IS BELIEVED THAT THIS PLAN ADDRESSES PEDESTRIAN SAFETY WITHOUT CONSIDERATION FOR MOTOR VEHICLE CONGESTION ISSUES. THIS INTERSECTION BACKS UP IN BOTH DIRECTIONS DAILY DURING RUSH HOURS. IT IS RECOMMENDED THAT DOT INVESTIGATE THE POSSIBILITY OF MAKING THE FOLLOWING CHANGES AT THE WESTBOUND INTERSECTION OF McLaughlin AVE. AND 188TH ST. RATHER THAN THE PROPOSED RAISED CONCRETE ISLAND, THE RIGHT LANE BE A RIGHT TURN ONLY LANE ONTO THE GCP ENTRANCE WHILE A MIDDLE LANE PERMITS TURNS IN EITHER DIRECTION AND THE LEFT TURN REMAIN A LEFT TURN ONLY LANE. IT IS FURTHER SUGGESTED THAT TURN SIGNALS BE INSTALLED ON 188TH ST. TO PERMIT VEHICLES TO ENTER THE GCP EASTBOUND ENTRANCE RAMP. CURRENTLY ONLY A RELATIVELY FEW CARS CAN MAKE THE TURN WHICH BACKS UP TRAFFIC NORTH AND SOUTH. AN UPDATED REPORT IS REQUESTED AT THE NEXT TRANSPORTATION COMMITTEE BEFORE ANY PLAN IMPLEMENTATION TAKES PLACE.

- I. Correspondence from Make Queens Safer has offered a report for tracking Vision Zero in Queens and has requested input from residents.
- J. DOT announced opening of new Queens Borough Hall Municipal Parking Lot with 302 parking spaces on 3/26/2018.
- K. DOT Milling Union Tpke. to start 4/9/18 from Utopia Pkwy. to Francis Lewis Blvd. MILLING IS COMPLETE; TO DATE ROAD HAS BEEN REPAVED FROM Francis Lewis Blvd. to 190th St. NO WORK HAS BEEN DONE ON THE MEDIAN.
- L. DOT Tentative Resurfacing schedule for 2018 (75 locations) is available at CB8 Office.
- M. DOT Correspondence from NYC Councilman Barry Grodenchik on behalf of constituent dangerous situation on 188th St. between McLaughlin Ave. & Hillside Ave. Has been assigned Tracking #DOT-360098-C7C3.

 - 1. Regarding safety issue at main entrance to Cunningham Park soccer field on 73rd Ave. between 210th St. & Hollis Hills Terrace Requires installation of pedestrian crosswalk and traffic calming device. **APPROVED**
- O. Correspondence from NYC Councilman Barry Grodenchik to resident from MTA- request for Express Bus Service from Hillside Ave. to Downtown Manhattan. Has been assigned Incident #171130-000461. **APPROVED**

- G. DOT Request Resurfacing Henley Rd. from Midland Pkwy. to Homelawn St. 9/21/17. **DENIED** as it was last completed 8/4/16.

- movement at 73rd Ave. is because at both main & service roads traffic is making a right from the main road and vehicles are also merging when they pass the intersection."(#DOT -343002-B0R5)
- FF. DOT Request regarding traffic signal operation at Hillside Ave. with Midland Pkwy & 180th St. As a result of study, a left turn signal has been approved at this location. **NOT DONE**
- GG. NYS DOT Request widening of SB exit ramp Clearview Expwy at Union Tpke. (Project #X034.13). **APPROVED** 6/16/16. Has progressed to the design phase of the project. Based on analysis of traffic flow, NYS DOT is planning to widen the ramp to provide for two lane exit for traffic proceeding EB on Union Tpke, and a one lane exit for traffic proceeding WB. Intersection crosswalks and curbs will be improved at that time. Feedback requested by April 1st.
