1. OPENING OF MEETING AND READING OF MINUTES

Chair Algredo asked if there were any corrections/additions to May 14th, 2024 meeting minutes and motions. There were none. Steve Forte motioned to accept the minutes as presented. Joan DeCamp seconded the motion.

2. Chairperson's Remarks & Exec. Report-Sherry Algredo, District Manager's Report- James McClelland

Chair Algredo reported on the items that were discussed at the June 10th, 2024 Borough Board meeting, She also made an announcement regarding the resignation of CB9 member, Mr. Reaz Khan.

Chair Algredo wished all a happy and safe summer.

DM McClelland wished Happy Birthday to Inderpaul Ahluwalia, Visnoonand Bisram, and Christian Orellana. He also reported on the following:

- Met with the other District Managers to discuss budget consultations for various city agencies.
- Stated that they are in the process of formulating a line of questions for about 14 different agencies regarding budgeting, staffing, programs, and services for our future budget meetings.
- DM McClelland stated that the office will continue to operate during the summer assisting board members and resolving constituent complaints. He wished everyone a happy and healthy summer.

3. Guest Speaker – Melinda Katz, Queens District Attorney

DA Katz addressed the board and gave a brief report on various crimes/incidents that recently occurred in Queens.

She spoke on the following topics:

- Unlawful occupancy/squatter situation
- Crackdown on illegal scooters
- Hate crimes
- Illegal cannabis shops
- Deadly Driving Bill
- Multiple various scams
- ACRIS Guide to register for alerts to guard against deed fraud.

Question and answer period followed.

4. NYPD 102nd Pct. Briefing

Deputy Inspector Jeremy Kivlin, 102nd Pct. Commanding Officer, stated that crime is down 4% year to date and 14% for the last 28 days in the Community Board 9 area. DI Kivlin reported on the following:

- Sixteen illegal smoke shops in the CB9 area have been shut down.
- A special enforcement team was formed to address various quality of life issues i.e., robberies, drinking on the street, noise, etc., on Jamaica Avenue.
- A murder suicide, domestic violence related, occurred this past week on 111th Street, south of Atlantic Avenue.
- PO Salamone stated that The National Night Out Against Crime annual event will take place on Tuesday, August 6th, 2024 at the Victory Field.

Question and answer period followed.

5. PUBLIC FORUM

Sol McCants III, Richmond Hill Resident, spoke about African American Veterans and their role in the victory

of World War II. Mr. McCants named a few books that are about this part of American history.

<u>Carol King, Kew Gardens Resident</u>, spoke about the need for accessible ramps at Overlook Park. DM McClelland stated that the issue was brought up at this year's budget consultations.

<u>Carmela Isabella, Woodhaven Resident</u>, spoke about the City of Yes Housing Opportunity and stated that she hopes that Council Member Lynn Schulman will be addressing the board regarding this.

Martin Colberg, WRBA President, urged board members to oppose the City of Yes – Housing Opportunity initiative as it will impact the neighborhoods' quality of life.

6. Education & Youth Services Committee Report – Alexandia Sumpter-Delves & Seth Welins, Co-Chairs

Alexandria Sumpter-Delves reported on the topics that were discussed at the Committee meeting and thanked committee members for their involvement and help at several events at P.S. 97, 62 and 161.

She stated that a Family Enrichment Center will be opening this month at 111-20 Jamaica Avenue in Richmond Hill and introduced Mr. Herman Cortes, DEC Director of Martin De Porres Youth & Family Services.

Mr. Cortes and Ms. Williams gave a brief presentation regarding the goals of FECs and their role in the community. Ms. Williams stated that they identify strengths, co-design programs, and create a nurturing environment where families come together to connect, contribute, and find the support they need.
