## 4. Education & Youth Services Committee Report, Alexandria Sumpter-Deles & Seth Welins, Co-Chairs

- Mr. Welins attended the meeting at Queens BP's office where Queens Public Library representatives gave a
  presentation regarding some of their current projects.
- The education committee will wait until the new year to see if the Richmond Hill Library renovation project will be approved by the DDC, as promised by officials of QPL. If it is not approved, then we can send a second request to the Comptroller's office for an audit of this project.
- Spoke about eligibility requirements for student OMNY cards.
- Daniel Chu spoke about the possibility of leasing a building adjacent to PS 99 annex for school expansion.

#### 5. Land Use & Housing Committee Report - Sylvia Hack & Andrew Taranto, Co-Chairs

## ULURP No. C250047MMQ

Sylvia Hack stated that on November 6<sup>th</sup>, 2024, CB9 held a public hearing for the proposed Metropolitan Park ULURP Application C250047MMQ, a city map amendment and a zoning map amendment on city-owned property. The proposal is to facilitate a new 3.7 million square foot mixed-use development including a gaming facility, music hall, hotel, convention space, parking and other amenities in Flushing Meadows Corona Park.

Approximately 100 people attended the hearing and those who testified were in support of the Application. Therefore, the Land Use & Housing Committee is recommending that CB9 votes in support of the proposed Metro Park ULURP Application

Co-Chair Hack pointed out that the proposal requires one of three state casino licenses expected to be awarded downstate by the end of 2025.

Chair Algredo gave the floor to those who signed up to speak at Public Forum regarding this issue.

Rebecca Pryor, Executive Director of The Guardians of Flushing Bay, stated that as representatives of the communities directly impacted by this massive public land giveaway, they are calling on the Community Board to vote No, or No, unless modified to include the following modifications in their vote:

- 1. Stop a 78-acre, likely tax-free public parkland giveaway.
- 2. Prohibit a casino on the parkland adjacent to Citi Field
- 3. Invest in public parkland, in alignment with the Phoenix Meadows Vision Plan.
- 4. Protect Comminities from displacement.
- 5. Demand a transparent and robust community benefits agreement (testimony submitted)

<u>Costa Constantinides, Variety Boys & Girls Club</u>, spoke in favor of the Metro Park proposal application stating that it will benefit the economy of the Borough of Queens in many ways.

<u>Tom Grech, Queens Chamber of Commerce,</u> spoke in favor of the Metro Park proposal application stating that this project will create twenty thousand new jobs and many other benefits for Queens residents.

<u>Ashley Lin, Korean American Family Service Center</u>, stated that she represents a not-for-profit organization that is committed to prevent and end domestic violence, sexual assault, and relationship abuse, overall to create a violence-free society. Her organization supports the Metro Park proposal.

Robert Dorsky, Flushing Business Owner, spoke in favor of the Metro Park proposal.

<u>Erica Ford, Queens Resident</u>, encouraged all to believe in expansion and to see the vision of why we need to grow as a community.

Co-Chair Andrew Taranto made a motion to approve, Stacey Yearwood seconded the motion.

## 7. NYPD 102<sup>nd</sup> Pct. Briefing

Deputy Inspector Jeromy Kivlin, 102<sup>nd</sup> Pct. reported on the crime stats stating that overall crime is down by 32.5% in every category for the last 28 days and 8.5% year to date. There was 5% increase in grand larceny.

Officers continue to work very hard to resolve quality of life issues.

DI Kivlin stated that documenting Level 1 encounters, which are stops where they request information from civilians, as part of the How Many Stops Act, does not affect their responses to assignments and overall policing. It is a very short form which is being processed during their overtime hours.

DI Kivlin stated that the harassment complaint submitted by Chair Algredo will be addressed.

Joe Ottomanelli, DSNY spoke about residential containerization and increase in commercial fines.

- Beginning November 12, 2024, all properties with 1-9 residential units will be required to use bins (55 gallons
  or less), with secure lids to set out trash.
- A compliant bin can be used (55 gallons or less with a secure lid) that is already in possession, but starting June 2026, an Official NYC Bin must be used.
- NYC Bins are available to order for recycling and composting, although they are not required. Compost must be set out in bins (55 gallons or less) with secure lids.
