6:31 PM Meeting called to order by Acting Chair, Anthony Cosentino, 1st Vice Chair with the Pledge of Allegiance.

Guest Speaker:

Eric Waldhelm, New Commanding Officer. 120th Precinct – There for 5 months. Prior to that, 2022 – 2024, I was Commanding Officer at the 121 Precinct. 2019-2022, 2nd in Command in the 120 Precinct. Lifelong Staten Islander. Attended Curtis High School and happy to help them out in any way I can. Crime is down 10% compared to last year. Some tips in the cold weather. Don't warm up your car and leave the keys or valuables in the car. There are people flipping door handles, we call it car hopping. Detective Connor will be here if you have any questions.

Councilmember Kamillah Hanks: A round of applause for our Commanding Officer of the 120. We are against Congestion Pricing and Governor Hochul should not lift the pause. This is borough discrimination. This gives an undue burden of tax on Staten Islanders. The pride center will be able to march in the St. Patrick's Day Parade. I'm here to discuss the Martling Avenue Bridge regarding the "ugly" fence that has been constructed. Please give a round of applause to our DOT Borough Commissioner Roseann Caruana. This bridge was done by the Central office of DOT Bridges and Tunnels in NYC. They sent a letter to all the elected officials & Community Boards. The letter said they would be doing some remediation, cleanup and some fencing. It is our fault if we missed that but when you say fencing, that does not explain what was put up there. We are all upset, myself and the Borough President, etc. I want to thank the Borough Commissioner Roseann Caruana who got in touch with the necessary agency and they explained what happened with the bridge and why it was put up. They said safety reasons but there is a gap in the fence so that doesn't make sense. Thursday, 11/14, 2:30PM, there will be a press conference with the borough president on the bridge. We are calling for the removal of the fence. We were not in office when this was designed but it doesn't excuse us but it wasn't specific enough to send out an alert. I am introducing a bill that requires bridges and DOT to submit design plans instead of the "innocuous" letters.

Agnes McBeth, Education Liaison in DA McMahon's office with ADA Carlos Gonzalez – Carlos said he started in June 2024 originally from California, living in Staten Island since September and with the Criminal Court Bureau. Agnes said on Saturday, November 23rd, 10:00AM, Mount Sinai Christian Church, another Gun Buy-Back in partnership with the NYPD.

At a recent Land Use meeting, there was a conversation about fencing at Silver Lake which was the discussion. During and following the meeting, the District Attorney's office received a flood of phones calls due to the comments that were made in reference to his participation in that project. He has written a letter which has been submitted to the community board. I will read that letter for the record. (Please see attached letter from the DA's office). First Vice-Chair, Anthony Cosentino said on behalf of Community Board 1, our District Attorney is always looking out for our best interest. Want to apologize on behalf of this board for that mishap, however, let it be known that it was not a sworn member of this board that made those comments.

Prince Cobbina of CCRB – Thursday, November 14th at 5:30 PM, Hybrid Meeting, 100 131st Street, NYC Teen meeting for young New Yorkers to share their experiences within their community.

Beth Stern, Community Agency for Senior Citizens (CASC) – We offer many services for seniors. Case assist if you want to apply for housing. Transportation, medical and food shopping. Case management where all Meals on Wheels go through. If you need help with housekeeping. If you have a homebound senior, they will match you with a volunteer with a same type of interest. Justice for Elder Abuse. 1 out of 23 of these crimes are reported. Financial, physical, emotional, and neglect. If you know someone being abused, it will be kept confidential. CASC works hand in hand with the NYPD. Crime victim's assistance. I was director of that program for 7 years. We can get a victim compensated if lost money. If you had your catalytic converter stolen, the insurance only charged you the deductible, we can reimburse you the deductible. You need the crime report. We have NY Connects. If we can't help with a service, we will find someone who can. I am director of the Cassidy Coles Adult Center. Open Monday-Friday, 8AM – 4PM. Breakfast and lunch are offered daily. There is a suggested donation but not mandatory. Arts & Crafts, Nutrition Education. There is a gym onsite.

Kelly Yim, Stapleton Library – Programs happening. Creative Aging Workshop with Nikita Shah for seniors 50 and over. Classes on media, painting acting, knitting and drawing Mondays at 12PM – 1:30PM from October 28 – December 9, 2024. Also, for anyone who has lived, worked or loved Stapleton, and want your voice to be heard for Civic Engagement on this Saturday, November 16th from 11AM to 1PM with a gift card raffle.

Mario Buonviaggio, Port Richmond North Shore Alliance – We just transported a 48 foot Spruce tree for our annual tree lighting on December 13th, 7PM at 415 Port Richmond Avenue. Thank you to all four precincts that helped with the transport.

Nughub, 1350 Forest Avenue, operating inappropriately. They are not allowed to smoke their product in front of the location. Veltman Avenue residents are sending videos and photos. Party in the parking lot giving out gummies occupying residential spaces. This is OCM, we have SLA, and the failing NYS Parol Board. They are "rubber-stamping" paroles. These are all state agencies. I am putting this on Senator Jessica Scarcella-Spanton's shoulders. She's the only one representing the North Shore appropriately. Asking her to get the State Electeds including the State Assembly to get in the game and work together and get these agencies in order. You are putting public safety in jeopardy. Nobody is answering at the Office of Cannabis Management. The cops wouldn't know how to approach this problem. Four marijuana dispensaries operating inappropriately right out of the gate. Two on the North Shore, one on Clove Road and one on the South Shore. To the Governor, clean your own back yard.

I have walked many dogs there too. He is working on it. He is also opposed to the Battery Storage Units. Anything you need, please do not hesitate to call.

Jermaine Williams, NYPD Ambassador for SI – It's the holiday season. If your going shopping and putting bags in your car and going back in, go to a different location. There are people watching you. Have a Great Holiday of Thanks and a safe one.

Mark Albin – Born in Manhattan, grew up in Bay Ridge. 30 years ago, came to Staten Island for a better life. Last 40 years I have been working in Broadcasting for all three networks. I have seen the quality of life in Rosebank on Hylan Blvd diminish the last five years with graffiti, trash, etc.. I am squeezed between the Hotel and Colton Street. Next to my house is the Colton Street Staircase that runs from Hylan Blvd. to Clifton Avenue owned by the State. DOT is responsible for it. Every year my neighbors and I have to call 311, the Borough President, this has to be on a regular rotation. We are in the worst drought that we have seen in decades. All that brush and dead trees that are sitting next to our homes, not only is an eyesore but a hazard for property and life. People will die and property will be lost. DOT has failed us. If they are not going to do anything with it, then remove all the vegetation and put cobblestones down this street. All it takes is for someone to throw a cigarette butt into the area.

RE: Correcting Misrepresentations at Community Board 1 Land Use Public Hearing on November 7, 2024

Dear Community Board 1 Members:

I hope this letter finds you and your families well. It was brought to the attention of our office that at a recent Community Board 1 Land Use Public Hearing there were several misrepresentations made about myself, our office, and advocacy we have undertaken on behalf of public safety interests at Silver Lake Park. Please allow this letter to serve as a correction of those misrepresentations and to clarify any position our office may have regarding plans for the park.

First, prior to last week's meeting, our office was not aware of a planned project by the Department of Environmental Protection (DEP) to change or implement higher fencing at Silver Lake Park. We have never requested a change to fencing at Silver Lake Park, we have never received information about a proposed change, nor do we have a position about the proposed project now. Any representation stating that this project was a result of advocacy by our office is misinformed and false.

What is true and accurate is that in 2021 there was a tragic death of a 9-year-old girl who drowned in the Silver Lake Reservoir. The circumstances surrounding her death were such that an investigation was undertaken by our office to determine what if any criminal charges might be applicable. During that investigation – three years ago – members of our office met with the Parks Department and DEP to better understand the schematic of the park, signage in the area, and the nature of the water current in the reservoir, among other things. We were compiling information to inform our decision-making process regarding the criminal investigation.

At that conclusion of our investigation, our office did circle back to advocate that signage in Silver Lake should be updated to reflect that swimming is prohibited in the reservoir. In conjunction with Borough President Oddo, and with the support of other elected officials, we submitted that request to City Hall and the Parks Department. The request for updated signage was honored shortly afterwards, for which we remain extremely grateful. That concluded our advocacy related to public safety changes at Silver Lake Park.

Again, our office has never taken a position nor advocated for changes to fencing at Silver Lake and we have no position regarding the current proposal made by DEP.

Thank you for the opportunity to clarify and correct the record regarding this project. We look forward to continuing to work with the members of the Community Board to strengthen and protect Staten Island's North Shore.

Shore Acres Pond is a unique protected wetland area of Staten Island. It goes by various names: Lake Alexandre, Clifton Lake and Shore Acres Pond. It is technically a kettle pond fed from underground springs and storm water.

There are no storm sewers along Wadsworth Road and Seagate Road. The natural drainage of this entire area including part of Von Briesen Park and the hills of Shore Acres culminates into the pond.

It is considered Special Natural Area District 3 which is controlled and protected by the DEC (Department of Environmental Conservation). It is the home of blue herons, egrets, geese, mallards, opossums, raccoons, and other wildlife. As a result heavy fines can be levied by the DEC when infractions occur such as destroying vegetation, and harming wildlife. Any construction within a 100 ft radius of the DEC boundary needs specific DEC permission and permits. They are the lead agency to deal with before other agencies can get involved with any building project.


Recently, since August 2024, the new owners of 100 Wadsworth Road on Shore Acres Pond, who also own a Brooklyn based Construction Company, brought in over a dozen workers who took over the entire area. They have blocked the road to certain residents with their construction vehicles cut down vegetation along the pond, constructed a huge dock on the pond to create a giant party area and altered the topography to block the natural drainage of storm water from the road to the pond (FIG 1)

In one weekend they excavated a site between 100 Wadsworth Road and 110 Wadsworth Road (FIG 2) to create a cement and stone parking pad. The problem with their parking pad is the slope. They destroyed the natural swail needed for storm water to enter the pond from the roads and in doing so have created a flooding situation for the nearby homes. They actually raised the elevation of the swail by almost 2 feet.

When confronted ,the owners were condescending and declared that they had all proper permits when ,in fact, they had none. They speak English when they want to but most of the time, play dumb.

Complaints were made by Shore Acres residents by calling 311 (Complaint numbers 5185606, 5185603, 5185602 and 5185521). Complaints were also made to the Department of Enviornmental Conservation (DEC).

Most recently they have modified their parking pad by substituting the cement with patio blocks . They still failed to address the slope to allow proper storm water drainage from the street to the pond and the condition persists.

needs to be directed to Clifton Lake. The lake has a drainage pipe installed which travels underground across Shore Acres Sea Gate Road and Wadsworth Road have no storm sewers. Clifton Lake (Shore Acres Pond) is the storm basin. All storm water Road and Harbor view Road to Cliff street to dump into the ocean. This pipe is maintained and periodically cleaned by the DEP

Shore Acres Area of Staten Island

The Shore Acres area of Staten Island owes its unique character to Shore Acres Pond, which is fed predominantly by springs percolating from an underground aquifer through Pleistocene strata of sand and gravel.

The Pond is a resting place for migratory and local fowl as well as a watering hole for opossums which are abundant along the wooded cliffs of the Narrows. The Pond has shaped its built environment, including the street layout, landscaping and orientation of neighboring homes. The surrounding area is distinguished by rolling topography with orientation of the northeastern edge toward Lower New York Bay and the Narrows.

The natural drainage area is in need of protection to ensure survival and maintenance of the Pond which in turn is essential to the preservation of this special area.

The Local f/k/a Pepper Jack Grill Liquor License Renewal

Called to Order 5:35 pm

A quorum was not present.

Agenda Items;

1. The Local Liquor License Renewal represented by applicant owner Joseph Territo, no quorum and no vote, but no complaints, no objections, forwarded with recommendation to approve.

Westerleigh Parks Coalition represented by Directors Lorenz Neuwirth, Albert Barry, Stefanie Danza and Douglas Patterson, introduced themselves and their organization, which is volunteering to maintain and improve Westerleigh Park and Northerleigh Park. They related several concerns, including grading, erosion and drainage in Northerleigh Park, particularly the ballfields; presence of drug users and homeless persons in the Park; illegal dumping of landscaping debris and trash (requested a camera be installed by Parks to monitor); hoped for plans to convert one of NYC -owned houses at eastern end of Park on Burnside Avenue to be converted into a museum for Westerleigh and the old trolley line which ran on Jewett Avenue; City of Yes neighborhood concerns; the environmental issues regarding the BESS planned for vacant lot by 1963 Victory Blvd just east of Jewett Avenue; and their present inability to secure organizational grants from NYC Parks because of a \$50,000 capital funds threshold. We suggested that they continue efforts with the Borough Parks Office, Assemblyman and Councilman Offices, fundraising with local businesses, development of a marketing strategy and NFP business plan, and encouraged them to attend the CB1 Full Board Meetings to introduce their organization and raise their concerns.

Westerleigh Improvement Society: Mike Morrell stated that they were holding their regular Meeting that same evening. He expressed support and cooperation with the Westerleigh Parks Coalition.

In closing we again extended our appreciation and thanks to Fran Reali & Frank Reali for hosting the meeting space for this Area Committee Meeting.

Meeting adjourned 6:10 pm.

The meeting was called to order at 19:07 pm. In attendance CB1 members were Chris Campbell, Anthony Cosentino and Charlie Olsen. A discussion on why the meeting was changed to quarterly was presented and accepted by the committee.

The webpage set up by the Cultural Affairs Committee listing cultural sites in the CB1 Area was created and has been distributed, accepted and the link to it posted by CB1 on the CB1 website. The idea of expanding exposure to these organizations was brought up. It was decided that the next step should be to also add other pertinent sites like the NYC Cultural Affairs webpage and Culture pass.

Discussion also involved creating pages that connect to each other to further enhance the depth of access to these sites as follows:

- A CB1 cultural affairs page with the CB1 mission statement which connects to cultural sites, NYC Cultural Affairs, Culture Pass and Cultural Site calendars (where available) of CB1 Cultural Sites be placed as the primary link site on the CB1 website.
- 2) The schedule of events page which displays each Cultural site and organization that has a schedule of events on their website or social media page be included with a link directly to their schedule of events page. This allows the viewer to be directly brought to that specific cultural sites schedule that the site creates and maintains.

Anthony Cosentino suggested that we contact those sites that we will include on our CB1 Cultural Affairs Schedule of events web page. A discussion ensued and it was agreed that a letter be sent to each of the cultural organization we include on the web page to notify them of the site and gain their approval to have their schedules be included. This will also notify them of the effort the community board is making to support and promote them. A letter will be drafted and distributed to the committee members for review and approval.

It was also suggested that the CB1 libraries be included as cultural sites since they promote culture through education in a multimedia format. The libraries are under the auspices of the NY Public Library so a feasibility study will be undertaken to see if a schedule of events is obtainable for posting.

The chair asked those in attendance if anyone else had anything to add. There being no further discussion the chair asked for a motion to adjourn. Motion to adjourn made by Chris Campbell and seconded by Charles Olsen. The meeting was adjourned on 11/18/24 at 19:29. Next meeting TBD.
