Officers' Reports:

Chair's report: Fred reported that Con Edison is making repairs to the equipment supporting the Fox Hill network. Once those repairs are complete and the equipment is back in service, Con Ed will begin removing the generators. The generator locations are as follows:

Treasurer's Report: Roy J. Garlisi reported that the Treasurer's Report for November 2023 is complete and accurate. It is filed in the Board office.

Public Session Speakers:

Sal Montefiore, a resident of Midland Beach asked if Homes for the Homeless, the organization that owns the former Island Shores Senior Residence in Midland Beach contacted the Community Board before selling to the city. Sal said many homeowners are concerned with the shelter. It is changing their quality of life.

John Aspinwall, president of the Travis Civic Association reported that two of the biggest concerns in Travis is the migrant issue and the lithium battery site that is proposed to be installed on Victory Boulevard. The civic is working with the company and the developers to get more information.

Carol Donovan spoke to the City of Yes for Economic Opportunity proposal. Carol reiterated what was in the letter that she had sent to the Community Board. She said this would be a tremendous hardship and destruction of quality of life in Staten Island and throughout the city. The proposal would be a free-for-all for developers just like the City of Yes for Housing Opportunity text amendment proposal. It would do nothing but bring crowding businesses where they never existed. It would not benefit the communities or residents it would only benefit developers.

Joseph and Rosanne McAllister of the South Beach Civic Association spoke to their opposition to the proposed City of Yes for Economic Opportunity Text Amendment.

On behalf of District Attorney Michael McMahon, Francesca Gallelli announced the following:

 DA McMahon joined Mayor Eric Adams and Attorney General Leticia James, along with our elected officials to announce the \$12 million to combat the opioid epidemic as part of funds secured by New York Attorney General Letitia James from settlements reached in Francesca Gallelli on behalf of DA Michael McMahon continued.

- her numerous lawsuits against different manufacturers and distributors of opioids. The funds will go exclusively to Staten Island-based organizations that provide a range of intervention services, including treatment, outreach, and harm reduction, as well as to housing and employment assistant. Over the coming months, the city will work closely with stakeholders and local leaders to ensure funds are distributed fairly, equitably, and efficiently to organizations across the borough. This is significant because earlier this year, \$150 million was designated to New York City, with not a single cent designated to Staten Island even though SI has the second-highest rate of overdoses in all of New York City.
- District Attorney McMahon's office offers "The Hope Program" to make sure people are getting the services and care that they need especially when they are accused of a crime, a very low-level crime as a result of addiction that they are facing due to overprescription by the pharmaceutical companies.
- Car thefts are down 10% on Staten Island compared to the rest of the city. It is still a major issue. Lock your cars, and take your belongings with you, especially as you are shopping this holiday season.

On behalf of Council Member David M. Carr, Loren Centineo wished everyone Happy Holidays. Loren said to contact her or anyone in Council Member Carr's office for help with any issues.

On behalf of Assembly Member Michael Tannousis, Richard Coyle wished everyone Happy Holidays. Richard said he would be available after the meeting if anyone wanted his card or had a problem they'd like to discuss.

On behalf of Assembly Member Sam Pirozzolo, Nick Robbins wished everyone Happy Holidays, Merry Christmas, and a Happy New Year. Nick touched on what Francesca Gallelli of DA McMahon's office said regarding the opioid settlement funds. He said Assembly Member Pirozzolo worked tirelessly on that alongside the entire Staten Island delegation and the opioid providers who are going to use this funding towards improving and saving the lives of Staten Island families.

On behalf of Assembly Member Jessica Scarcella-Spanton, Vanessa Limani wished everyone a Merry Christmas and a Happy New Year.

On behalf of concerned citizens of Midland Beach, committee chairperson Natalie reported that the group has been protesting daily for more than 60 days and is looking for community board assistance. Natalie said she does not understand why Homes for the Homeless did not have to go through the ULURP process which had to be done in the 1980's. She said she believes the homeless shelter at the former Island Shores is overcrowded and may need metal detectors. Natalie said there has been an unconfirmed case of tuberculosis and according to medical health laws, this is supposed to be reported to a medical doctor and CDC within 30 days.

The NYC Department of City Planning is proposing a citywide zoning text amendment to implement changes to the New York City Zoning Resolution (ZR) to support economic recovery and resiliency in New York City. The Proposed Action would make it easier for

businesses to find space and grow by lifting barriers to enable businesses to locate closer to their customers; support growing industries by reducing impediments for emerging business types; foster vibrant neighborhoods by ensuring businesses contribute to active, safe, and walkable corridors; and create new opportunities for local businesses to open by establishing new zoning tools to boost job growth and business expansion. The Proposed Action would affect all 59 Community Districts in the City.
