MTA Construction & Development gave a presentation on **ADA Accessibility Upgrades at Huguenot SIR Station**. The MTA is committed to making 70 stations ADA accessible under the 202-2024 MTA Capital Program. There are three stations on Staten Island: Clifton, New Dorp, and Huguenot. No customer will be more than 2 stations away from an accessible station. The Huguenot Station topography is most suitable for a ramp system. Construction will begin on or after June 6, 2024, and will be completed by the end of 2026.

Project Scope

ADA Improvements

- 2 new ADA-accessible ramps from the street to the platform
- Detectable warning panels to extend the length of the platform
- New ADA raised boarding area with platform edge tactile strips

Infrastructure Improvements:

- New concrete work, steel ramps, and ramp canopies
- New Ice melting system

Station Environment Improvements:

- New help point, customer information, and CCTV
- Artwork on the ADA ramp railings

Construction and Service Impacts

- Stakeholders will be notified of construction phases.
- Access to walkways and sidewalks will be maintained.
- Weekdays 9am to 3pm and weekend nights 10pm to 5am trackwork may require diversions.
- No long-term station closures are planned.


