All analysis of DOC's non-contact visit list was done on the 23<sup>rd</sup> day of the relevant month (current month, one month back, and three months back).

<sup>&</sup>lt;sup>2</sup> If an inmate has been restricted to non-contact visits for a period greater than six months, he should receive periodic review of such restriction. The review shall be conducted not less than once every six months. <sup>&</sup>lt;sup>5</sup> Central Punitive Segregation Unit (CPSU) locations from which visits were counted are not currently available, so the ADP and per inmate rates cannot be calculated. In September 2016, DOC had punitive segregation units at GRVC, OBCC, and RMSC therefore, non-CPSU ADP for GRVC, OBCC, and RMSC may be slightly lower than what is reported in this table. Additionally, data does not exist on the number of restrictions or arrests associated with CPSU.
