



Total DOC Population by Custody Status January 15, 2022 – January 21, 2022




City Sentenced Population by Custody Status January 15, 2022 – January 21, 2022





Number and Percent of Patients Ever Confirmed Positive for COVID-19 While in Custody January 15 – January 21, 2022









Number of People in Likely Exposed but Asymptomatic Housing March 16, 2020 – January 21, 2022




Number of People in Confirmed/Symptomatic Housing March 16, 2020 – January 21, 2022

Number and Percent of Open Cell and Dorm Units Above and Below 50% Capacity January 20, 2022




Number and Percent of Open Units Above and Below 50% Capacity by Housing Category January 20, 2022
