




City Sentenced Population by Custody Status March 5, 2022 – March 11, 2022






Number and Percent of Patients Ever Confirmed Positive for COVID-19 While in Custody March 5 – March 10, 2022<sup>2</sup>






Number of People in Likely Exposed but Asymptomatic Housing


Number of People in Confirmed/Symptomatic Housing March 16, 2020 – March 11, 2022

Number and Percent of Open Cell and Dorm Units Above and Below 50% Capacity March 10, 2022




Number and Percent of Open Units Above and Below 50% Capacity by Housing Category March 10, 2022
