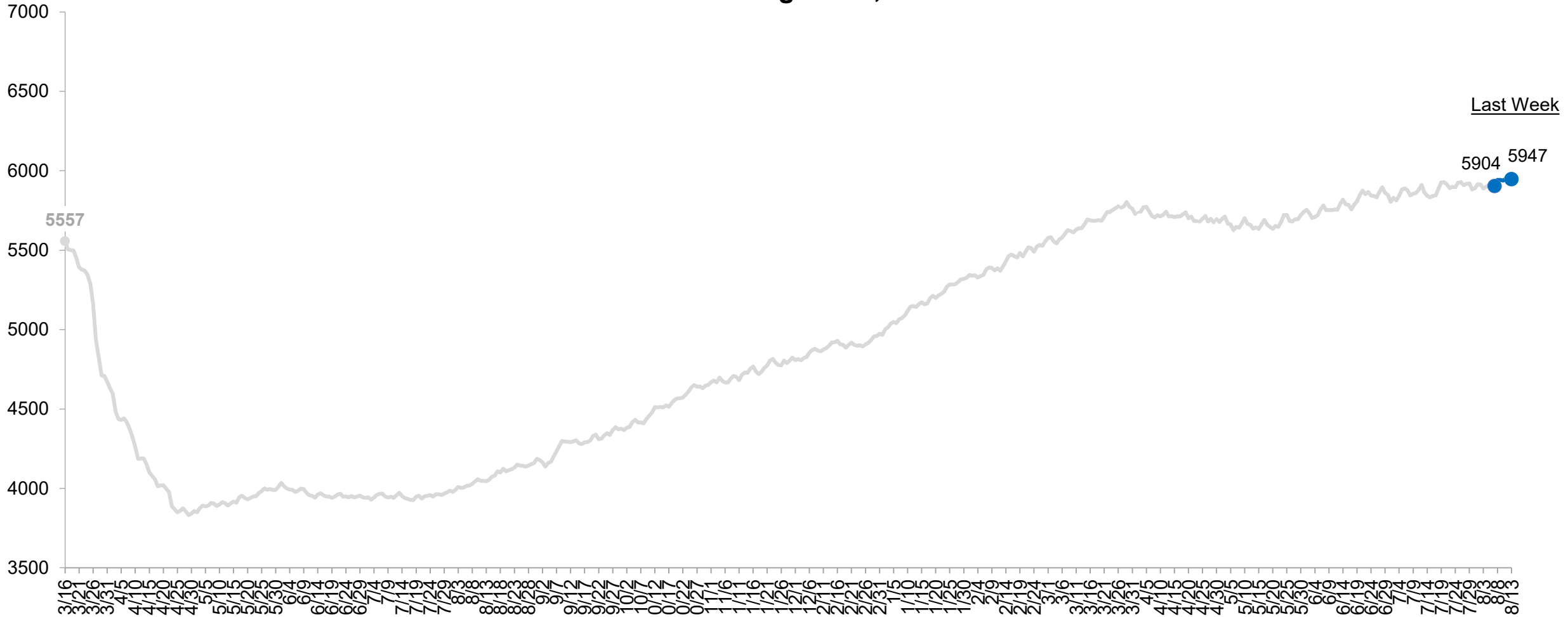

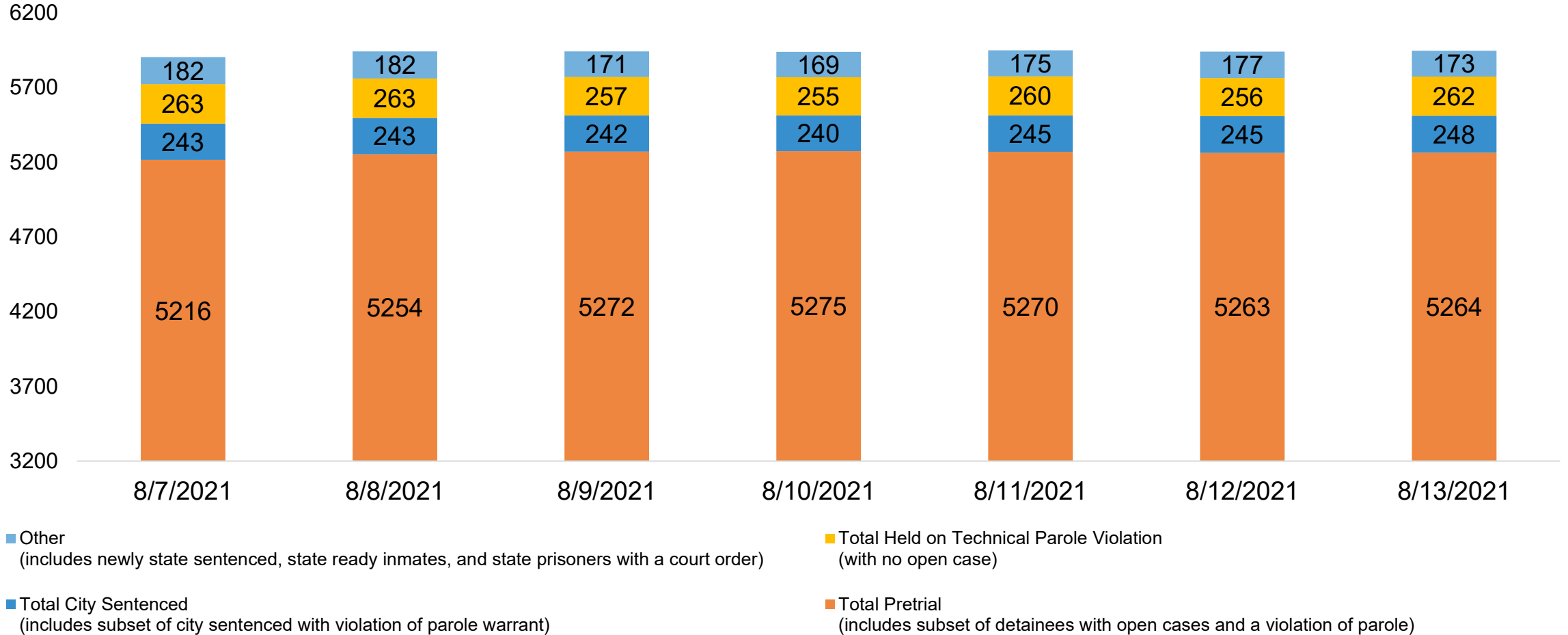
## Total Population in DOC Custody March 16 – August 13, 2021

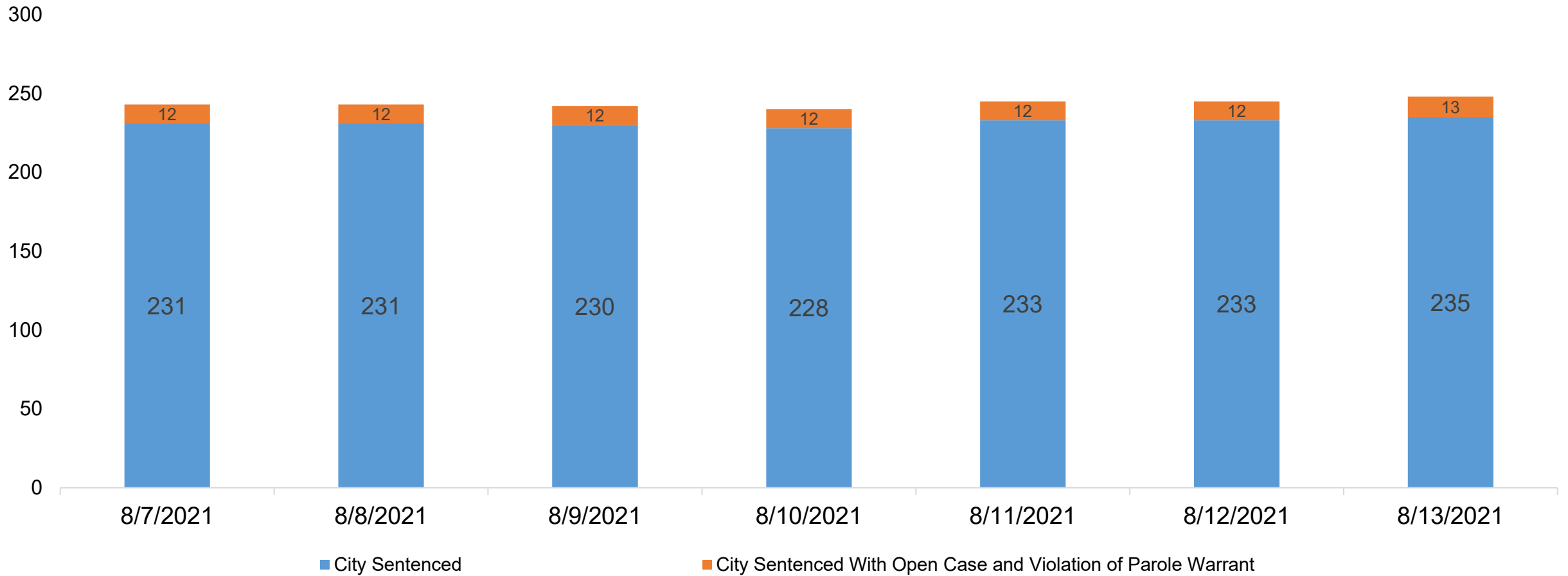

## Total DOC Population by Custody Status, 8/7/2021 - 8/13/2021



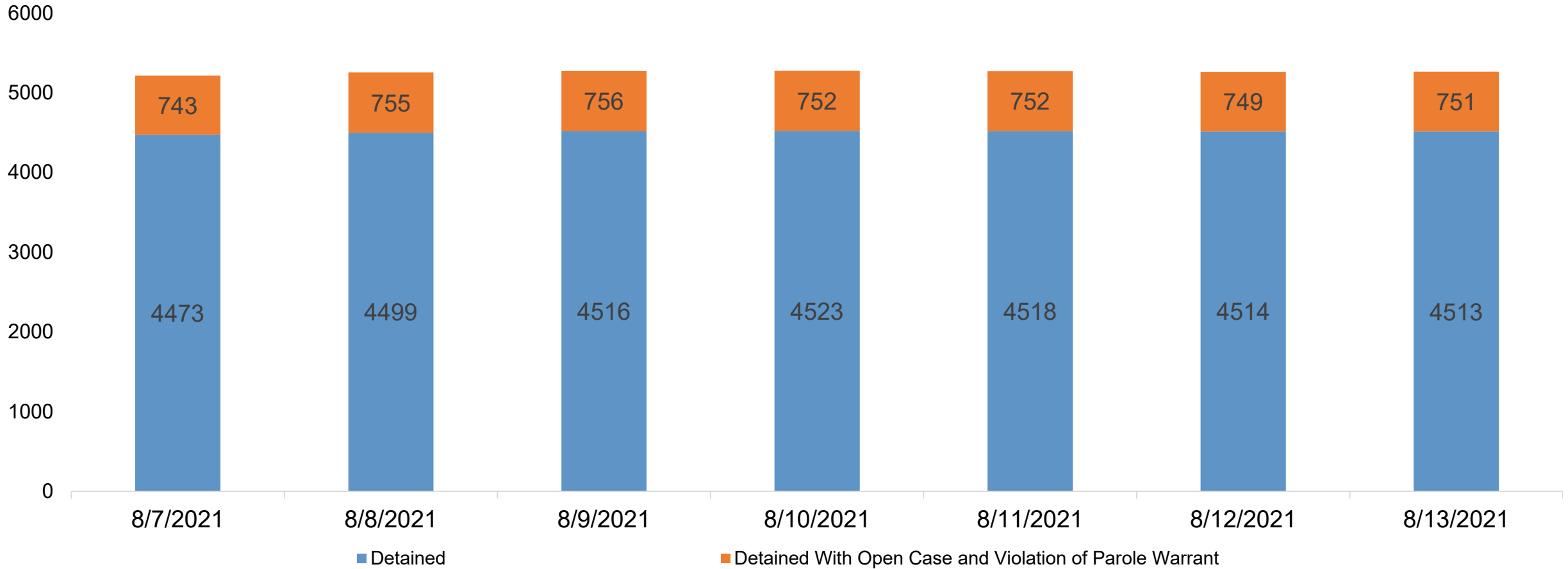

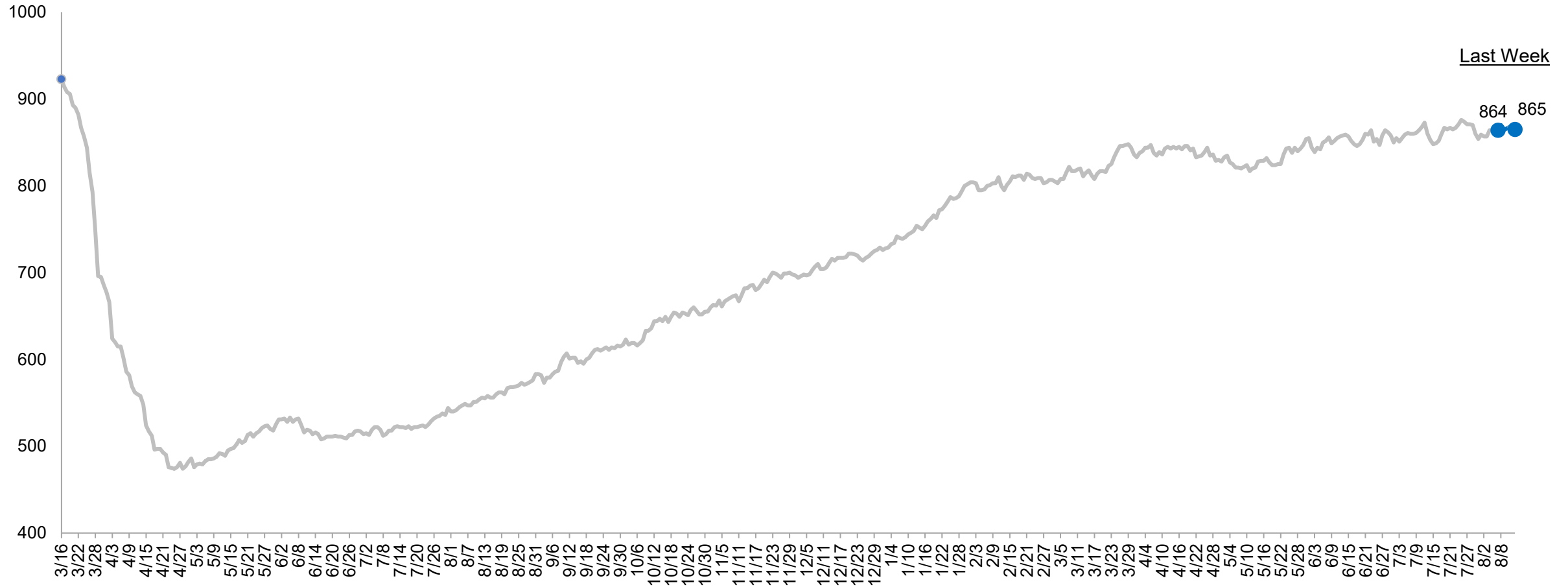

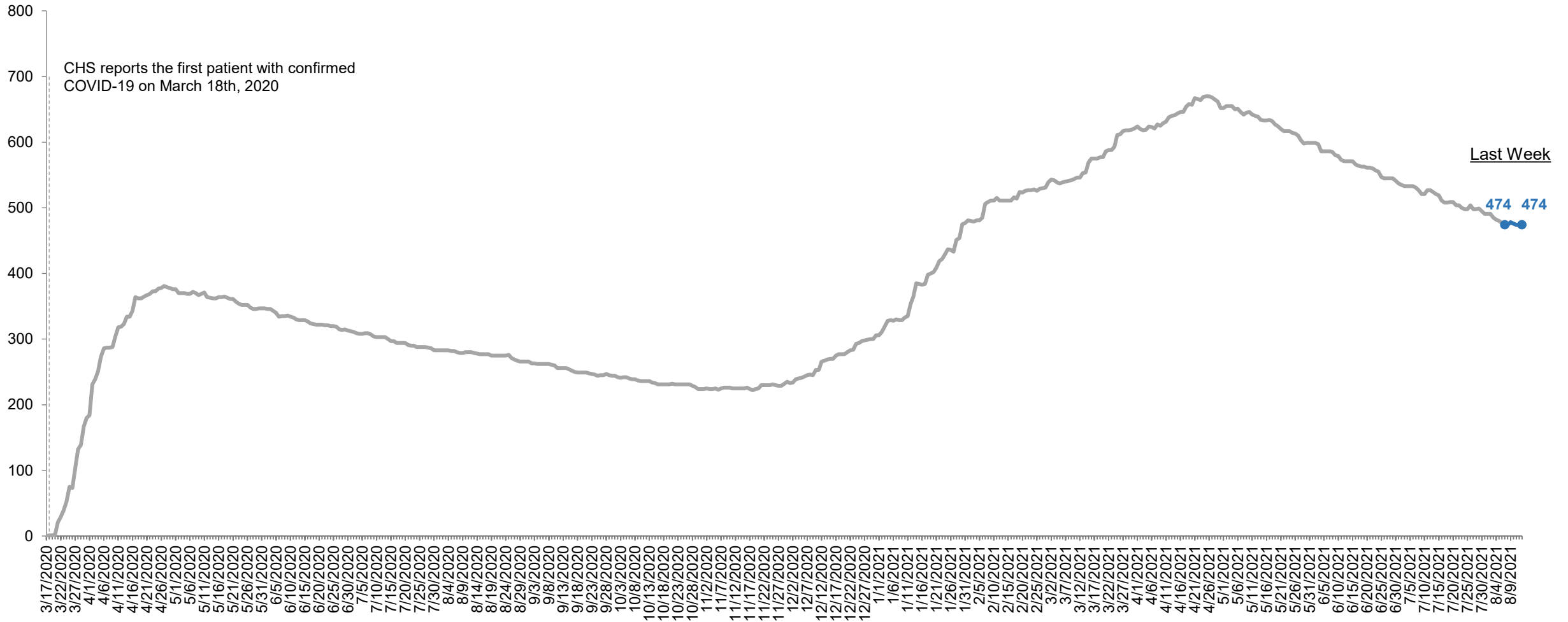
Number and Percent of Patients with Confirmed COVID-19

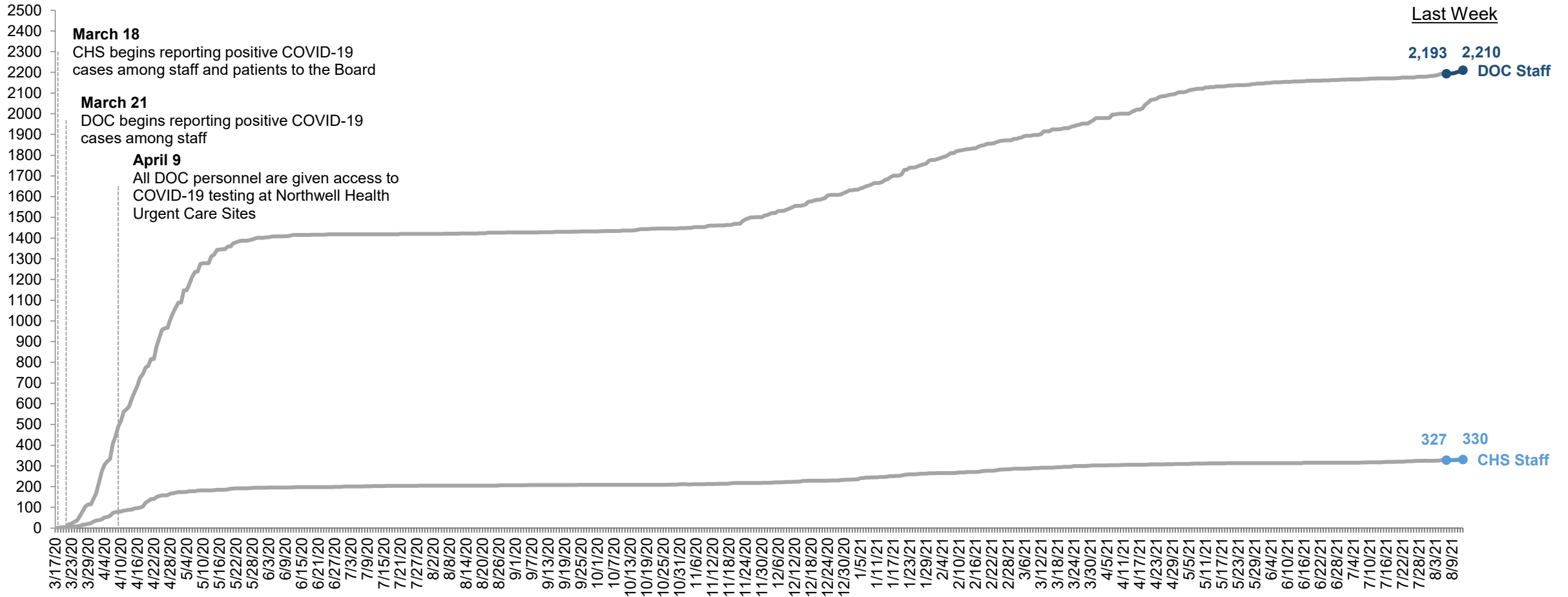

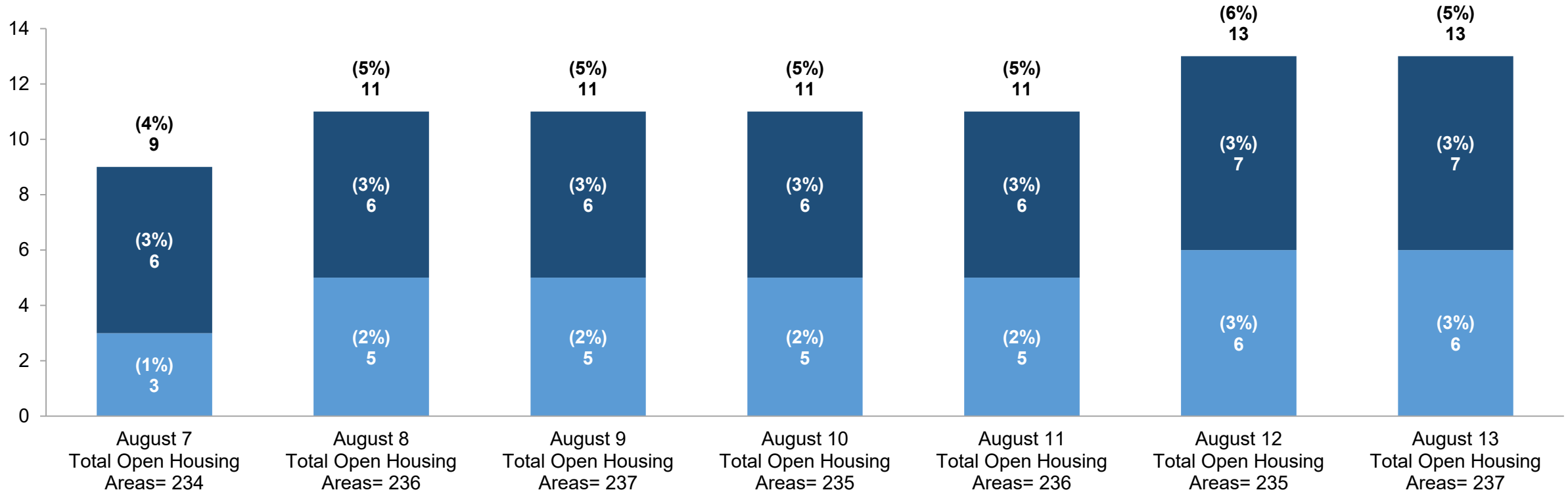

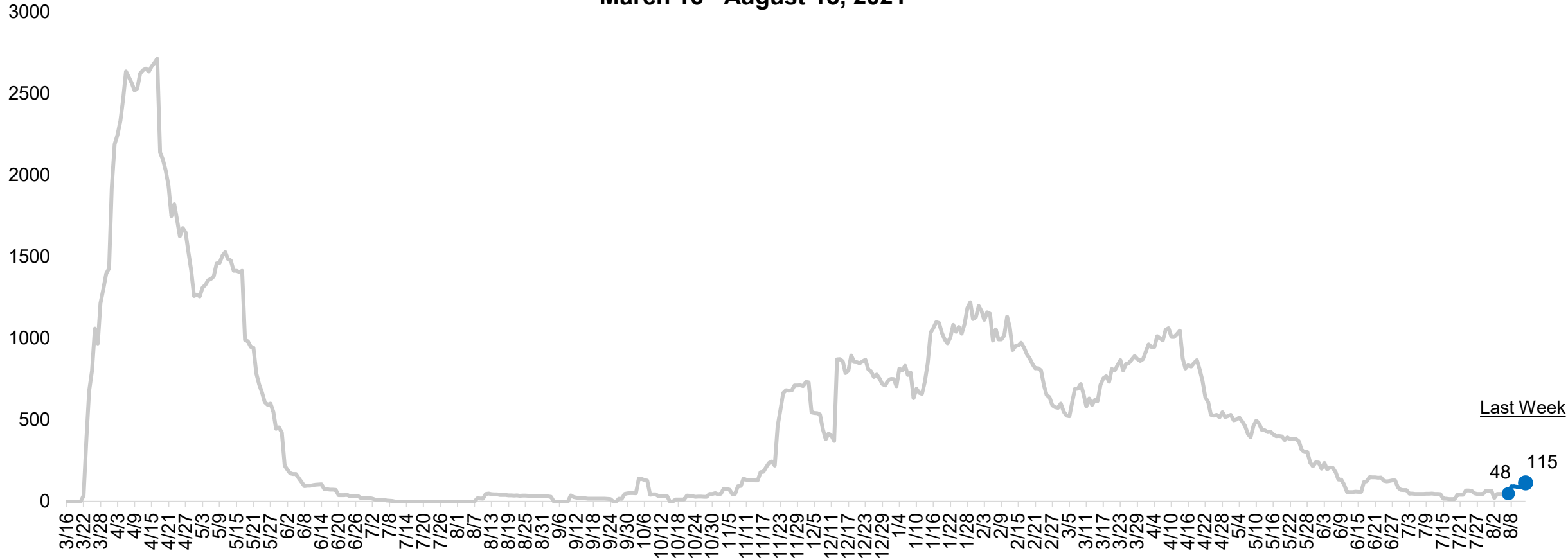

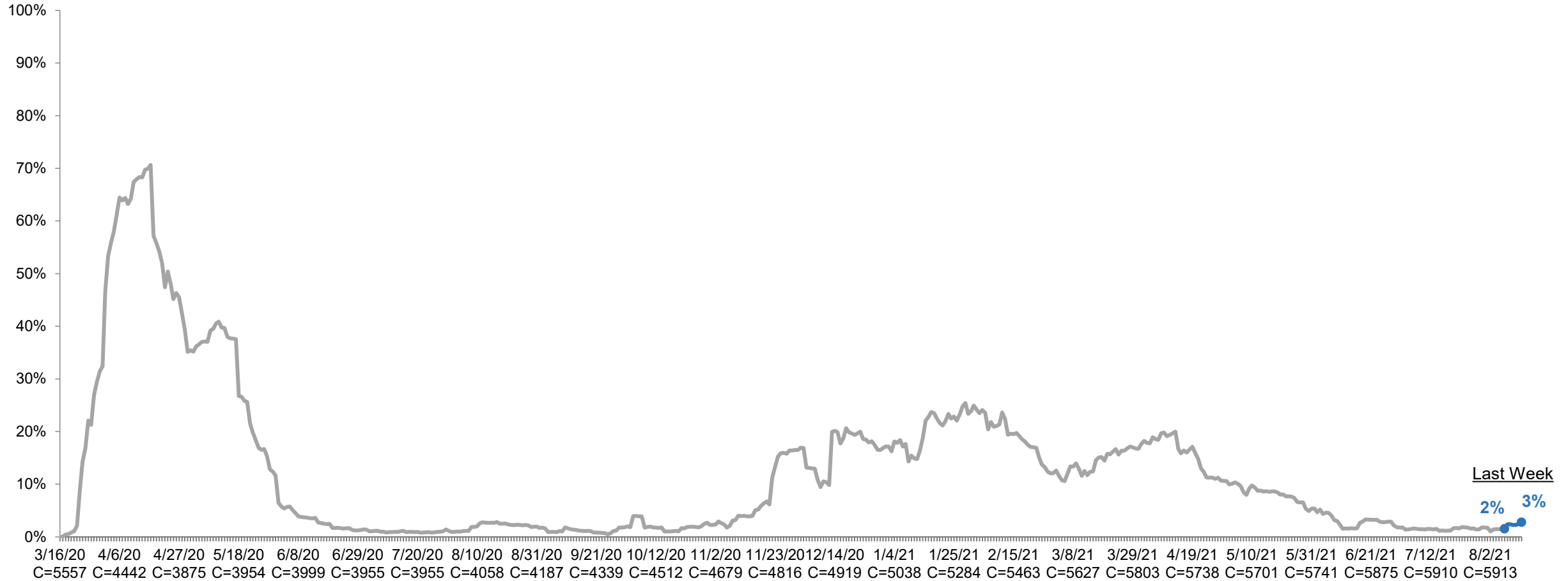

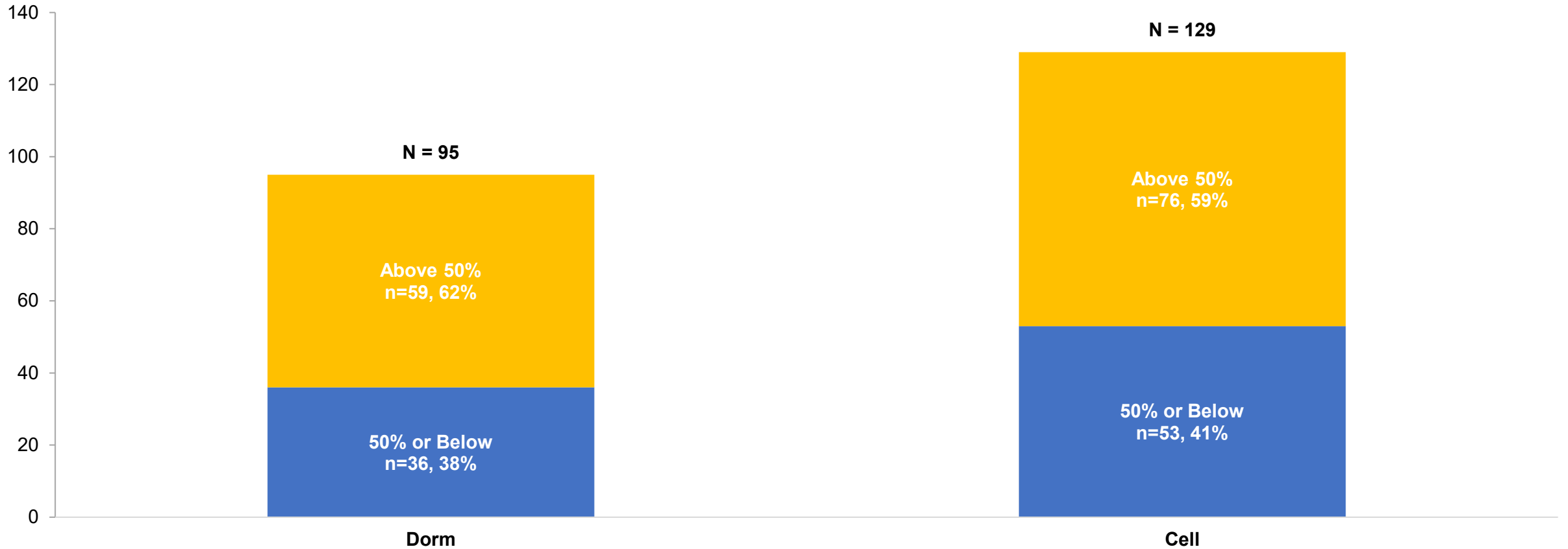

August 12, 2021



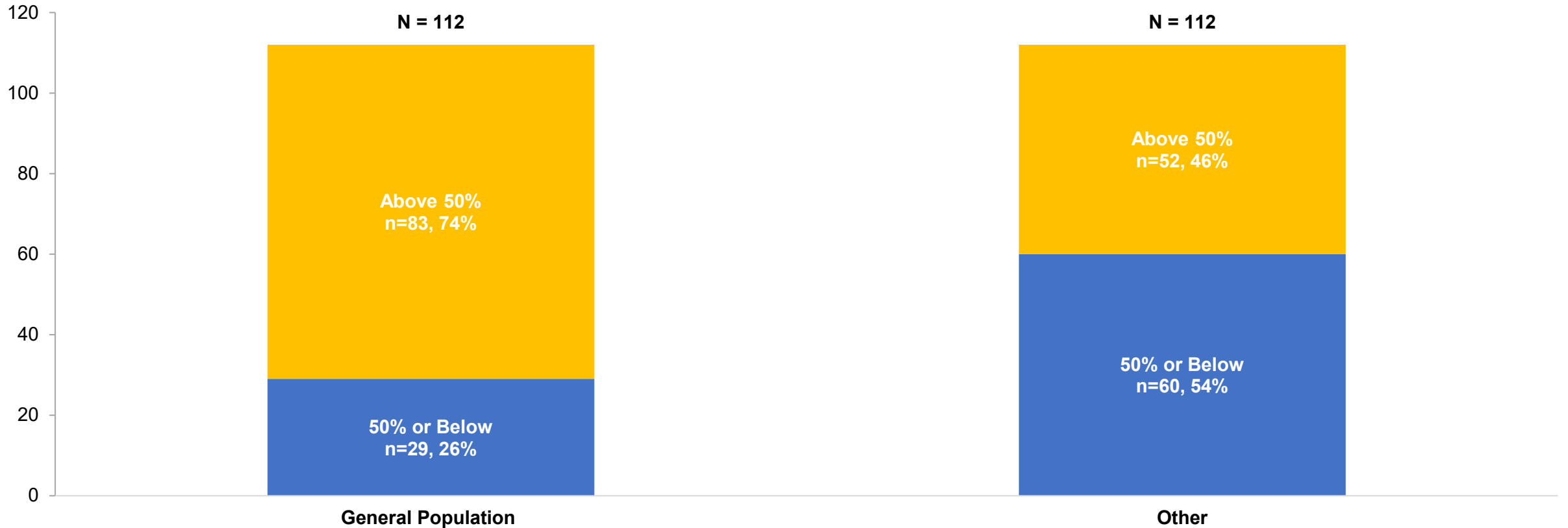

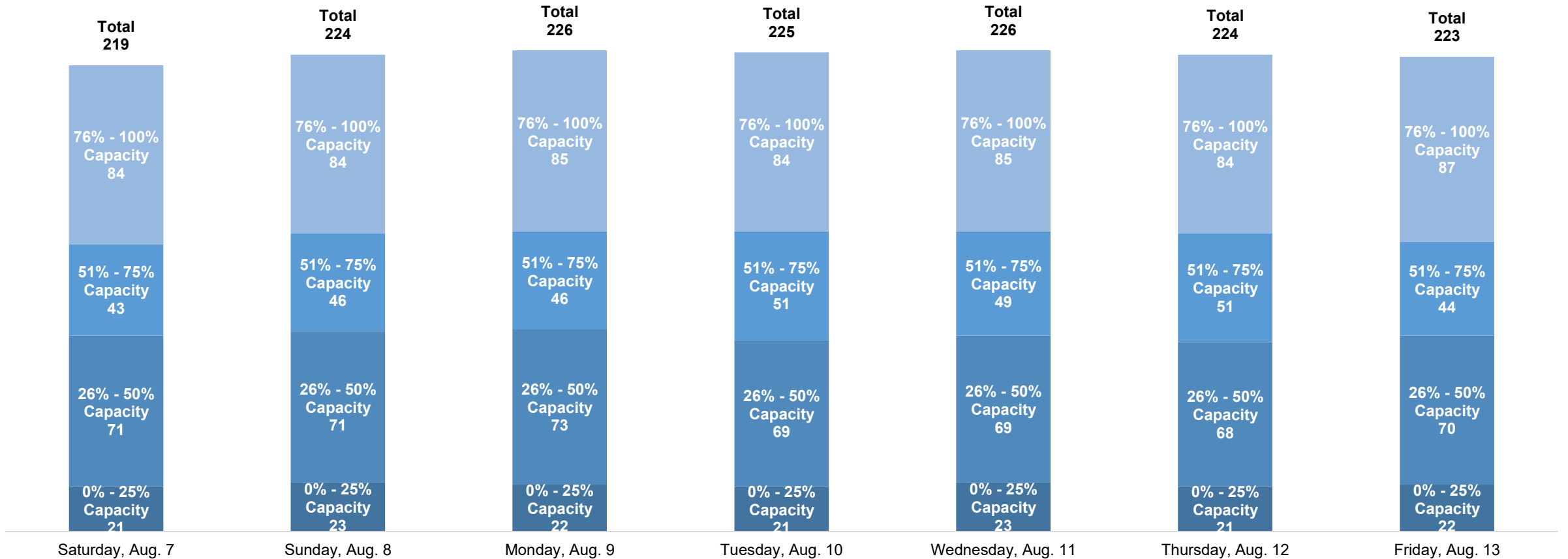
