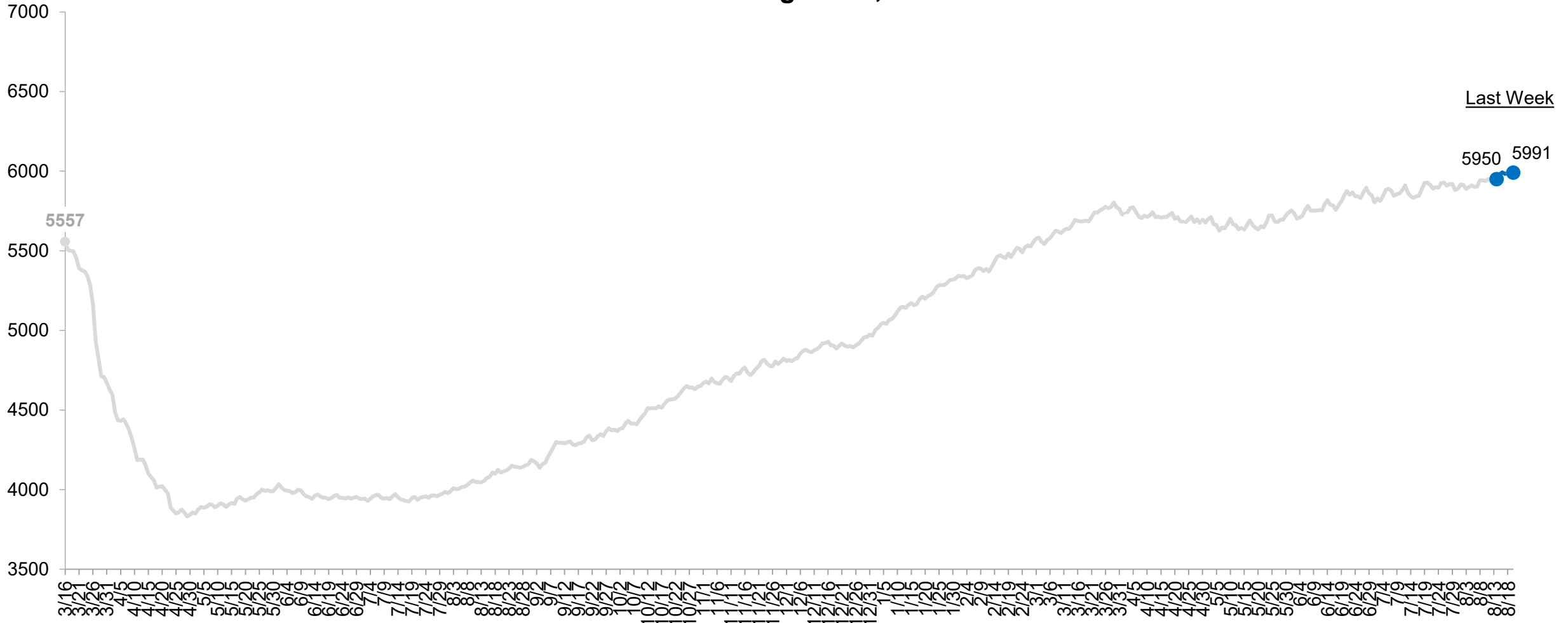

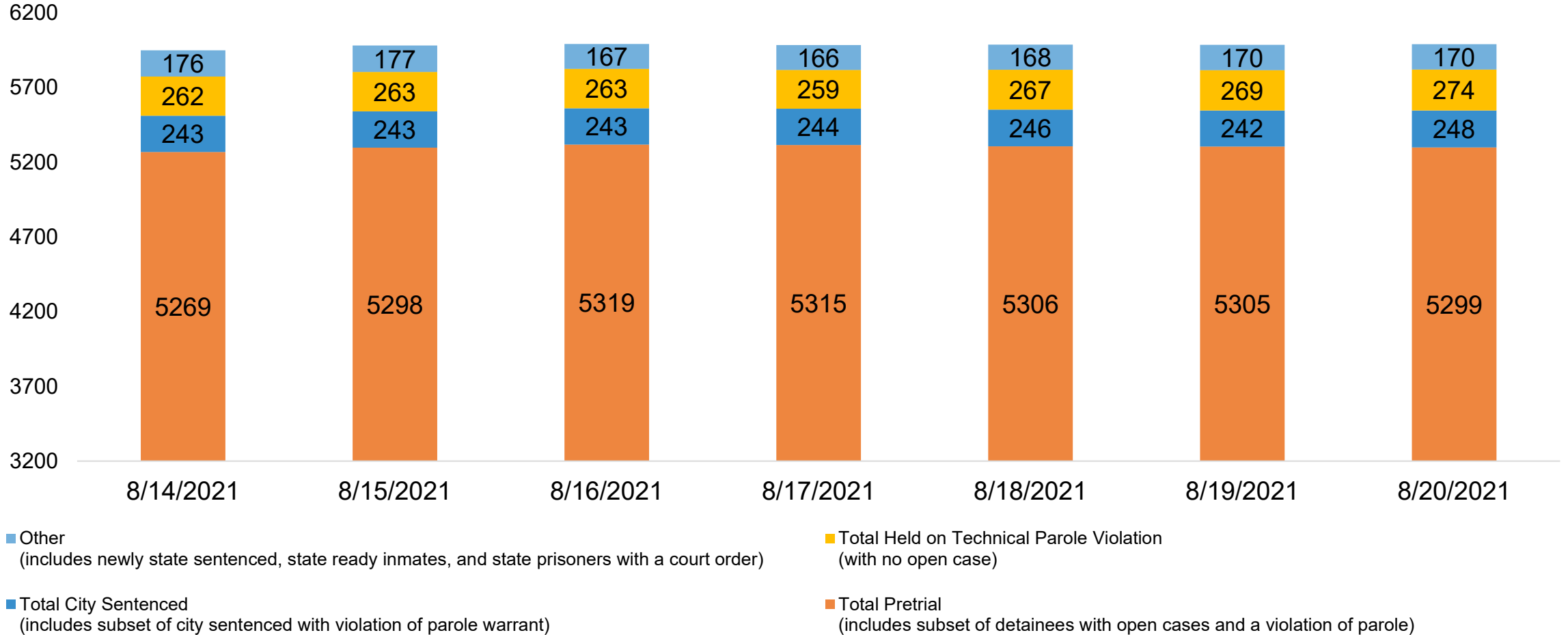
Total Population in DOC Custody March 16 – August 20, 2021

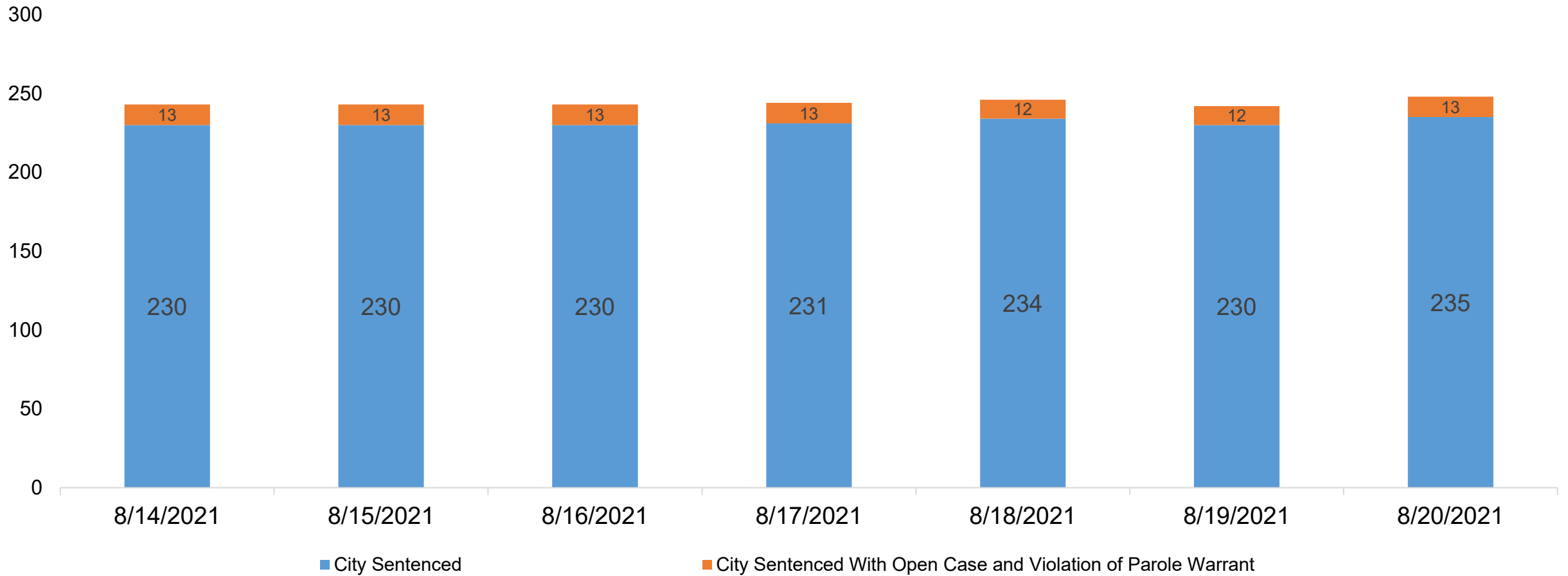

Total DOC Population by Custody Status, 8/14/2021 - 8/20/2021



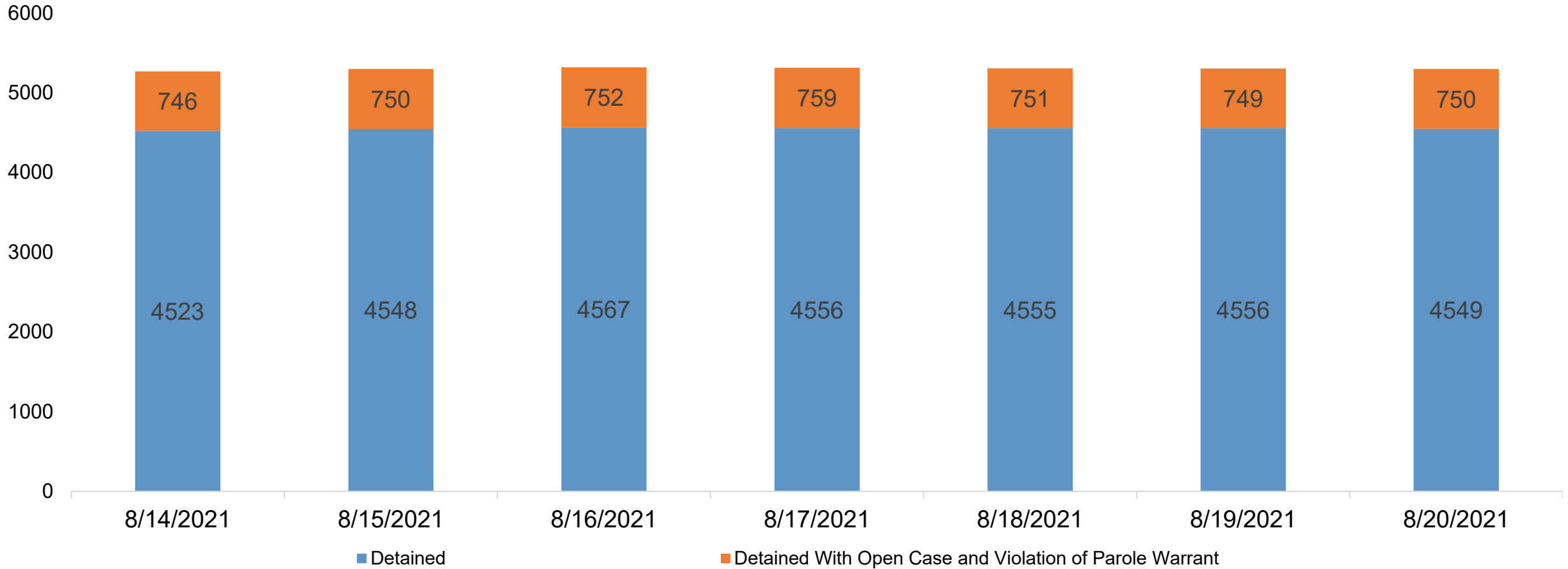

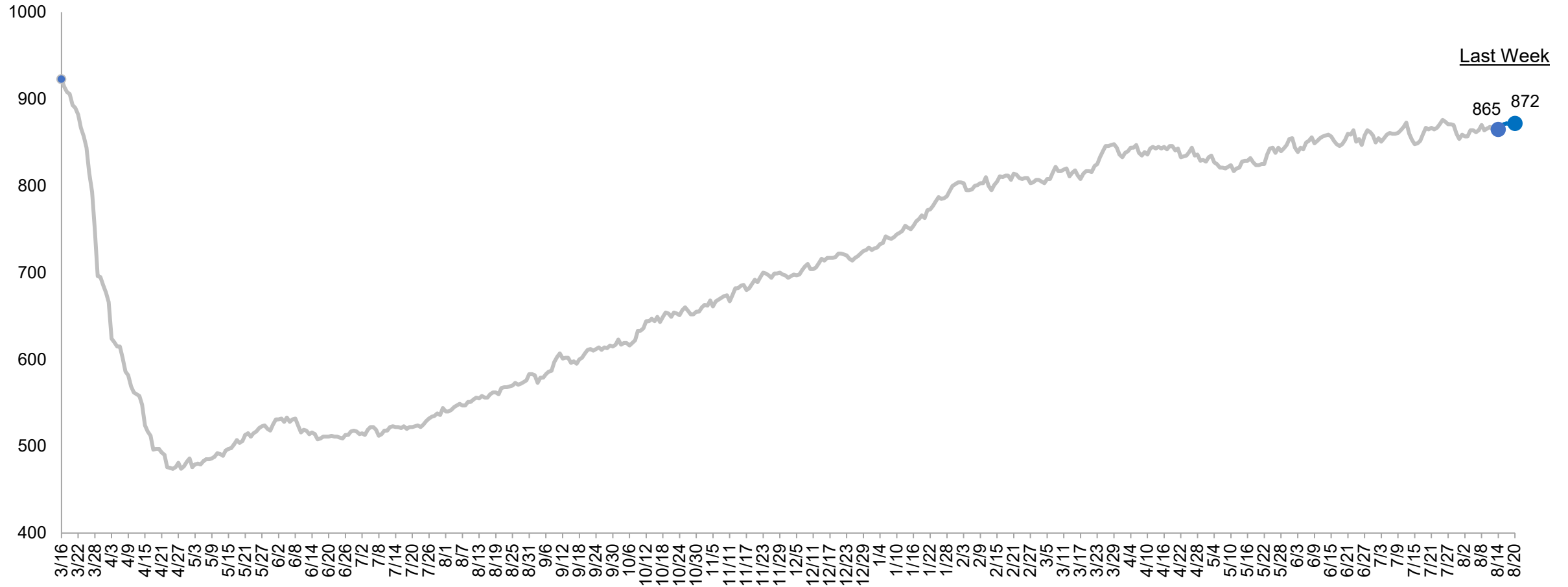

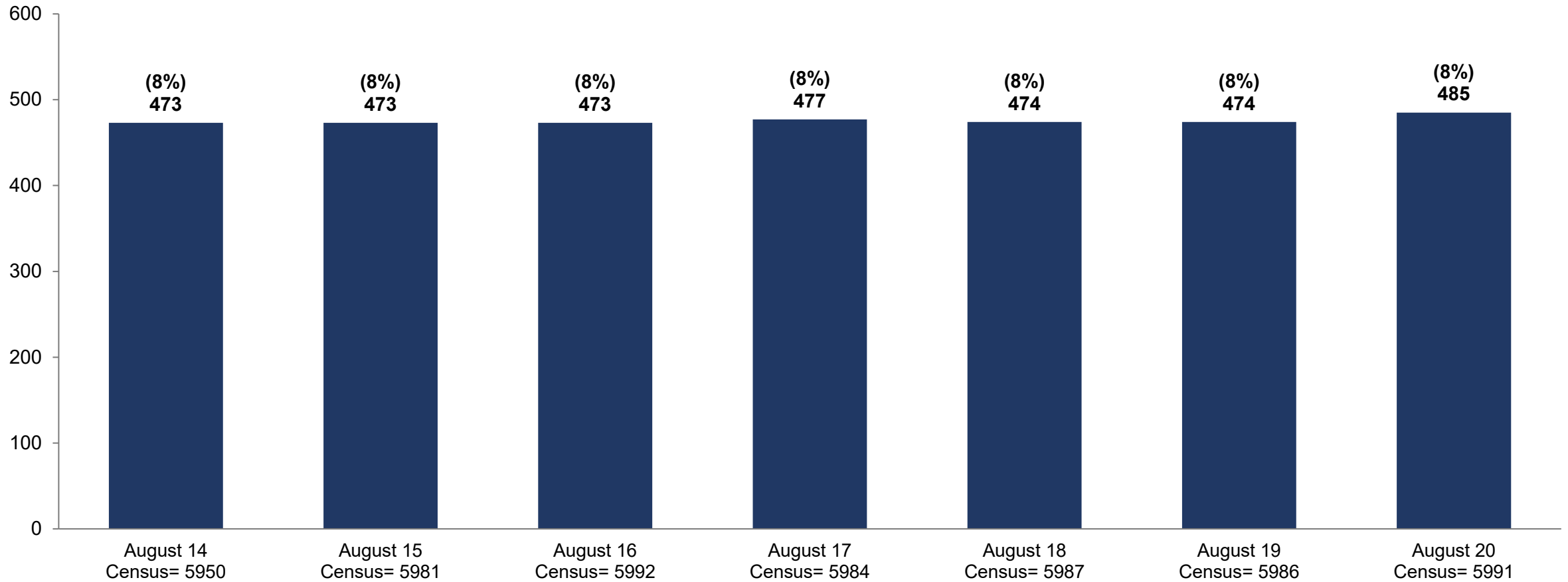

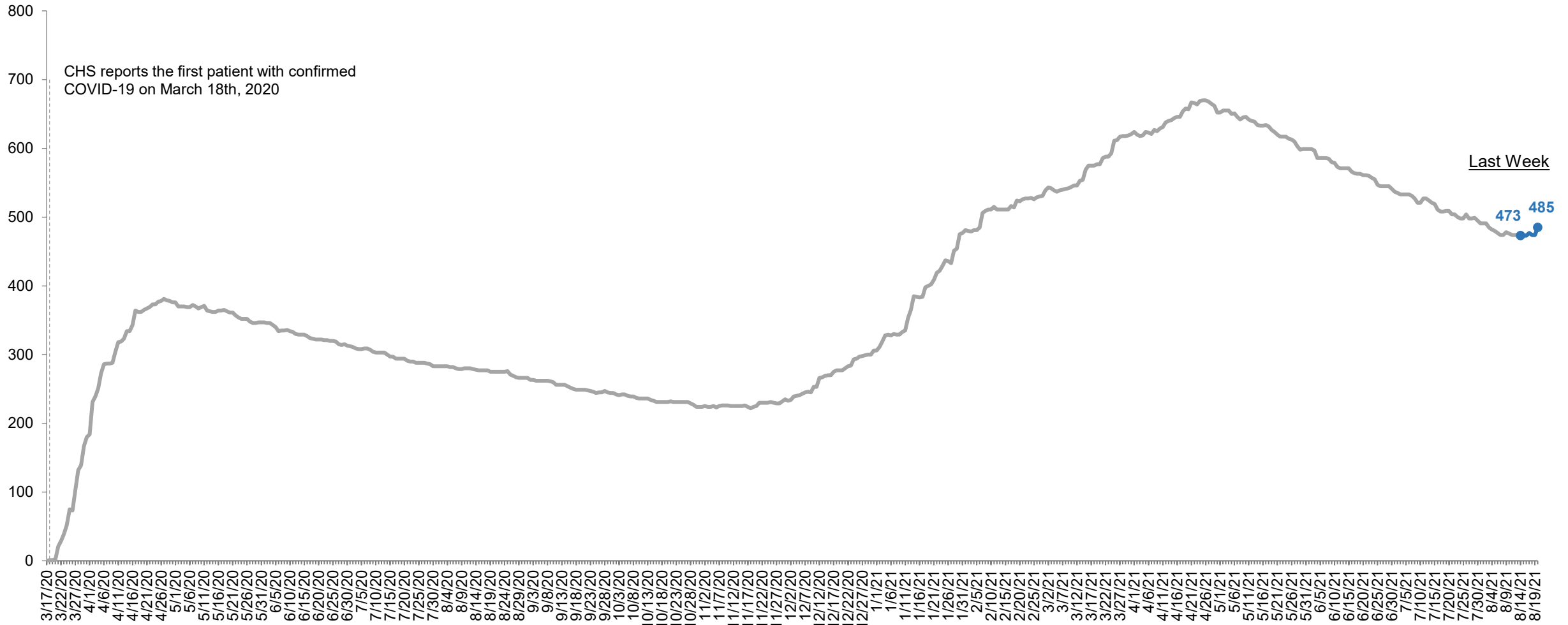
Number and Percent of Patients with Confirmed COVID-19

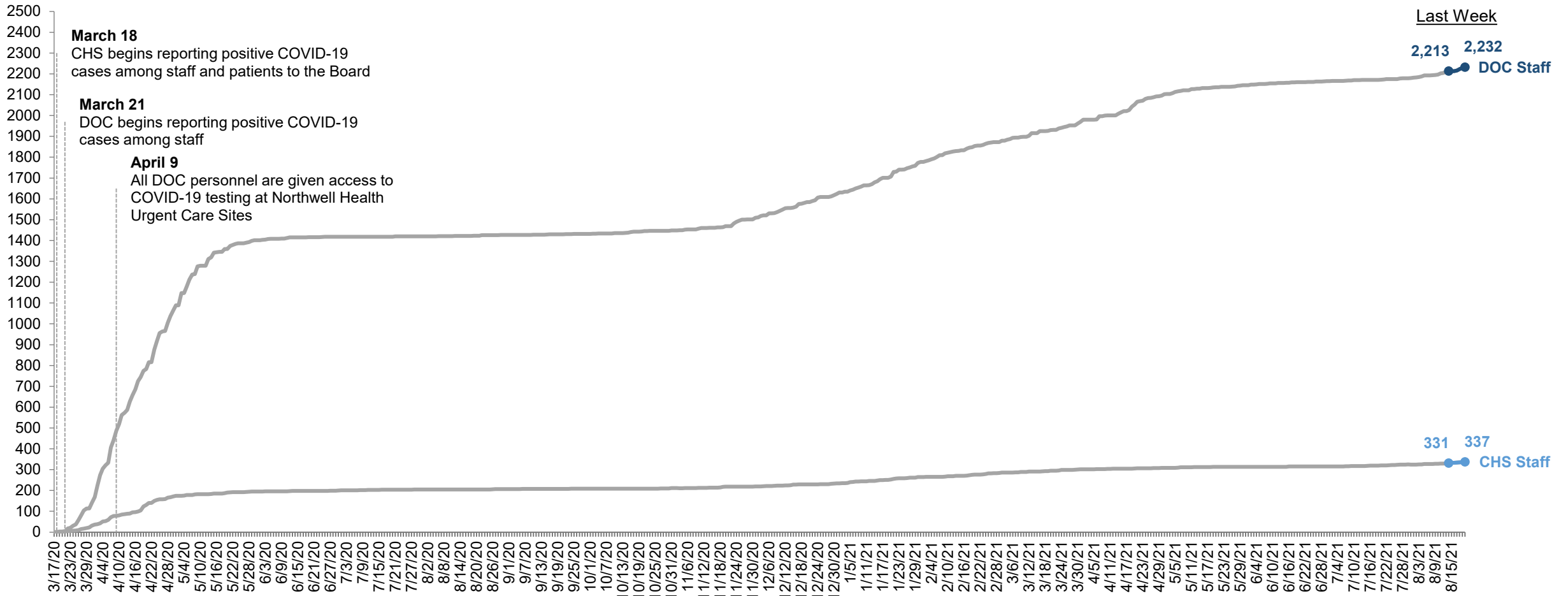
**Number of Currently Incarcerated Patients with Confirmed COVID-19

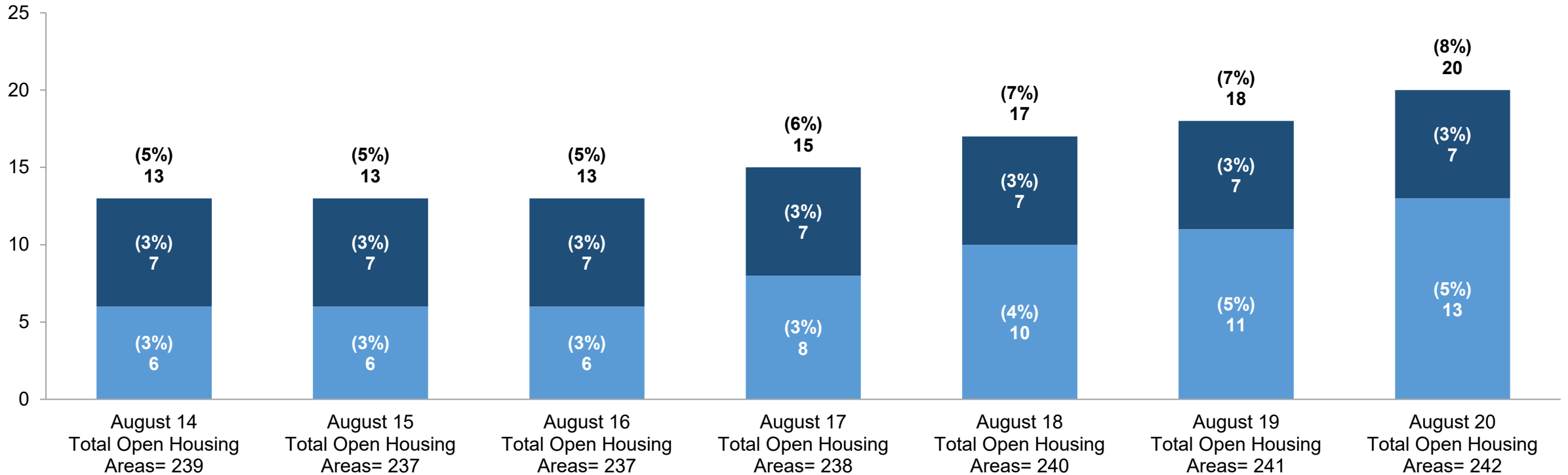

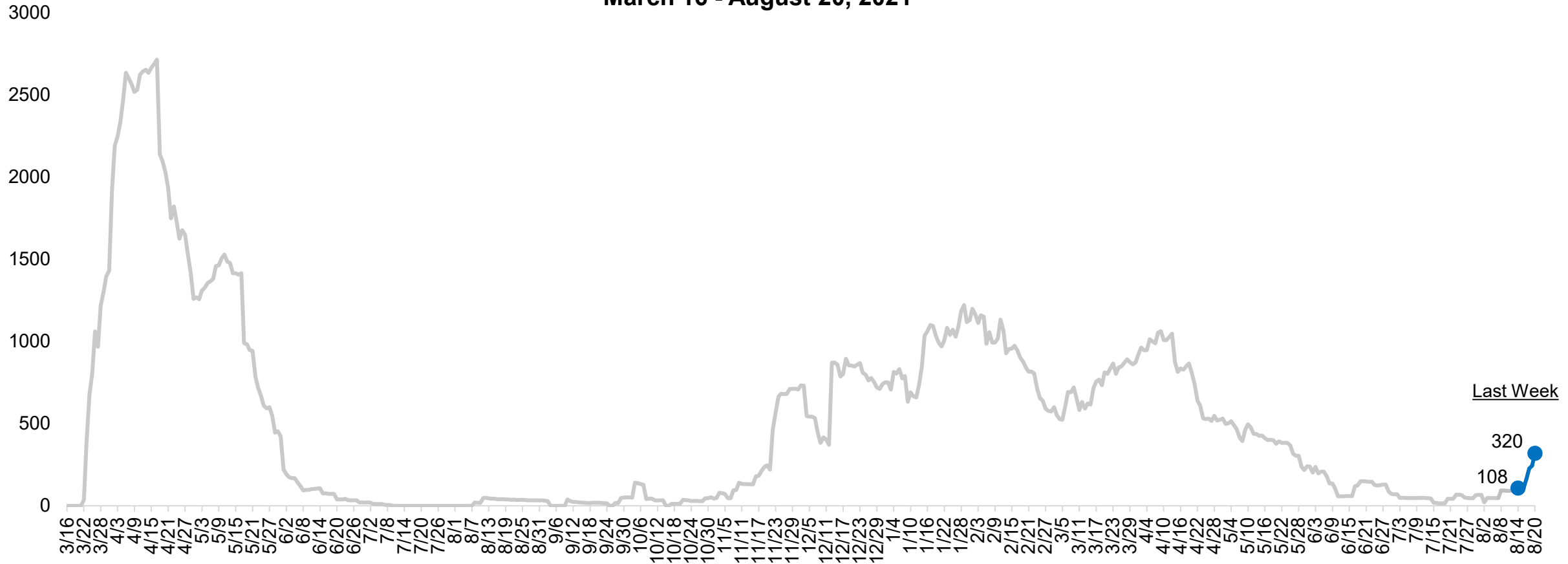

March 16 - August 20, 2021**

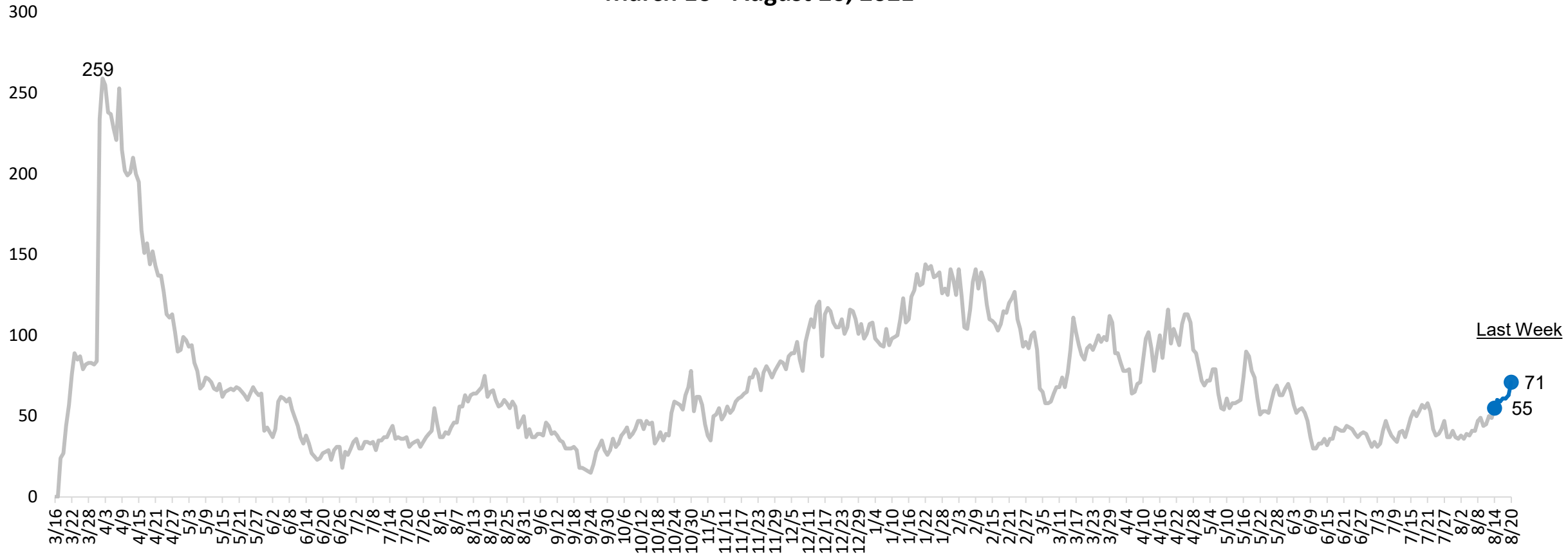

March 16 - August 20, 2021**



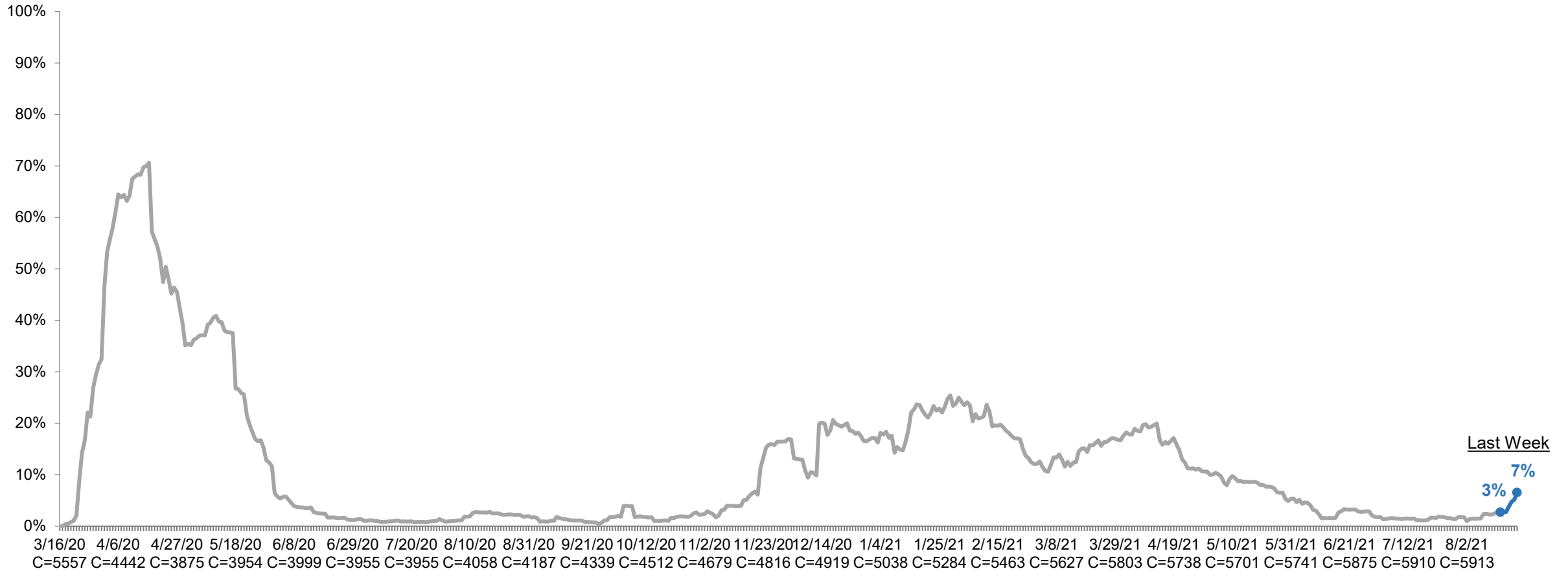

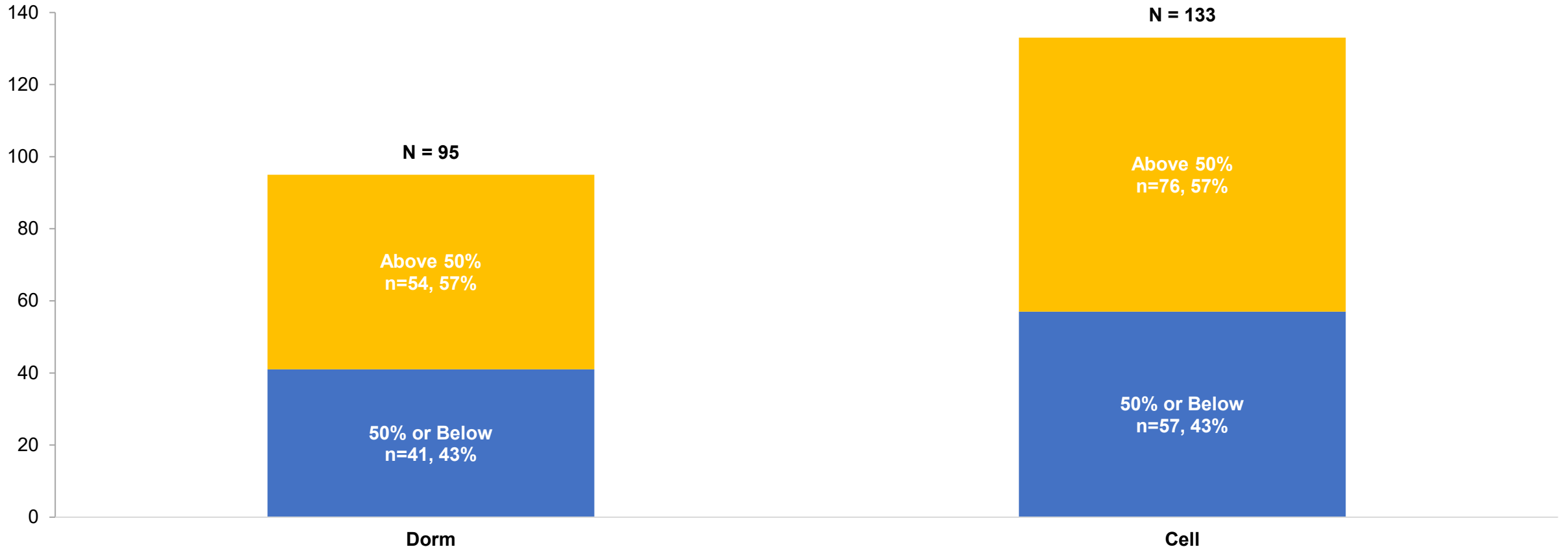

August 19, 2021



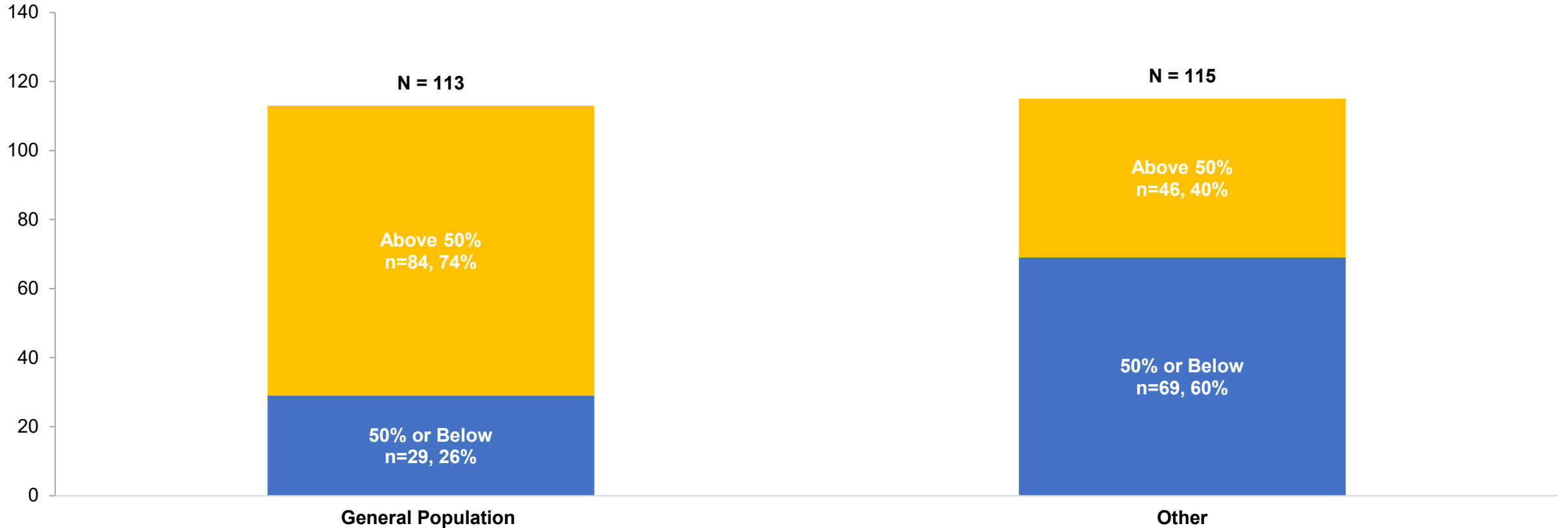

August 19, 2021



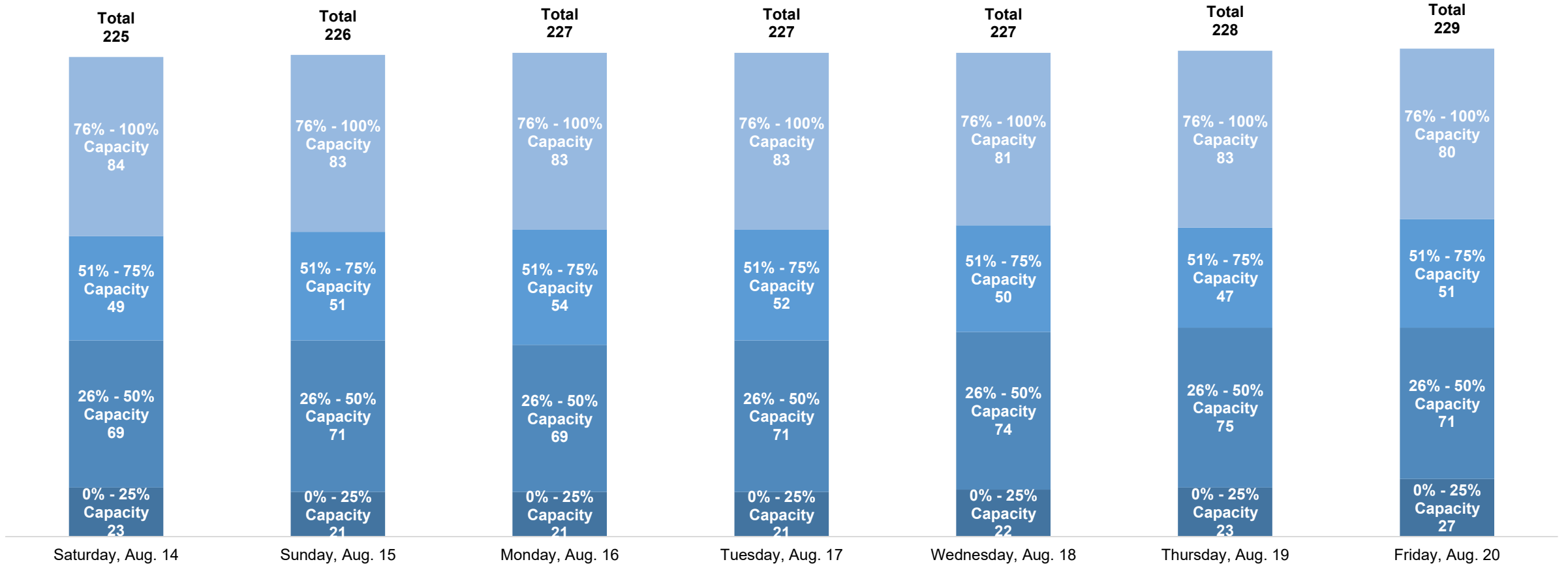
