




I. Population Change: DOC Population by Custody Status

Total DOC Population by Custody Status, 8/21/2021 - 8/27/2021










Number and Percent of Patients with Confirmed COVID-19 August 21 – August 27, 2021


Number of Currently Incarcerated Patients with Confirmed COVID-19 March 17, 2020 – August 27, 2021








III. Housing: People in Likely Exposed but Asymptomatic Housing¹


