




I. Population Change: DOC Population by Custody Status

Total DOC Population by Custody Status, 9/4/2021 - 9/10/2021















■ Confirmed COVID-19 or Symptomatic Housing






III. Housing: People in Likely Exposed but Asymptomatic Housing¹








