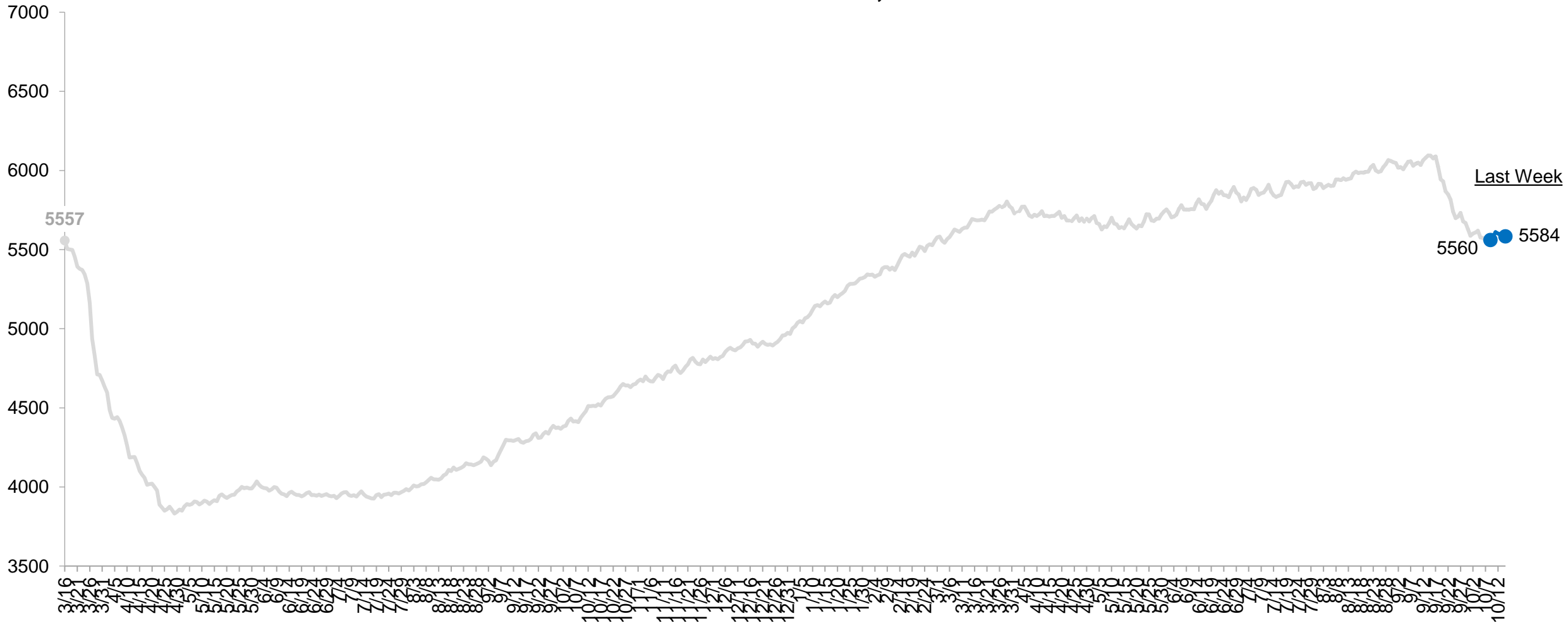

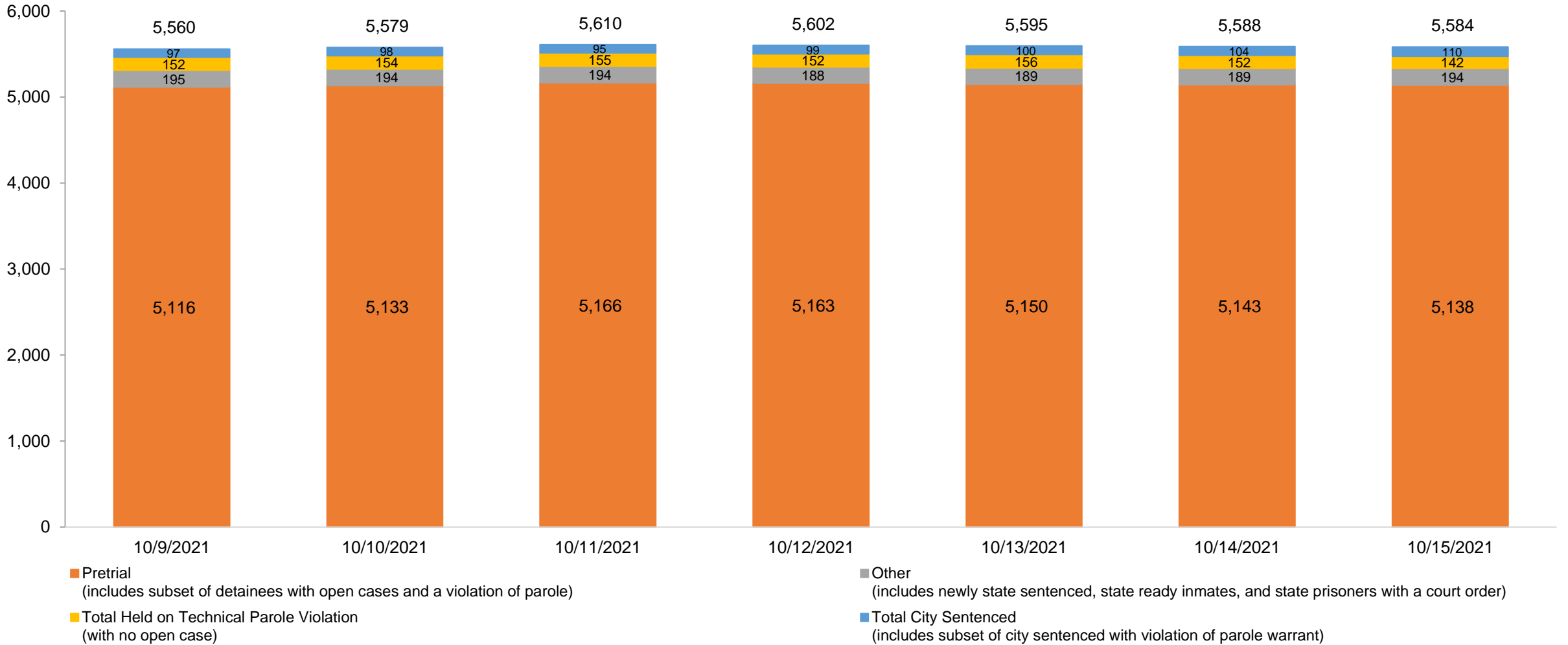
Total Population in DOC Custody March 16 – October 15, 2021

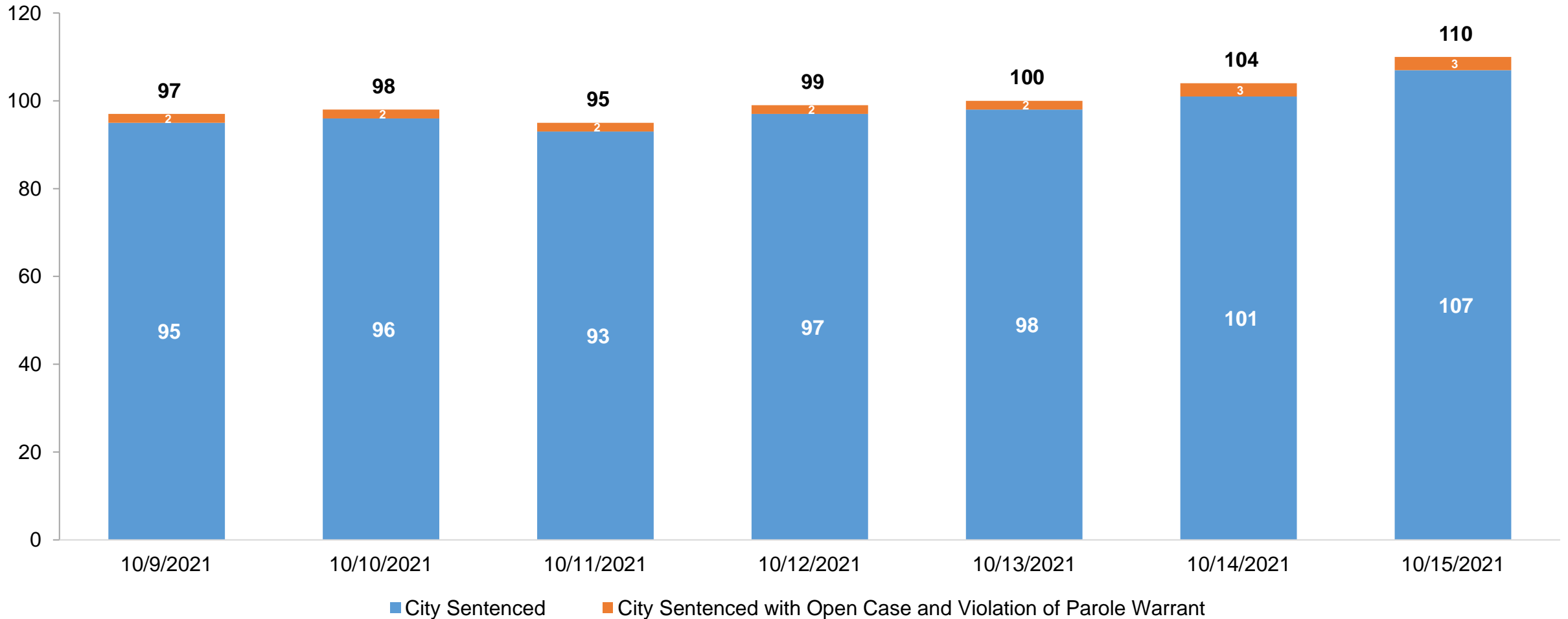

I. Population Change: City Sentenced Population by Custody Status

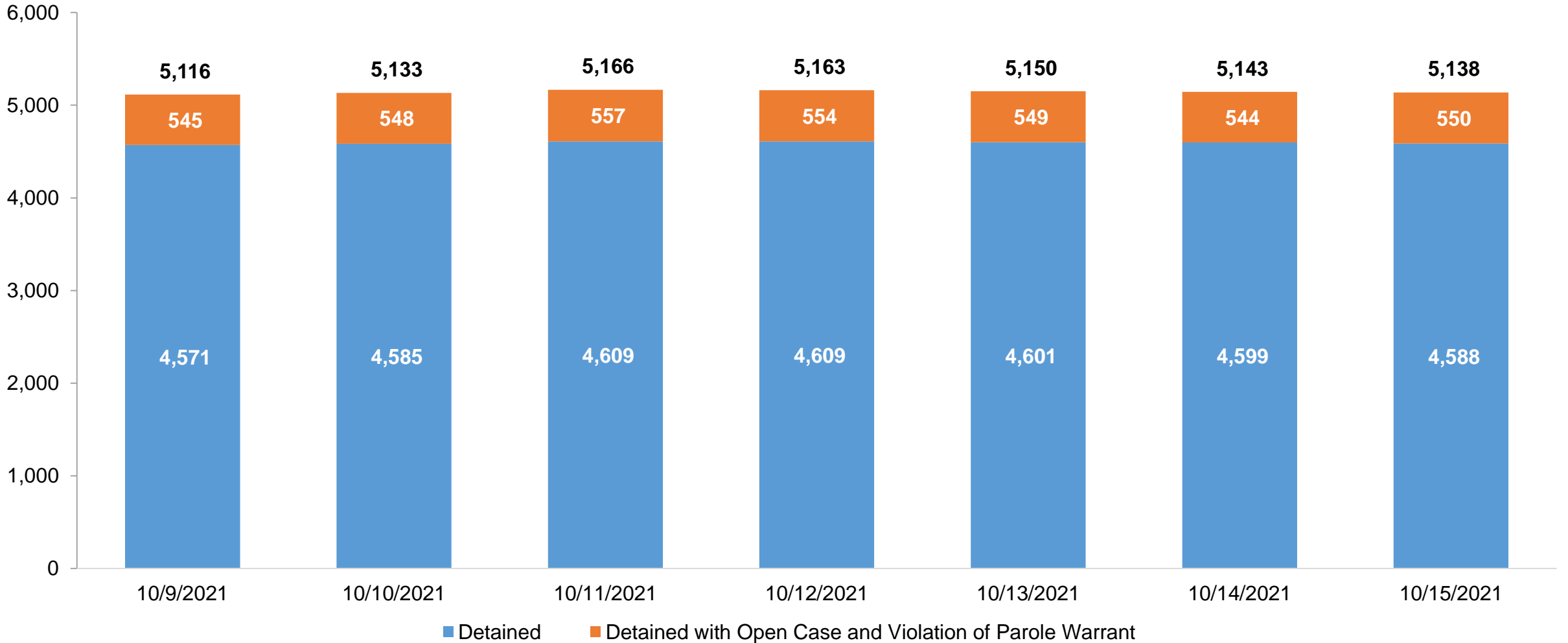
City Sentenced Population by Custody Status October 9, 2021 – October 15, 2021

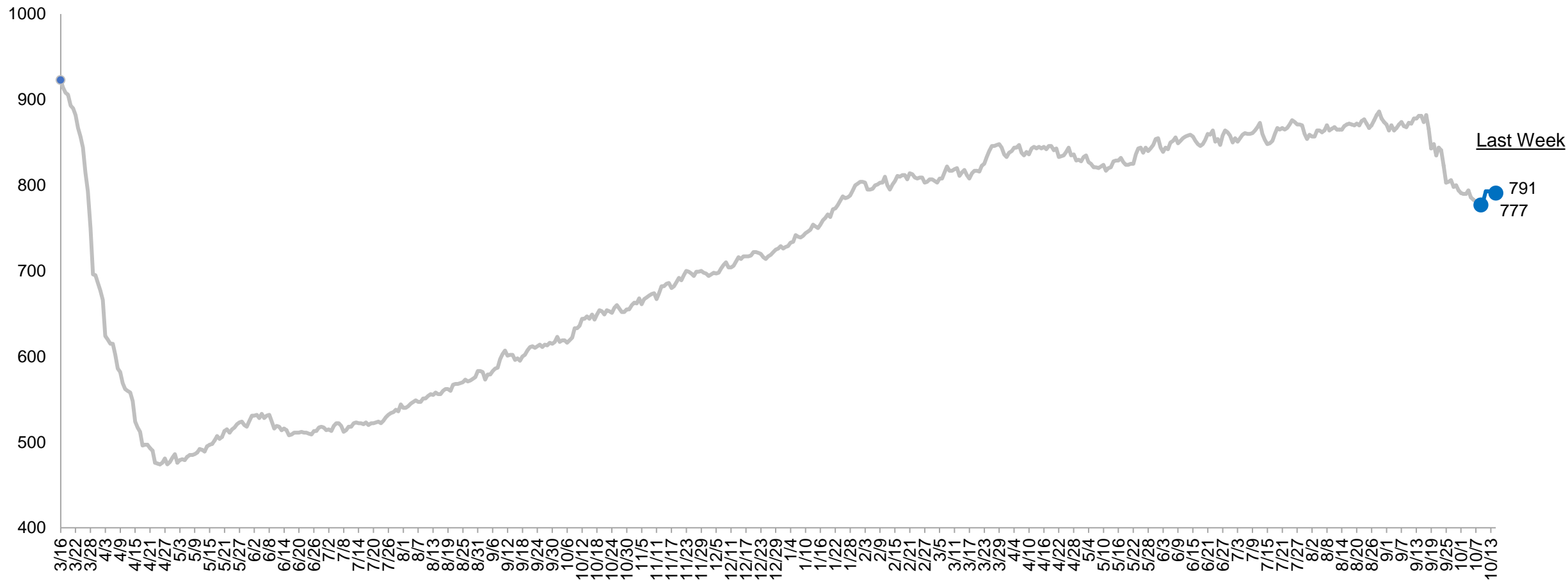

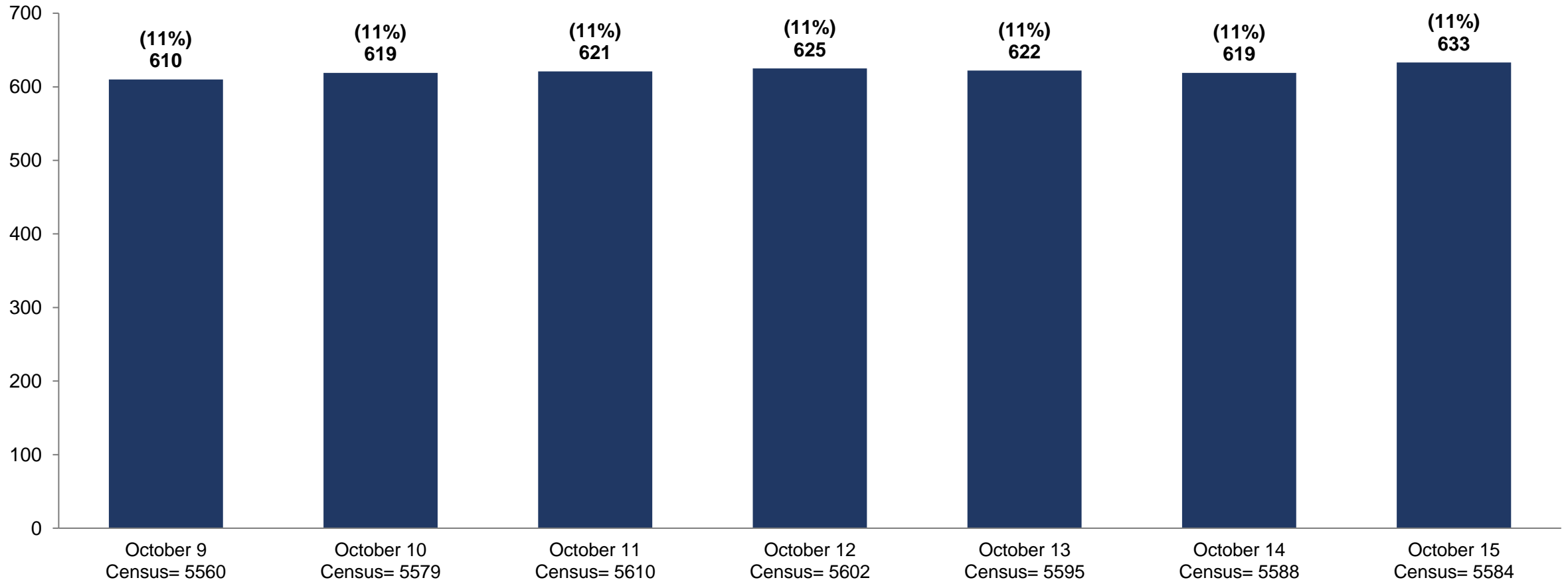

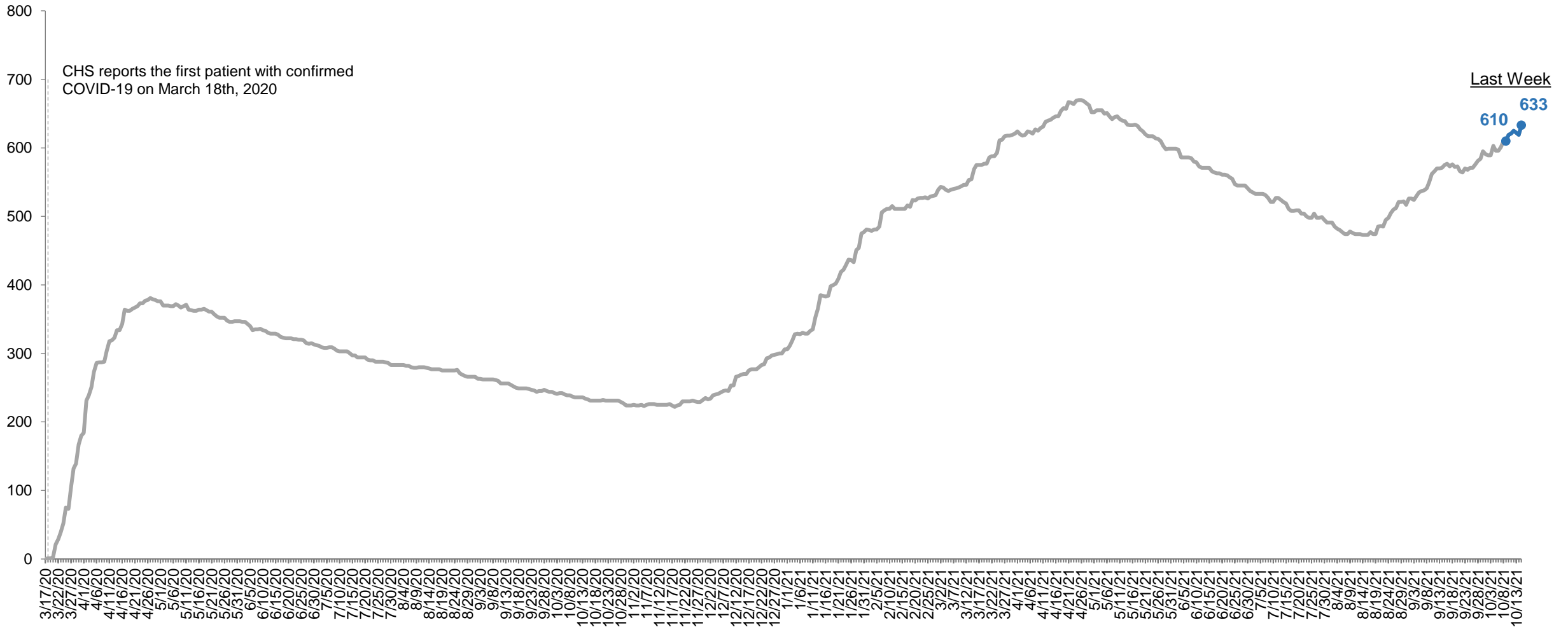
**Number and Percent of Patients with Confirmed COVID-19

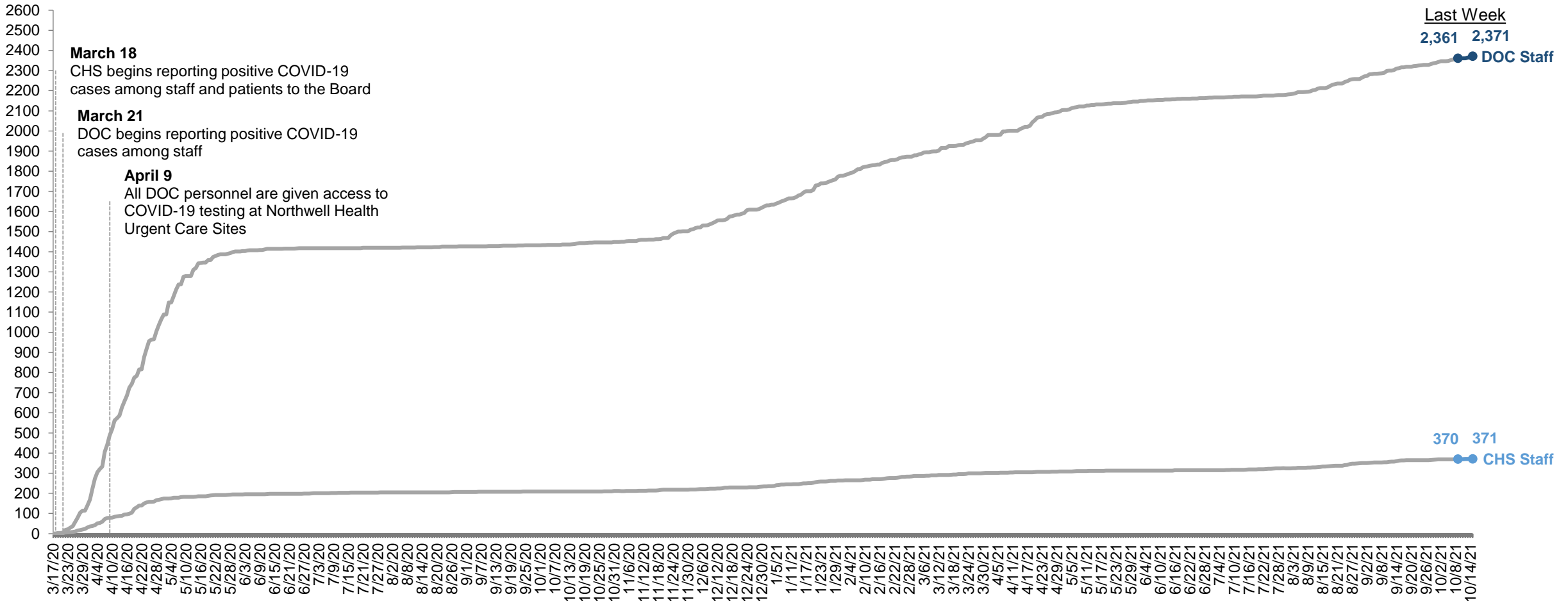
**Number of Incarcerated Patients Ever Confirmed Positive for COVID-19 While in Custody

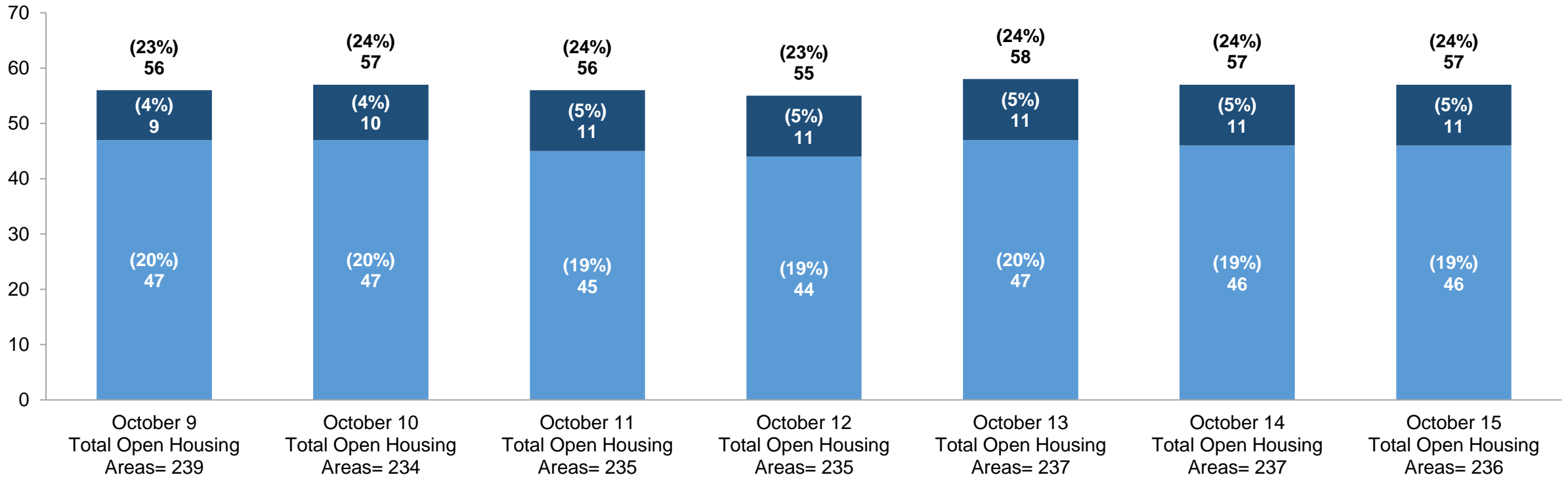

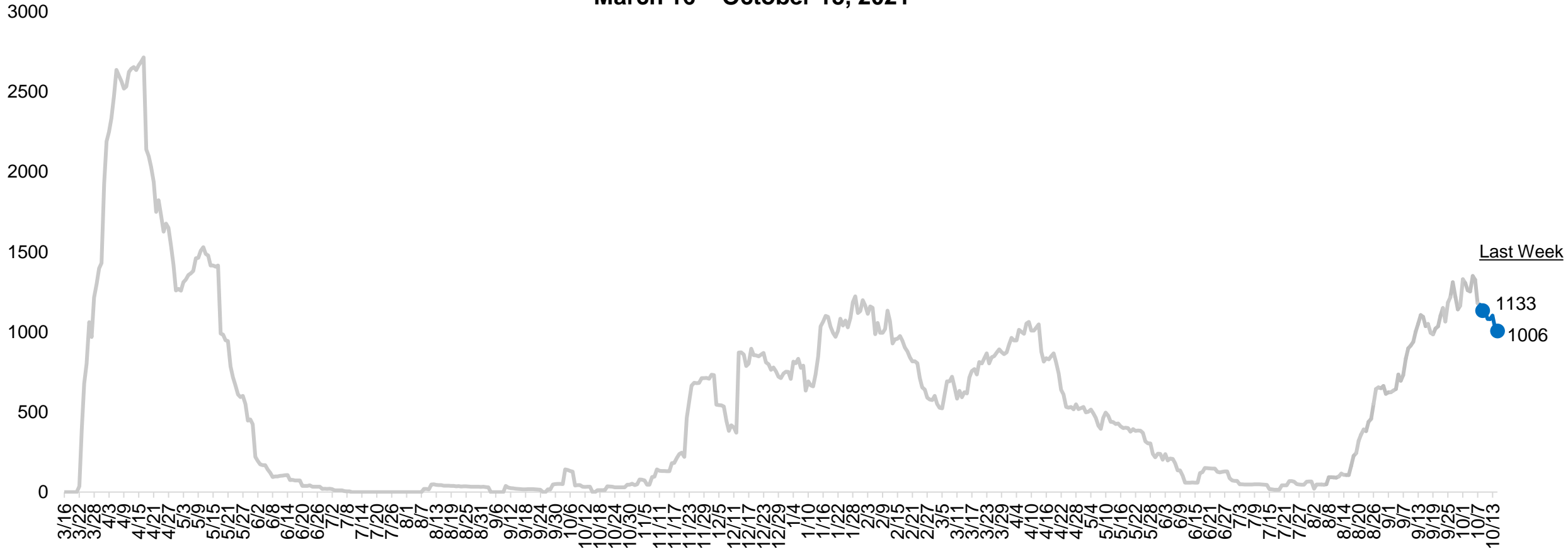

March 16 – October 15, 2021**

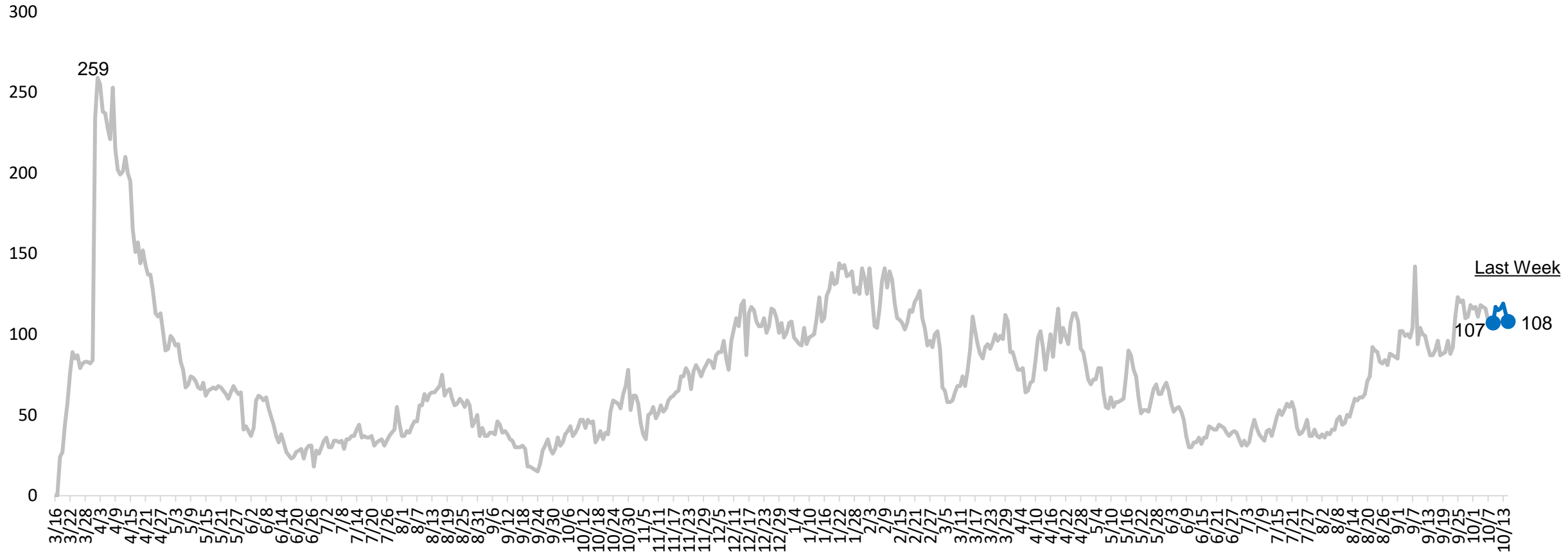

March 16 – October 15, 2021**

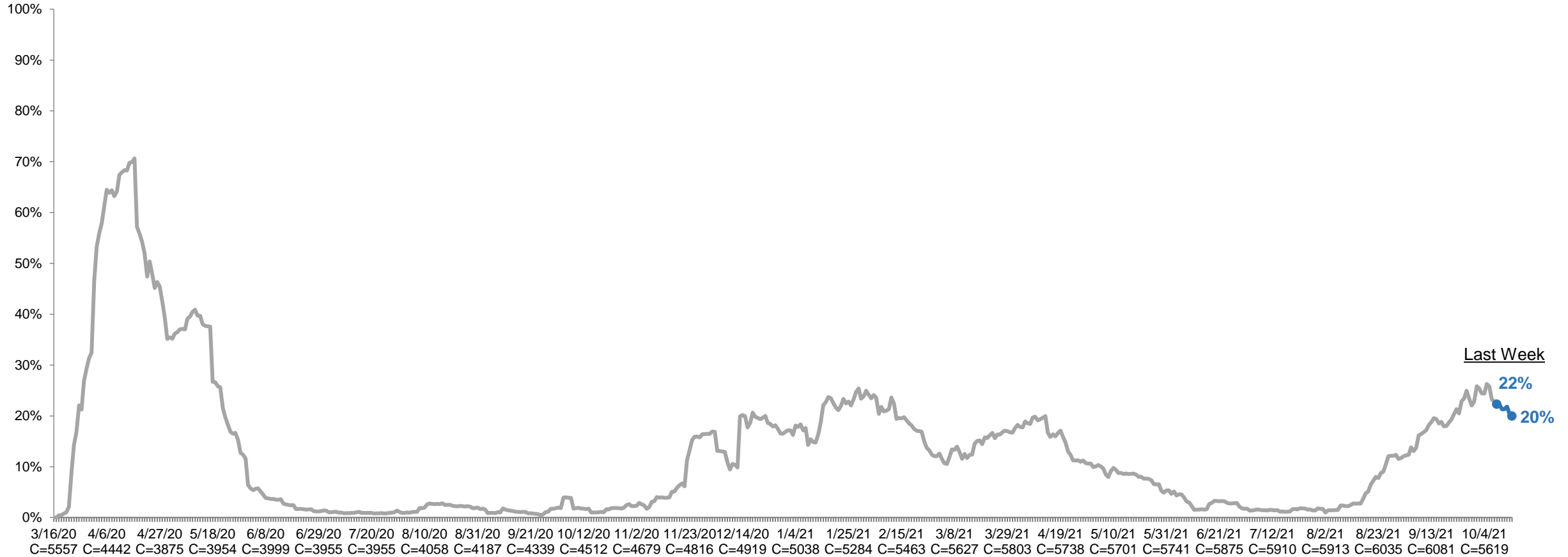

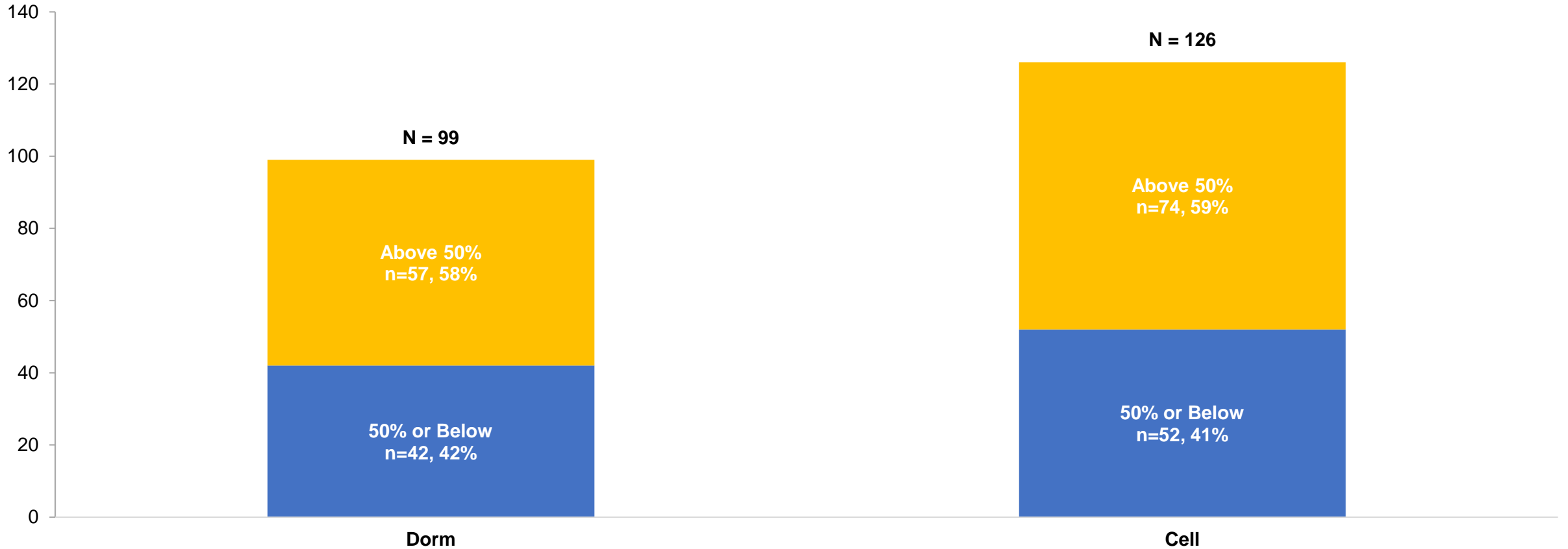

October 14, 2021



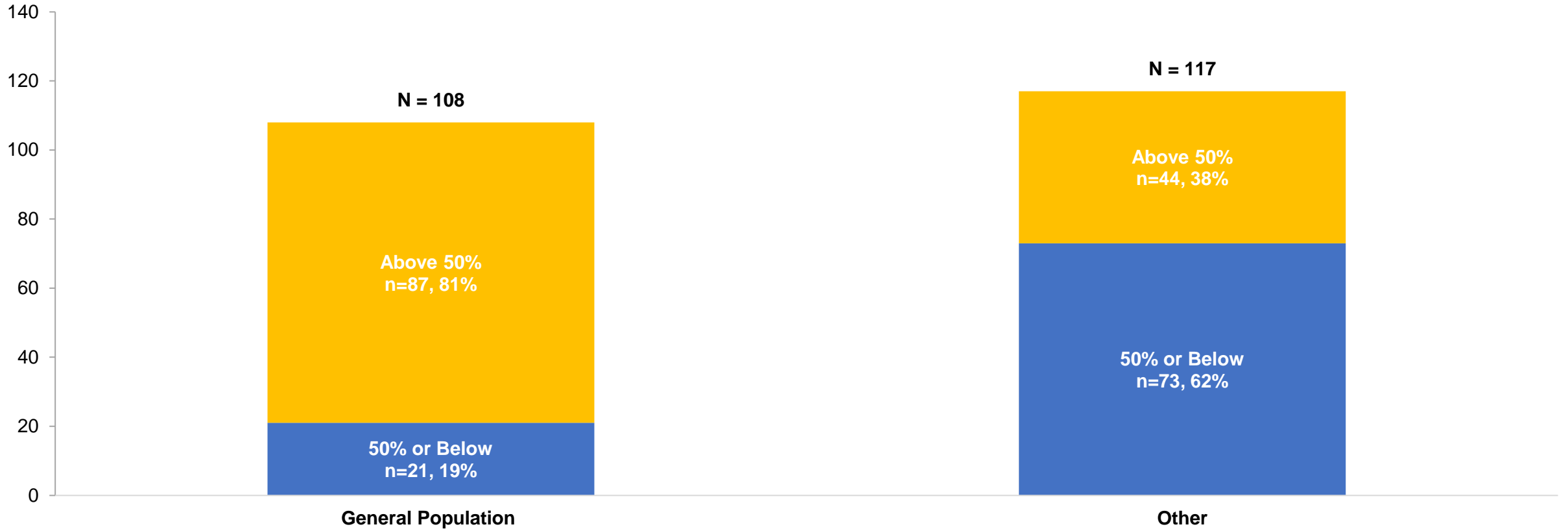

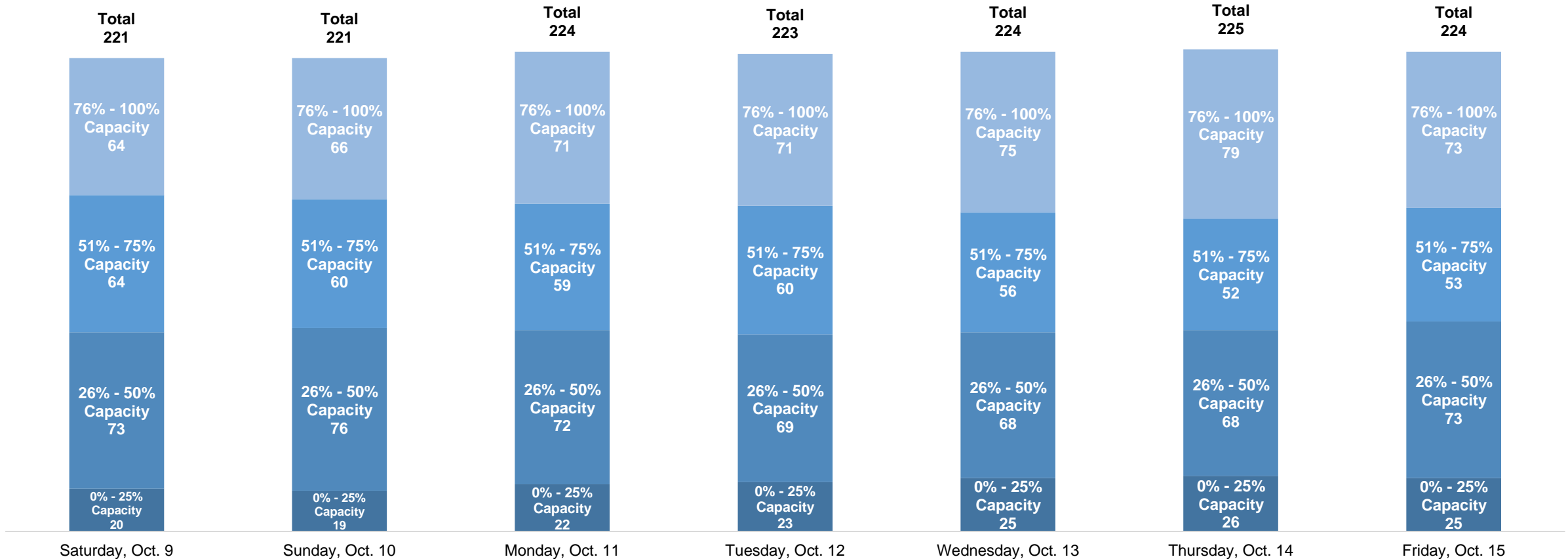
