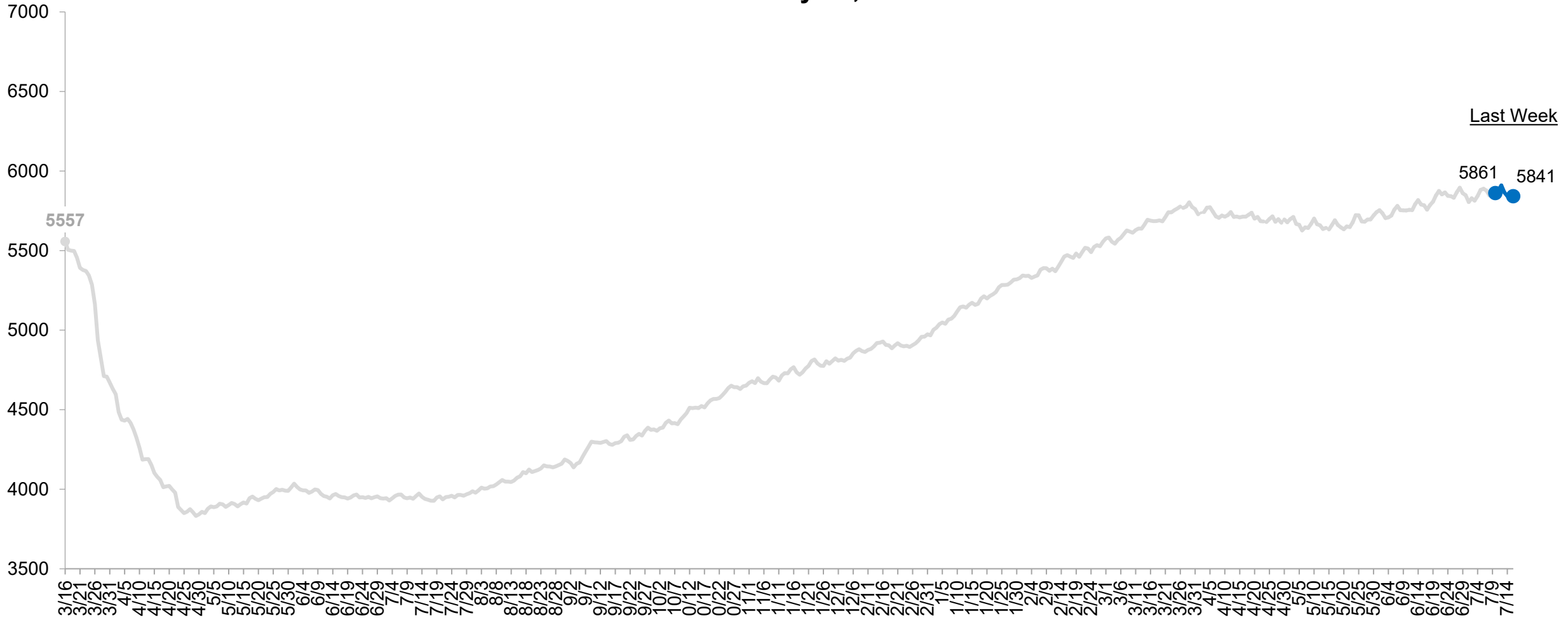

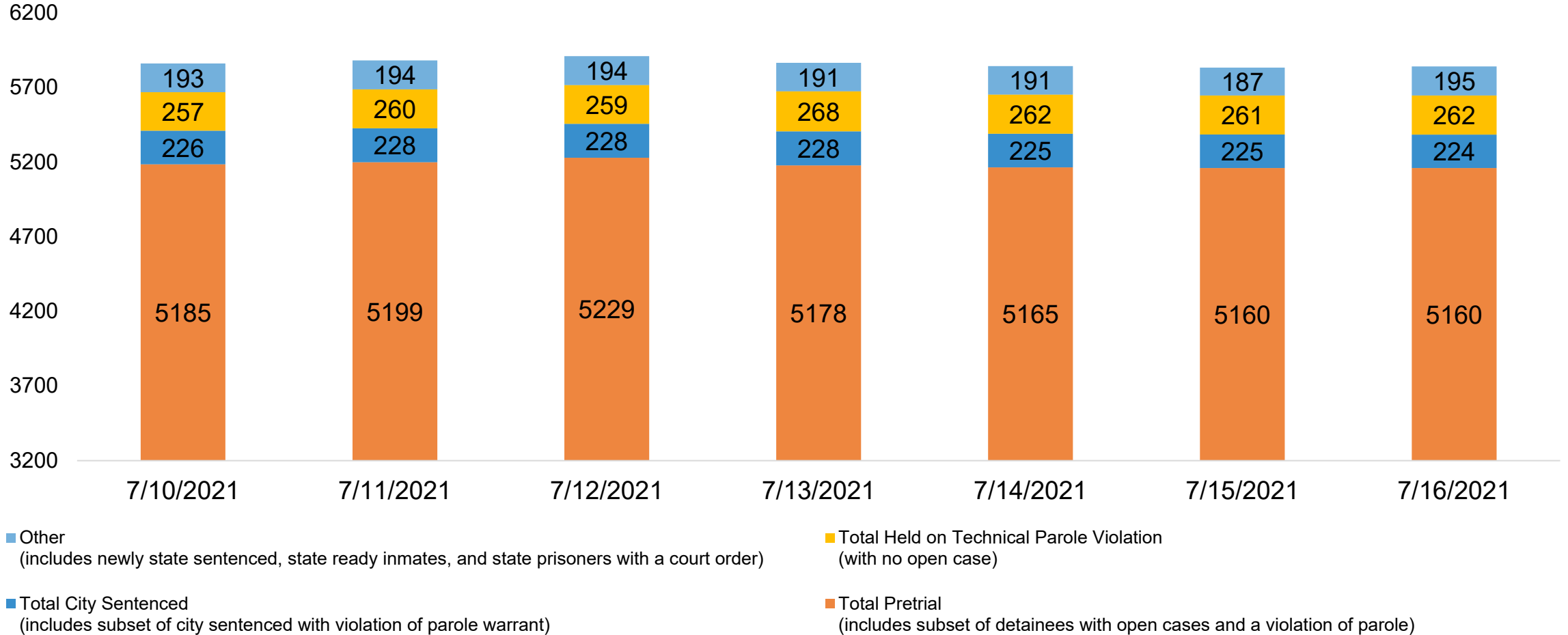
Total Population in DOC Custody March 16 - July 16, 2021

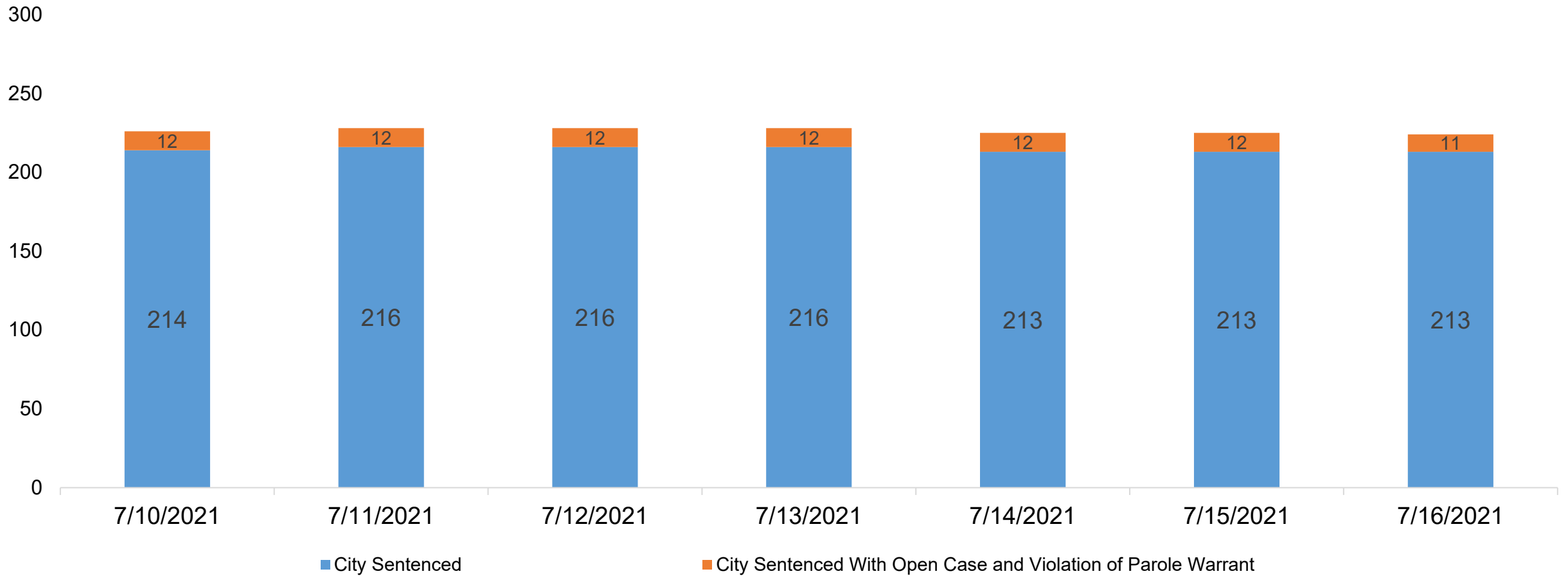

Total DOC Population by Custody Status, 7/10/2021 - 7/16/2021



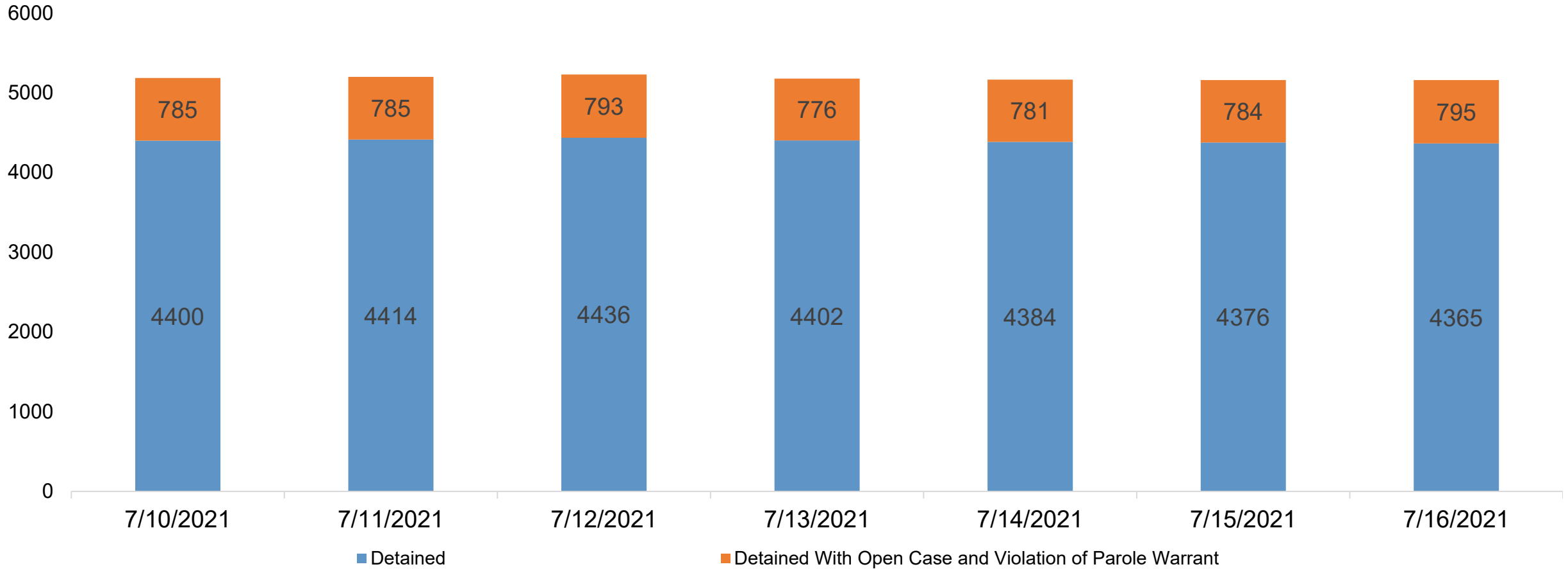

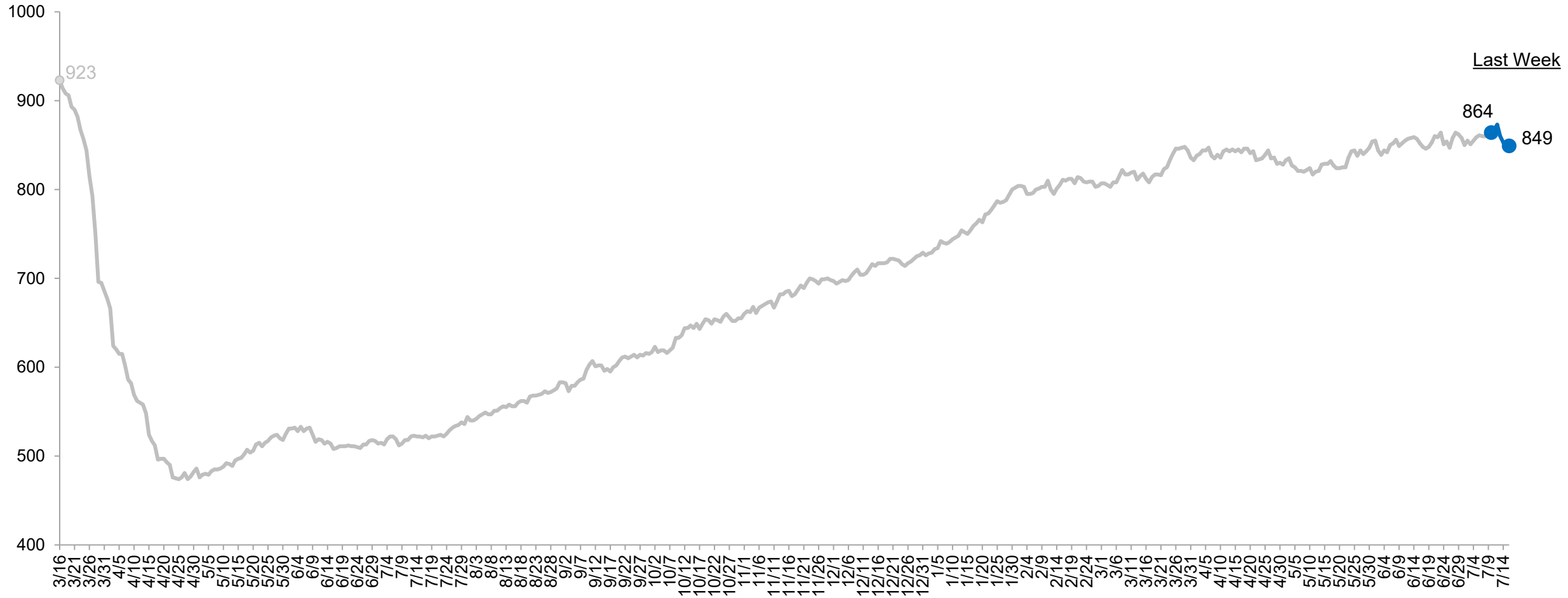

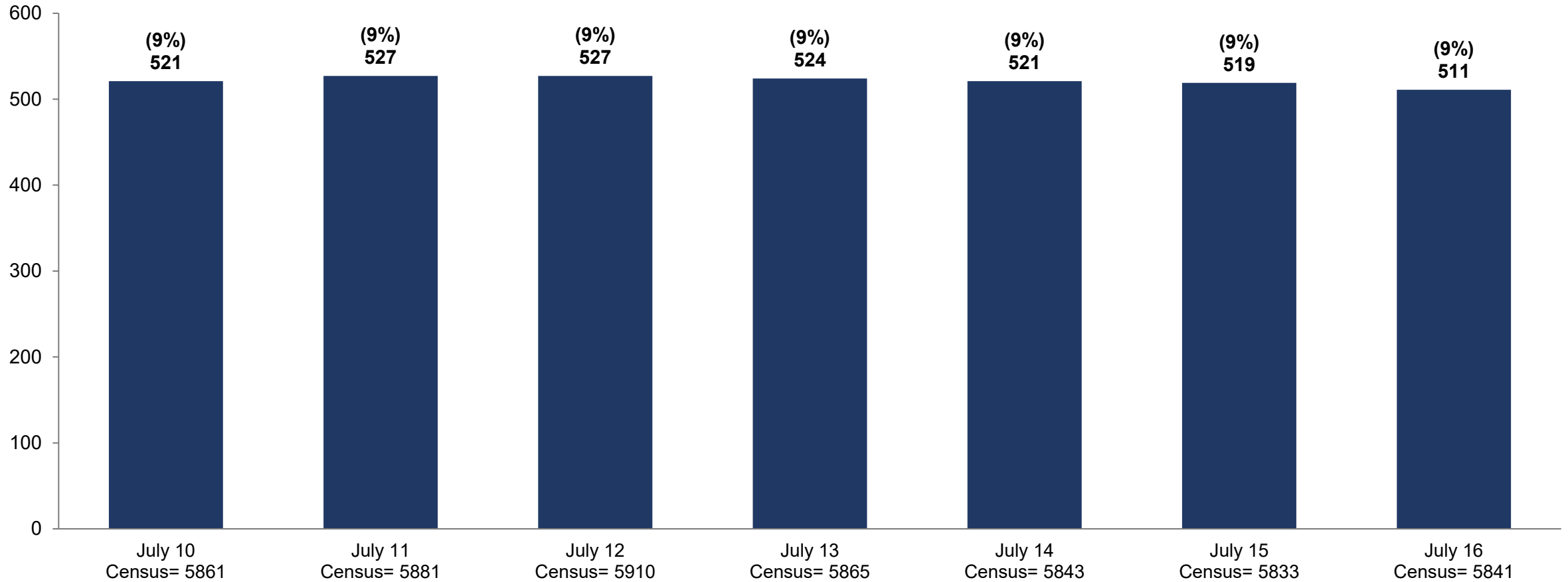

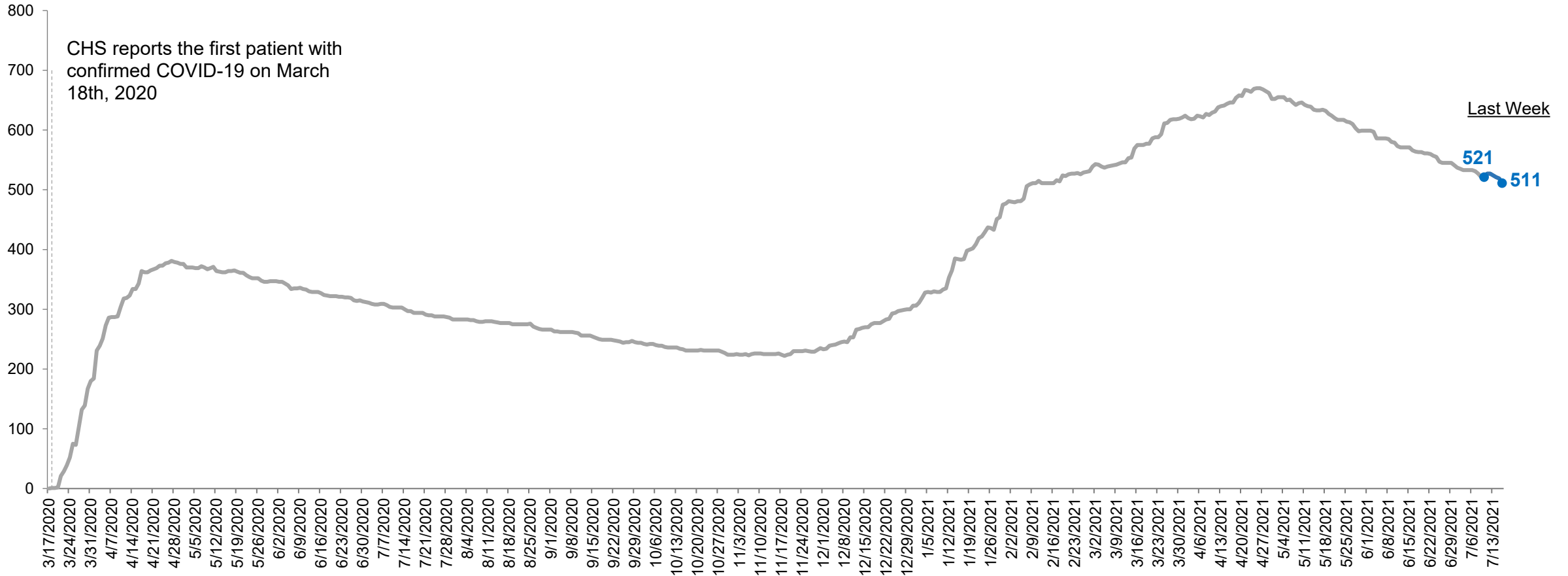
Number and Percent of Patients with Confirmed COVID-19

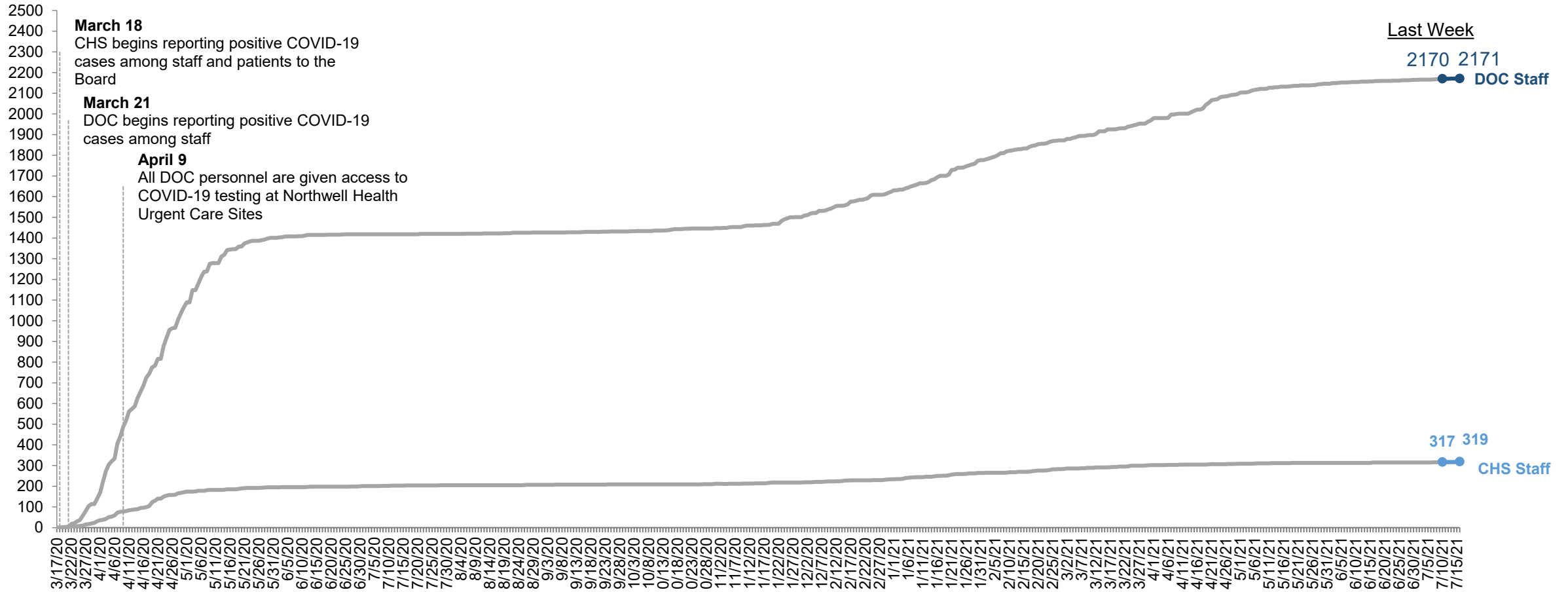
**Number of Currently Incarcerated Patients with Confirmed COVID-19

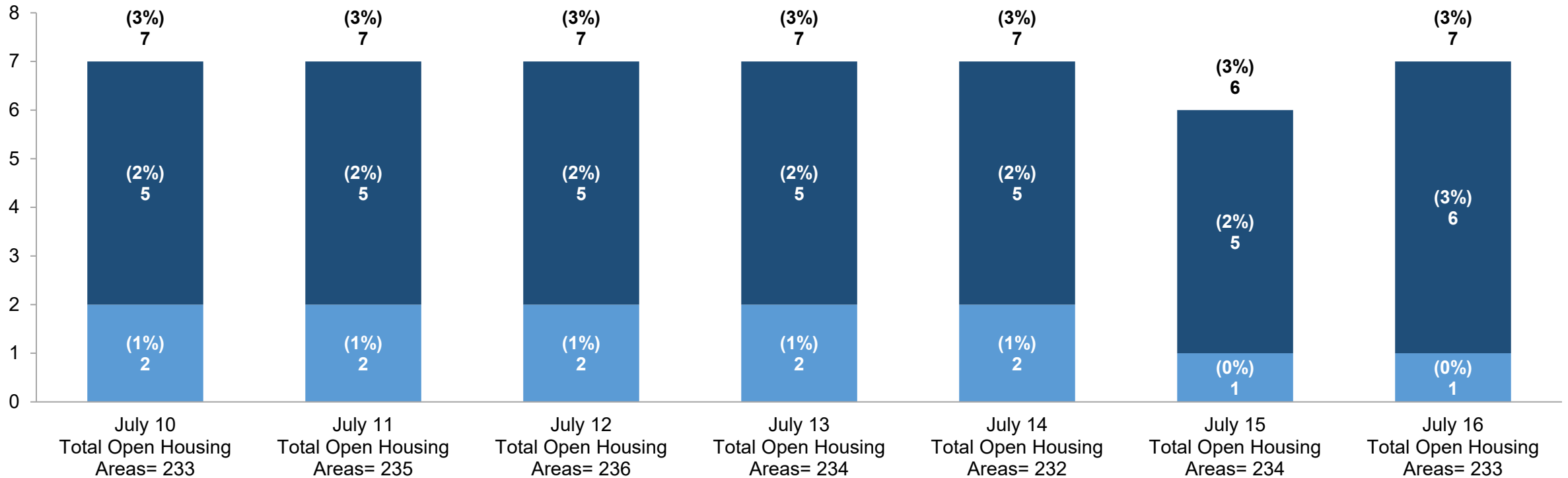

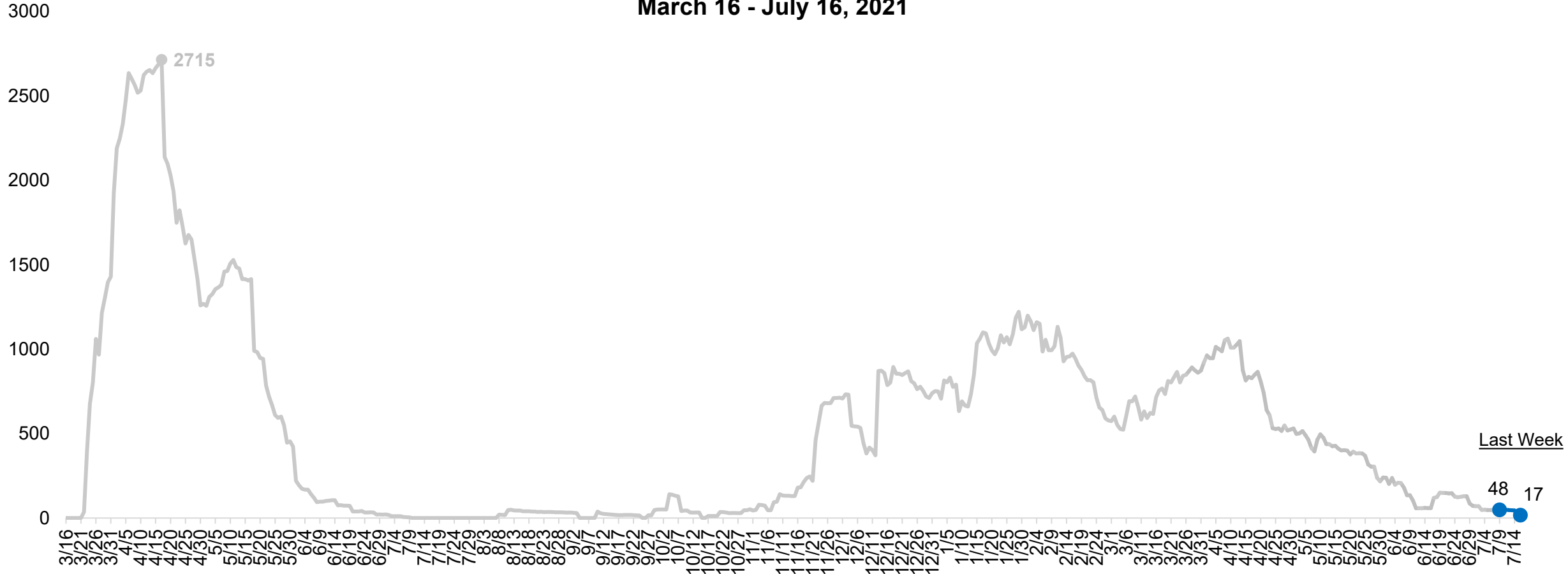

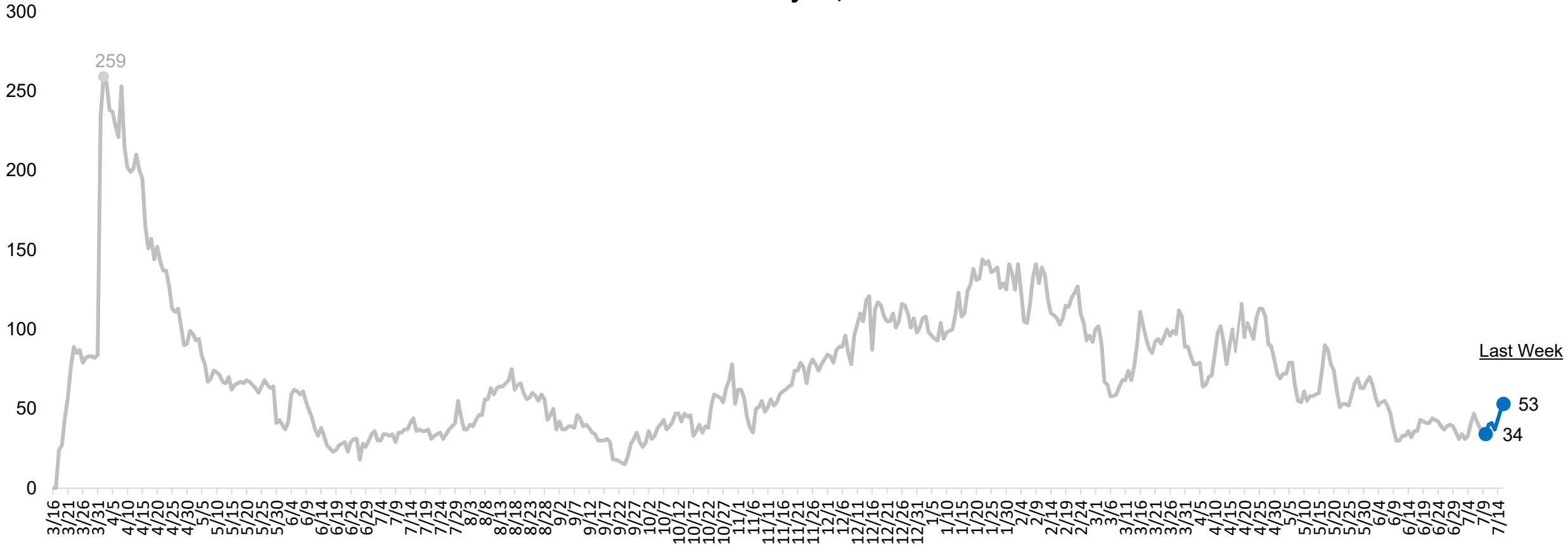

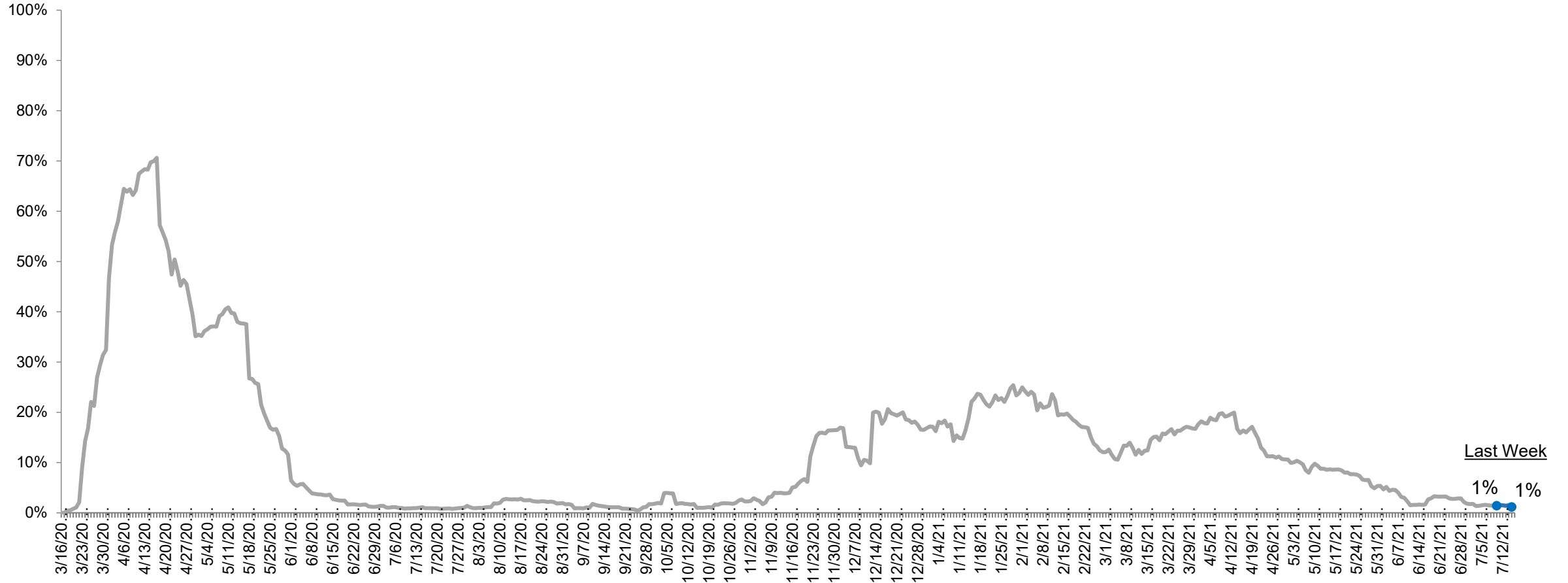

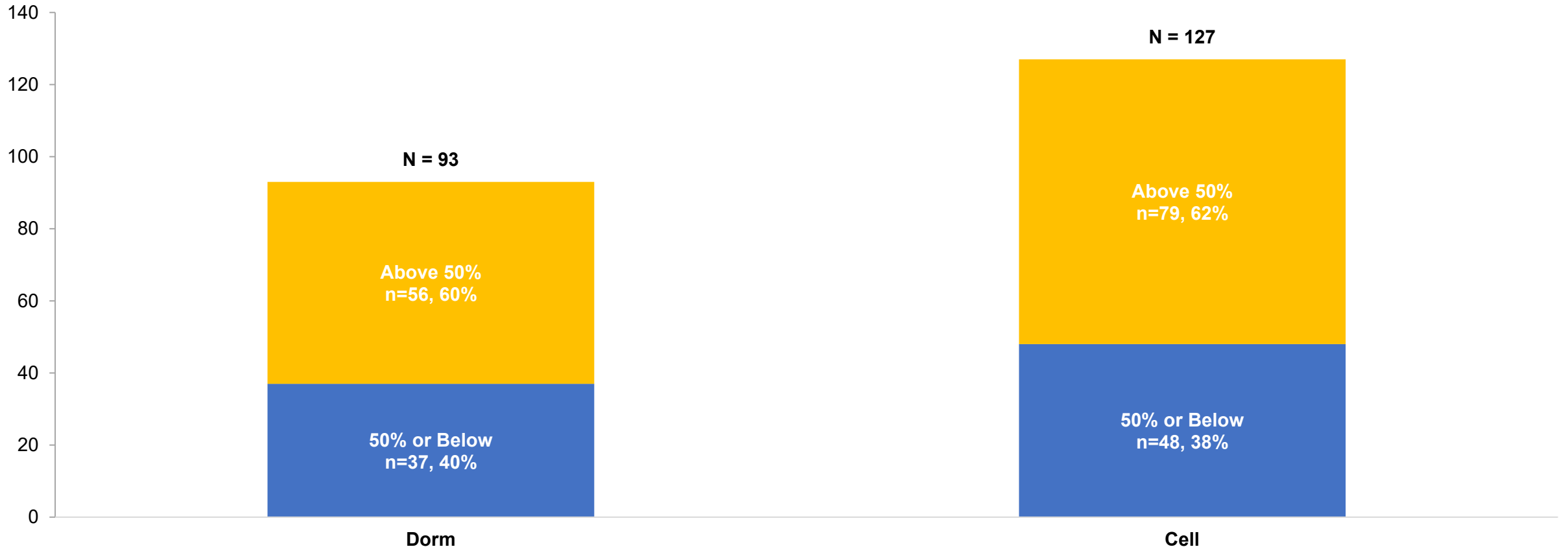

July 15, 2021



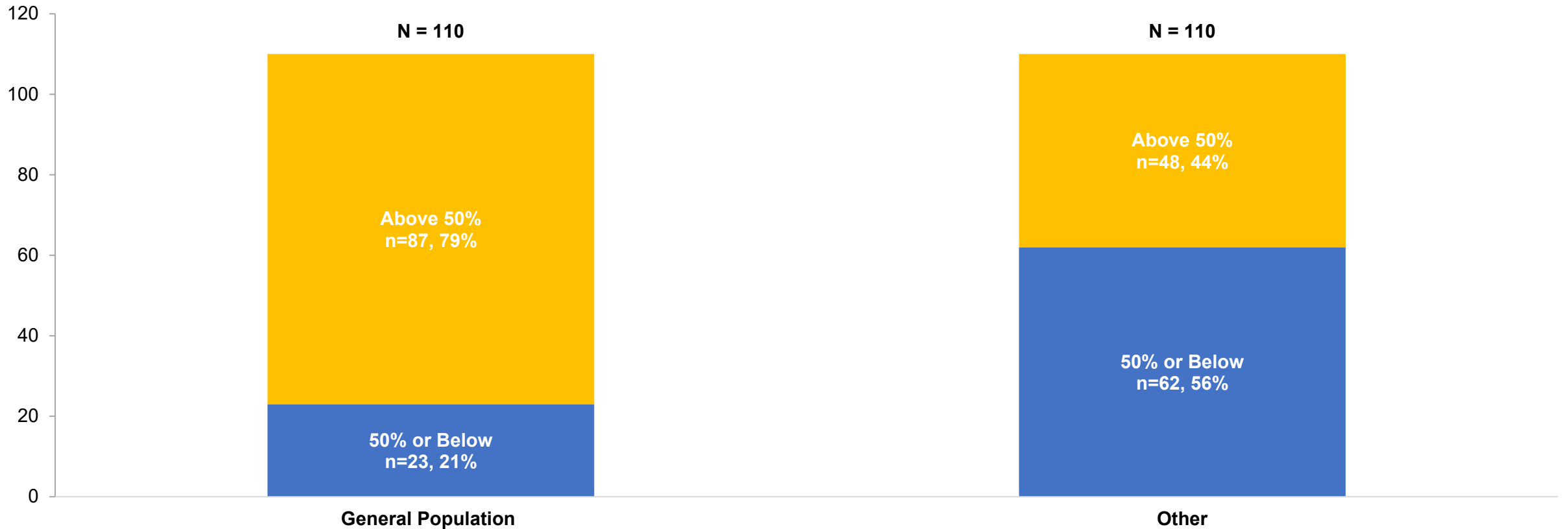

July 15, 2021



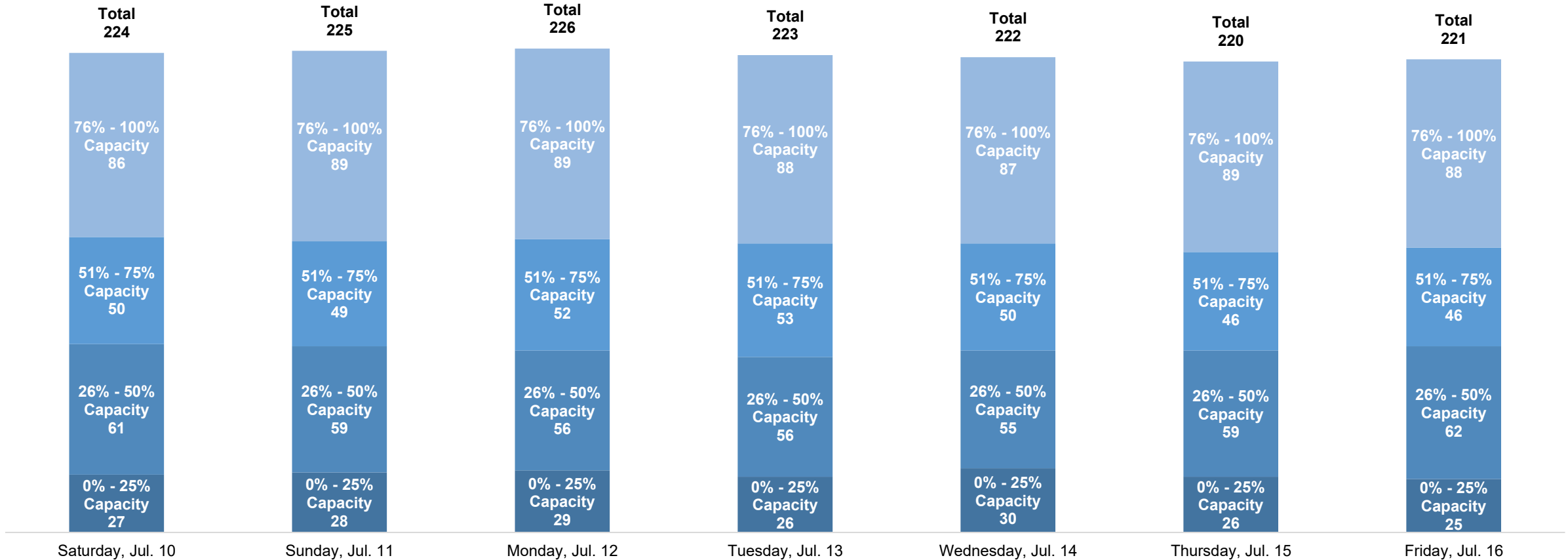
