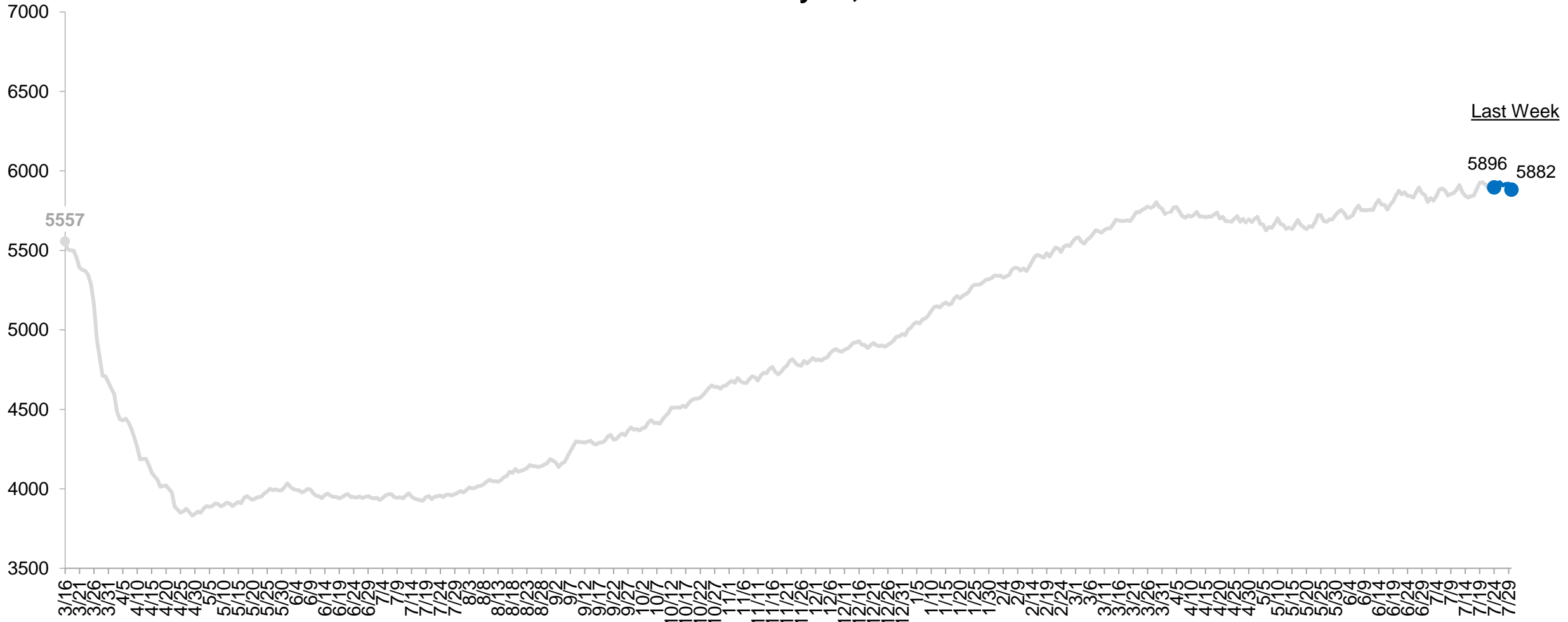

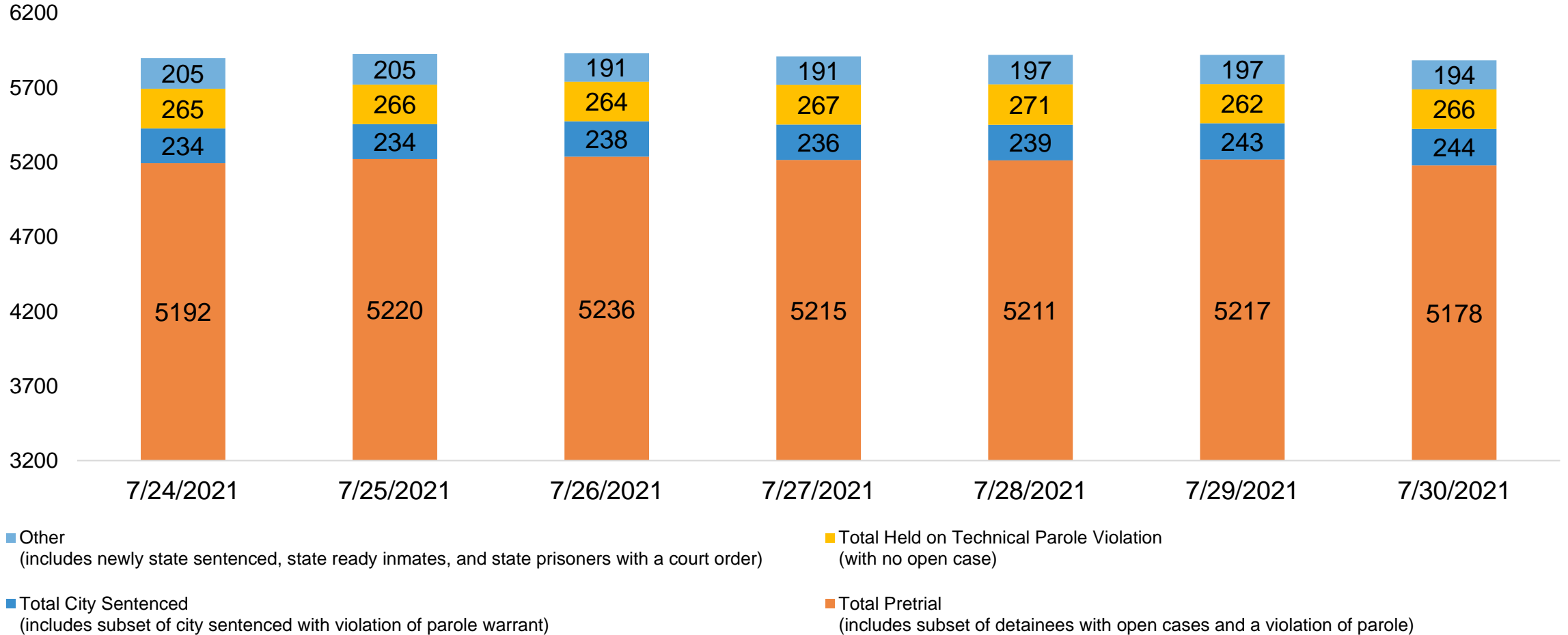
## Total Population in DOC Custody March 16 - July 30, 2021

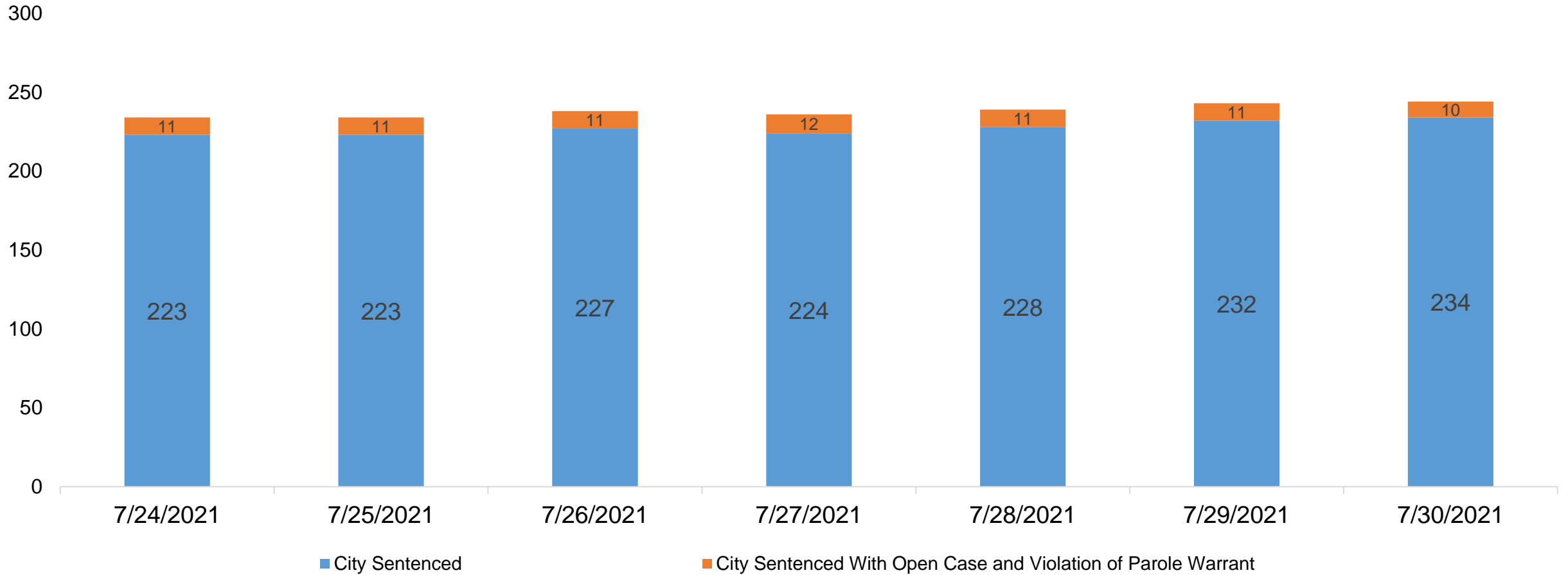

## Total DOC Population by Custody Status, 7/24/2021 - 7/30/2021



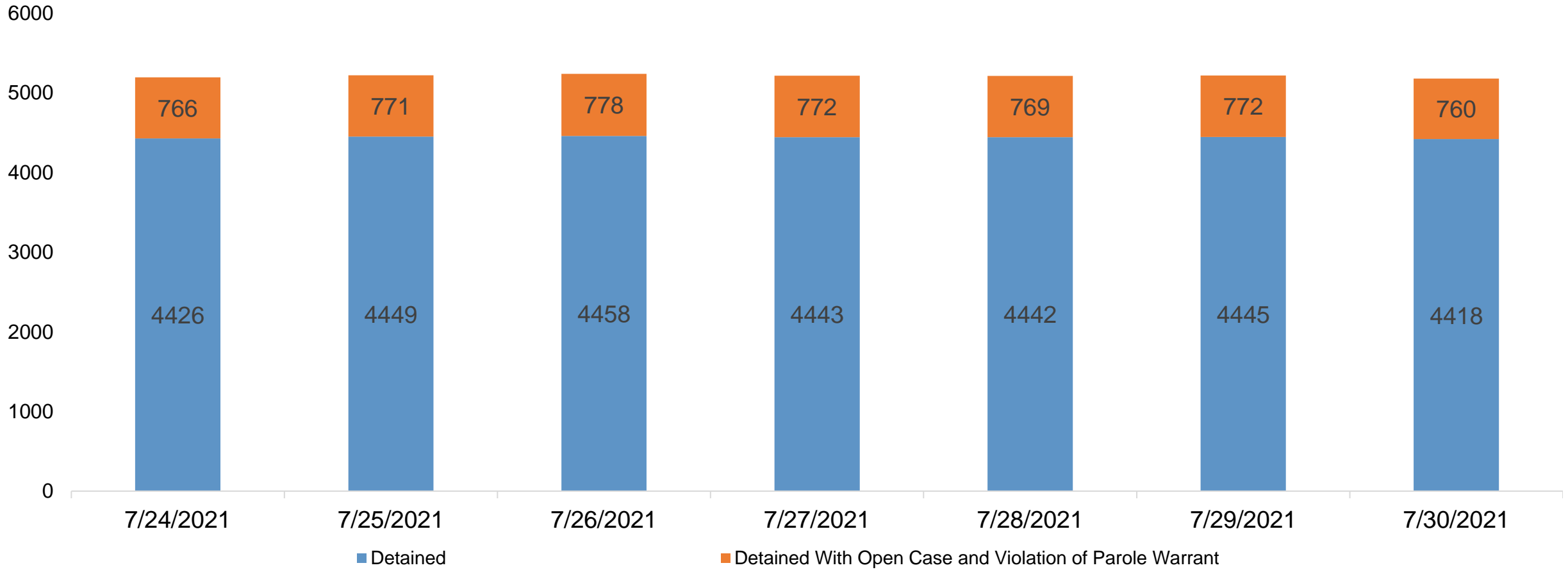

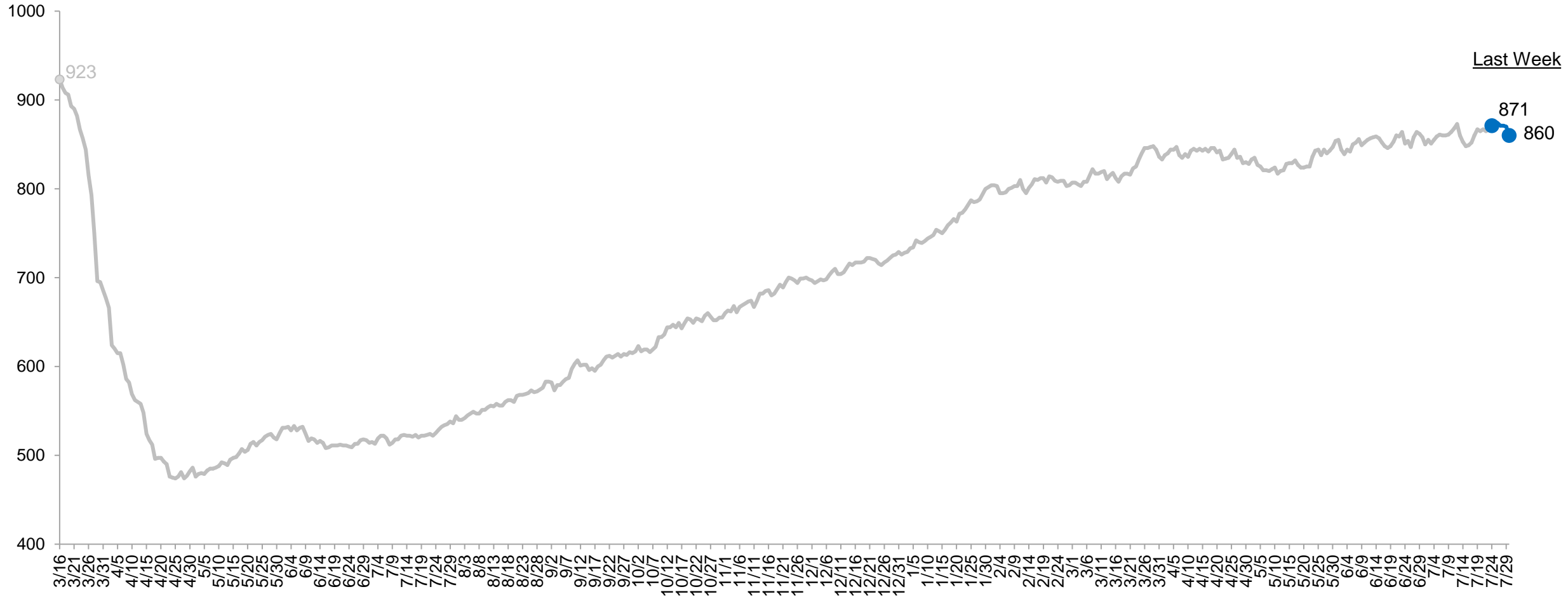

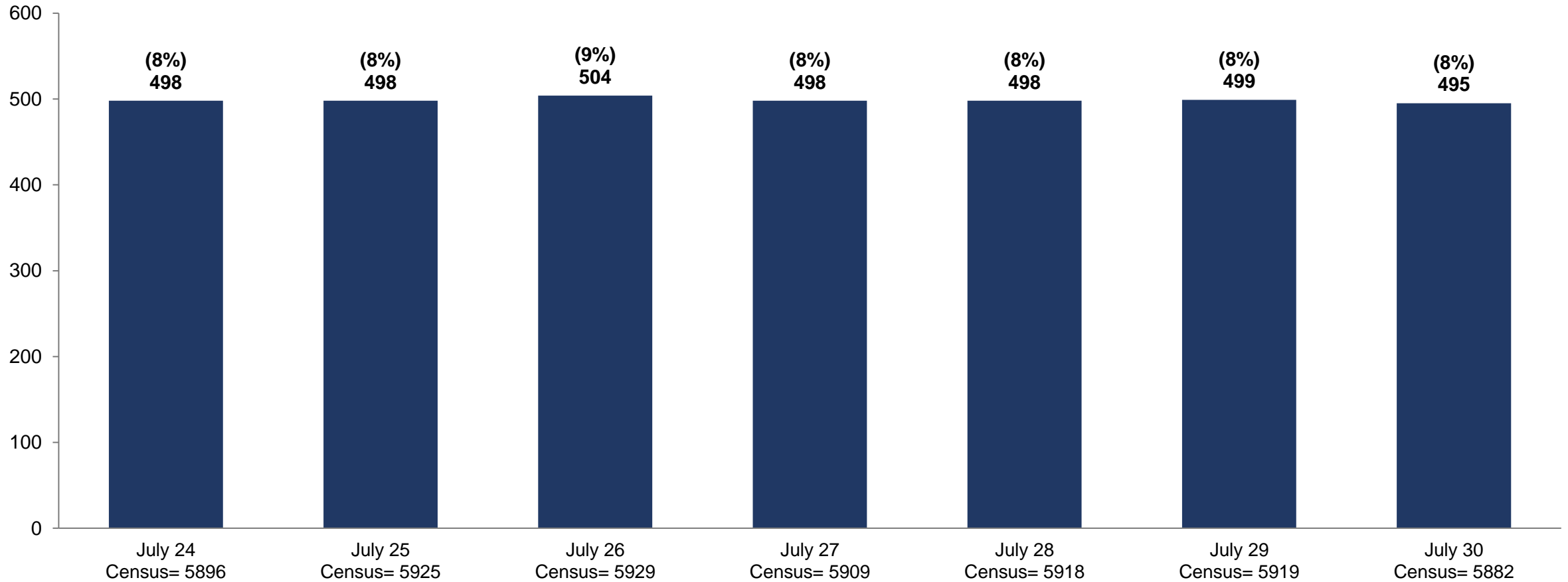

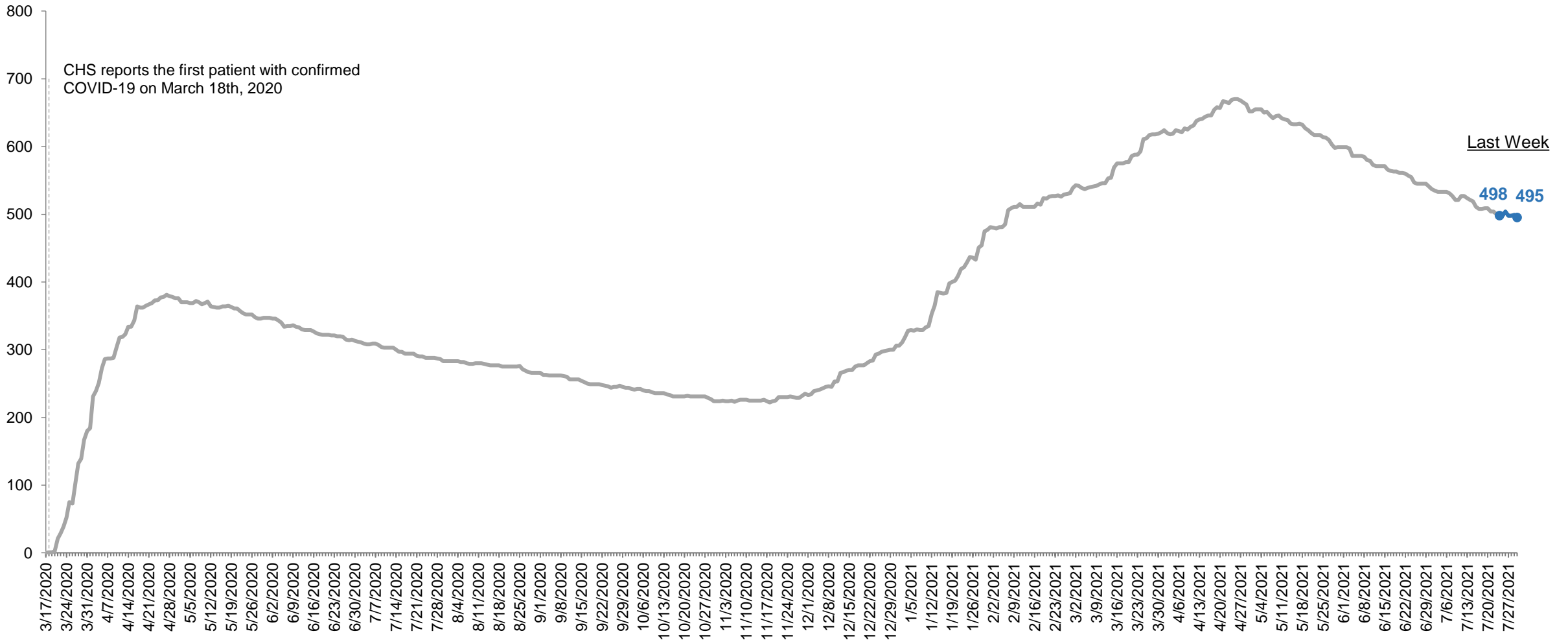
Number and Percent of Patients with Confirmed COVID-19

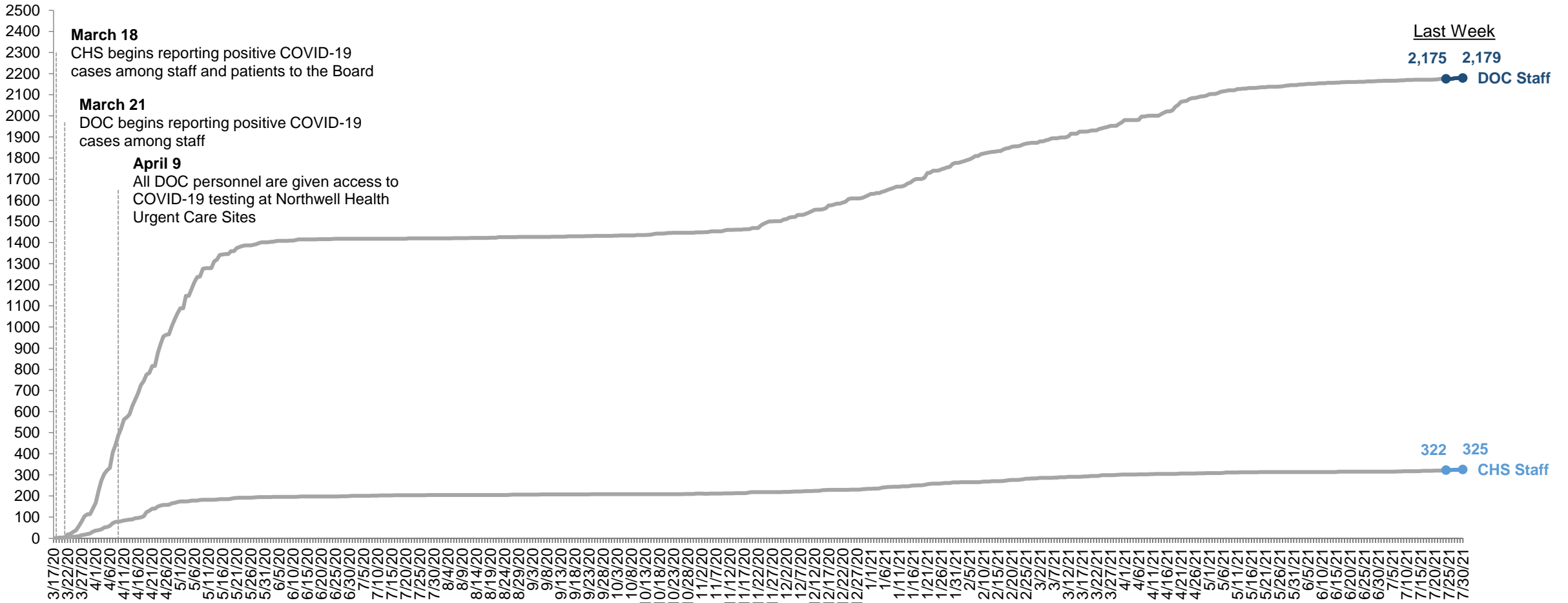

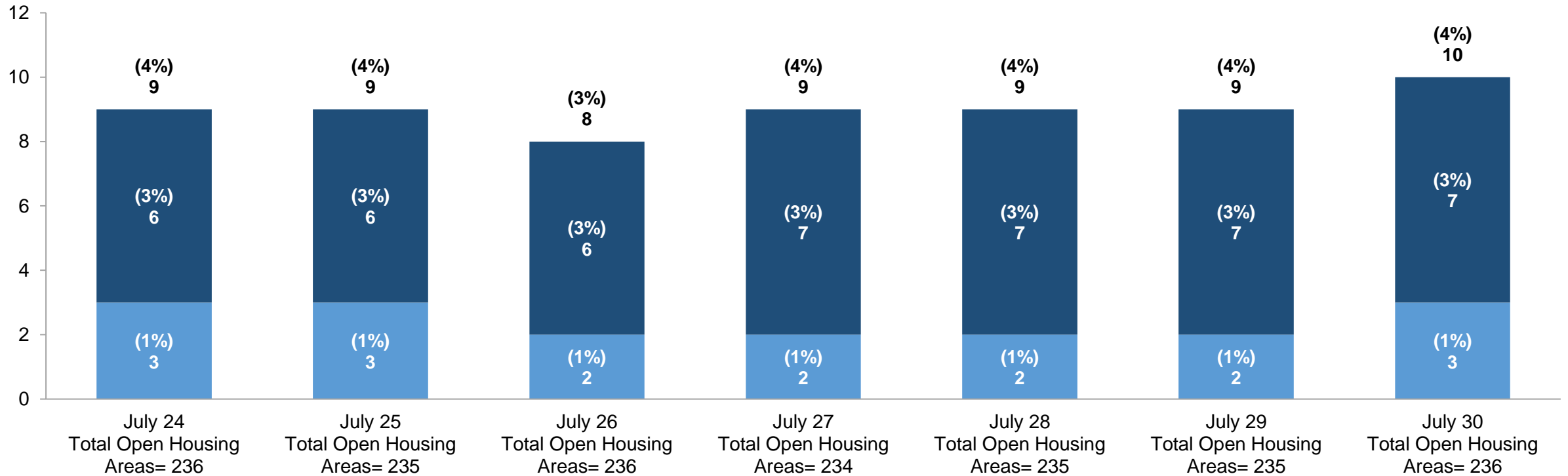

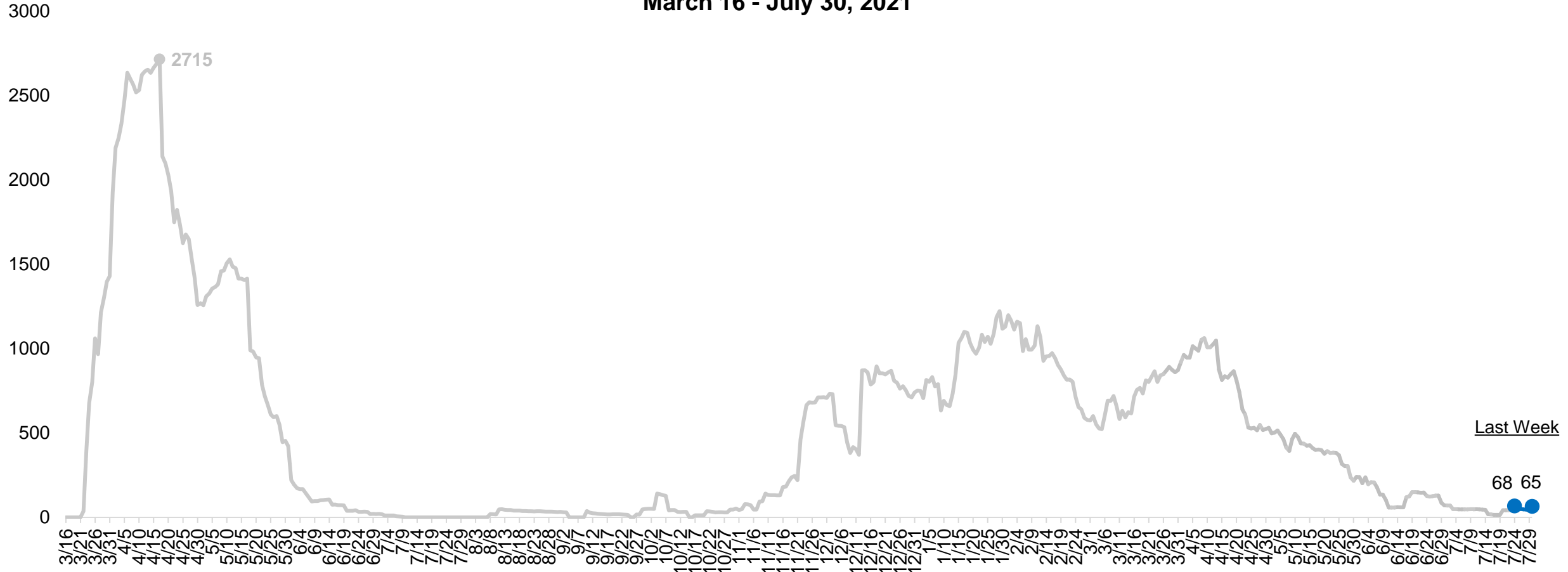

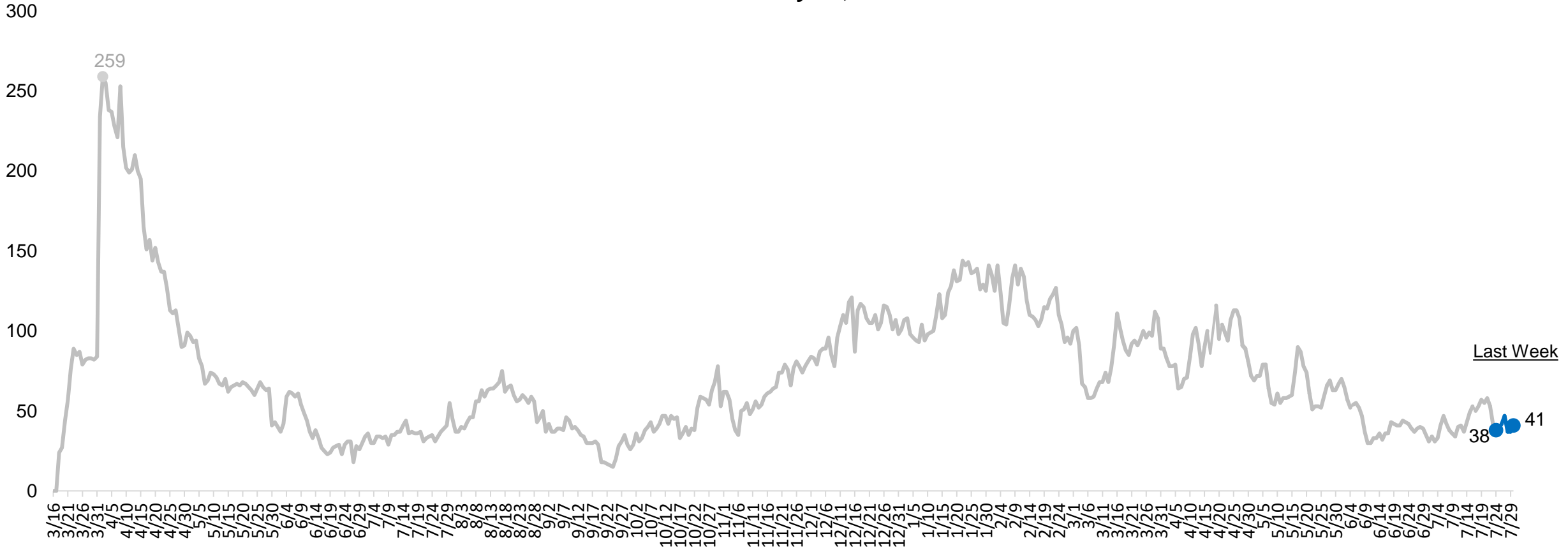

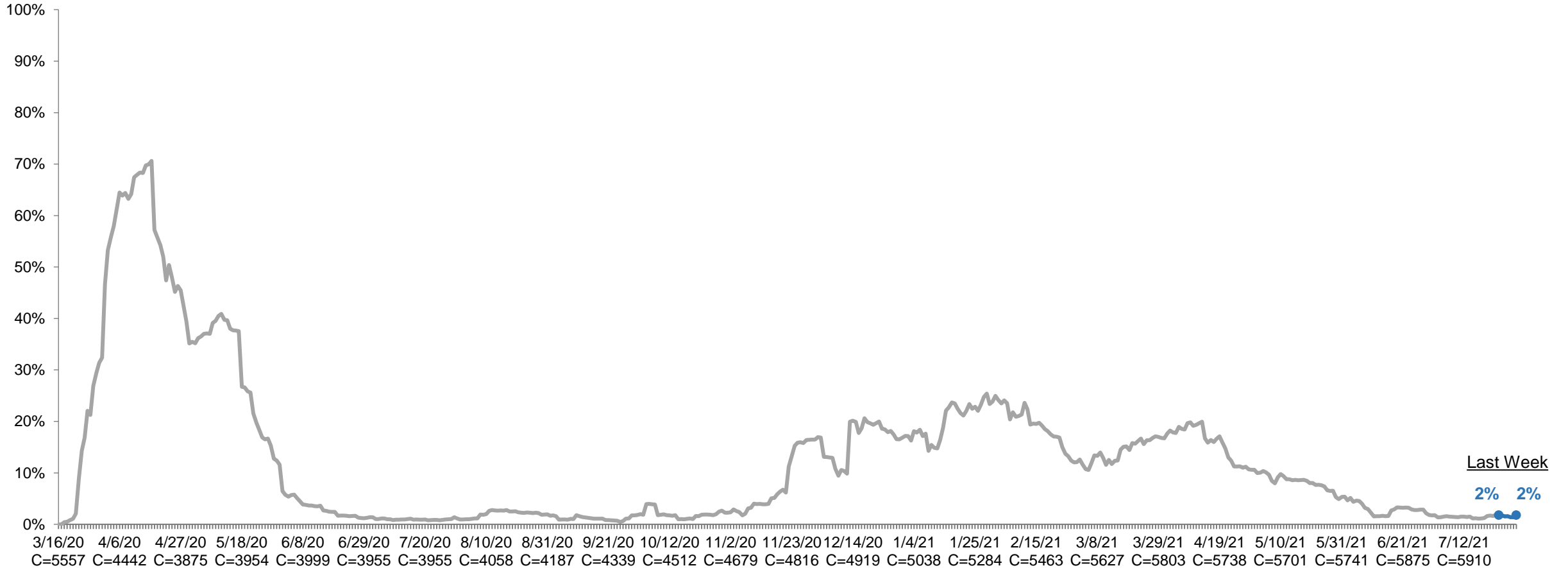

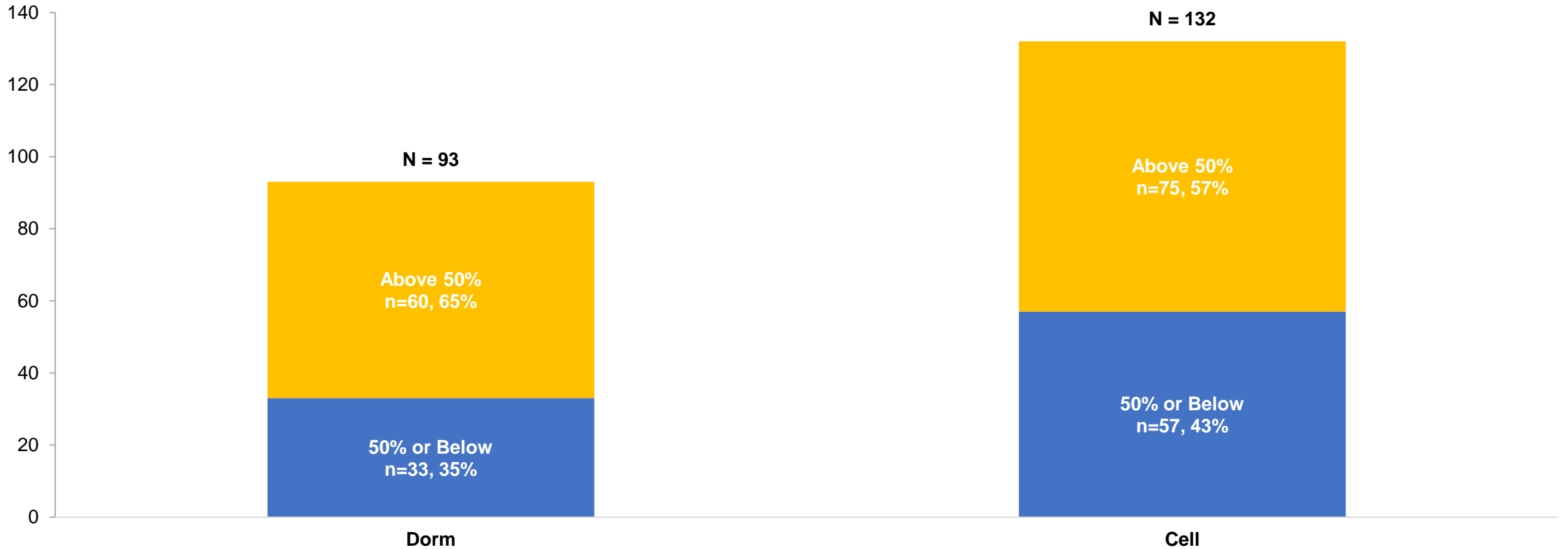

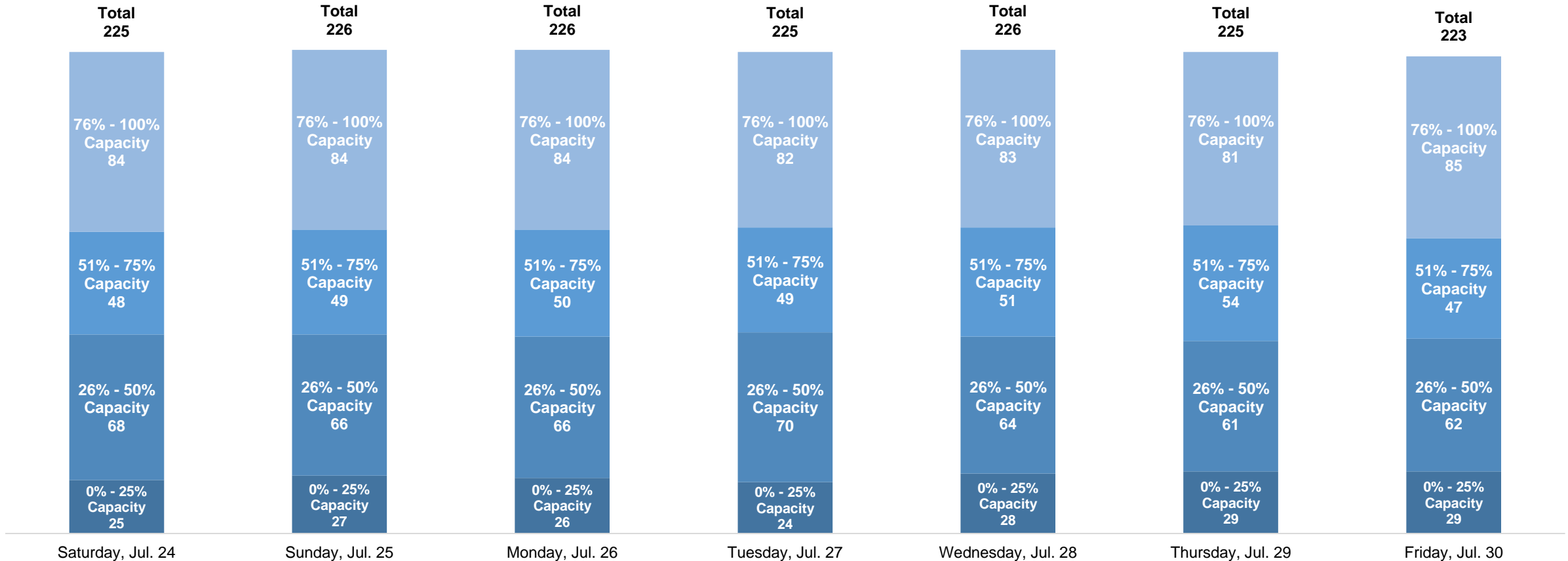
