The review shall be conducted not less than once every six months. DOC Inmate Visit Procedures, Directive #2007R-C, <u>https://www1.nyc.gov/assets/doc/downloads/directives/Directive\_2007R-C.pdf#page=7</u>. In November 2016, the Department began providing the Board with a copy of each six-month row conducted.
