



Supplemental Investigation Questionnaire for Master Fire Suppression Piping Contractor Class A, B or C

LICENSE AUTHORIZATION

This license authorizes a NYC licensee to perform fire suppression work, except that a city employee who holds a master fire suppression license may only perform replacement, maintenance and repair fire suppression piping work on existing buildings in the course of his or her employment.

QUALIFICATIONS

- I am at least eighteen (18) years old;
- I am able to read and write the English language;
- I am fit to perform the work authorized by this license;
- I am of good moral character.

- I have at least seven (7) years total experience* within the ten (10) years prior to the application date in the planning or design and installation of fire suppression piping systems under the direct and continuing supervision of a Department-licensed Master Fire Suppression Piping Contractor in the United States, with at least two (2) years of such experience as a registered journeyman fire suppression piping contractor. All experience was in the class of license I am applying for; or
- I have received a bachelor degree in engineering or appropriate engineering technology from a college or university registered by the New York State Department of Education and have at least five (5) years total experience within seven (7) years prior to the application date in the planning or design and installation of fire suppression piping systems under the direct and continuing supervision of a Department-licensed Master Fire Suppression Piping Contractor in the United States. All experience was in the class of license I am applying for and at least one (1) year of such experience was in New York City; or
- I am a New York State-licensed professional (Registered Architect or Professional Engineer) and have at least three (3) years of experience within five (5) years prior to the application date in the planning or design and installation of fire suppression piping systems in the United States under the direct and continuing supervision of a Department-licensed Master Fire Suppression Piping Contractor. All experience was in the class of license I am applying for and at least one (1) year of such experience was in New York City; or
- I have at least seven (7) years total experience* within ten (10) years prior to the application date with at least two (2) years of such experience working in the planning or design and installation of fire suppression piping systems under the direct and continuing supervision of a Department-licensed Master Fire Suppression Piping Contractor in the United States and with at least two (2) years of such experience as a registered journeyman fire suppression piping contractor. The balance of experience may be obtained by performing maintenance, replacement and repair of fire suppression piping work on existing buildings while in the employment of a City agency under



the direct and continuing supervision of a Department-licensed Master Fire Suppression Piping Contractor Supervisor employed by the City agency. All experience was in the class of license I am applying for; or

- I have been an employee of a government agency, private inspection agency or other entity, accepted by the Buildings Commissioner whose duties primarily involved the inspection of plumbing work for compliance with the New York City Plumbing Code and/or other laws relating to the installation, alteration or repair of fire suppression piping systems and this experience** combined with my work experience, this equals seven (7) years of work experience required within the ten (10) years prior to application.

**At least two (2) years of the required practical experience must be obtained as a journeyman fire suppression piping contractor registered with the Department. Please see the full text of Title 28 of the New York City Administrative Code for all the qualifications requirements*

***Such applicants can count 50 percent of the years he or she was satisfactorily employed in the above work towards the seven (7) years of total required work experience as long as it was obtained within ten (10) years prior to application. The number of years credited shall not exceed two and a half (2.5) years of the satisfactory experience. The remaining balance must be obtained by working in the planning or design, and installation of fire suppression piping systems under the direct and continuing supervision of a Department-licensed Master Fire Suppression Piping Contractor in the United States*
