Executive Summary

The Civilian Complaint Review Board ("CCRB") is an independent municipal Agency that investigates complaints of NYPD misconduct. Every month, the CCRB prepares an Executive Director report for its public meeting. Data for January 2025 included the following highlights:

- 1) Of the cases in the CCRB active investigations docket, 46% have been open for 4 months or fewer, and 65% have been open for 7 months or fewer (page 10). In January, the CCRB opened 482 new cases (page 4), and currently has a total open docket of 2,955 cases (page 11).
- 2) The CCRB substantiated allegations in 57% of its fully investigated cases in January (page 17).
- 3) The CCRB fully investigated 45% of the cases it closed in January (page 14).
- 4) For January, investigations using video evidence resulted in substantiated allegations in 57% of cases compared to 40% of cases in which video was not available (page 24).
- 5) The Monthly Report includes a breakdown of complaints and substantiations by NYPD precinct and borough of occurrence (pages 5-6, 43-56).
- 6) In January the Police Commissioner finalized 25 decision(s) against police officers in Administrative Prosecution Unit (APU) cases (page 30). The CCRB's APU prosecutes the most serious allegations of misconduct. The APU has not conducted any trials against members of the NYPD year-to-date; no trials were conducted against respondent officers in January.

The CCRB is committed to producing monthly reports that are valuable to the public, and welcomes feedback on how to make its data more accessible.

Glossary

In this glossary we have included a list of terms that regularly appear in our reports.

Allegation: An allegation is a specific act of misconduct. The same "complaint" can have multiple allegations – excessive force and discourteous language, for example. Each allegation is reviewed separately during an investigation.

APU: The Administrative Prosecution Unit is the division of the CCRB that has prosecuted "charges" cases since April 2013, after the signing of a 2012 Memorandum of Understanding between the CCRB and NYPD.

Board Panel: The "Board" of the CCRB has 15 members. Following a completed investigation by the CCRB staff, three Board members, sitting as a Board Panel, will make a finding on whether misconduct occurred and will make a recommendation on what level of penalty should follow.

Case/Complaint: For the purposes of CCRB data, a "case" or "complaint" is defined as any incident within the Agency's jurisdiction, brought to resolution by the CCRB.

Disposition: The Board's finding as to the outcome of a case (i.e. if misconduct occurred).

FADO: Under the City Charter, the CCRB has jurisdiction to investigate the following categories of police misconduct: Force, Abuse of Authority, Discourtesy and Offensive Language, collectively known as "FADO".

FADO&U: A ballot measure revising the New York City Charter, which passed on November 5, 2019, authorized the CCRB to investigate the truthfulness of an official statement made by a subject officer during a CCRB investigation into a FADO allegation. This expanded jurisdiction—Force, Abuse of Authority, Discourtesy, Offensive Language, and Untruthful Statements (FADO&U)—went into effect on March 31, 2020.

Intake: CCRB's intake team initially handles complaints from the public. Intake takes complaints that come via live phone calls, voicemails, an online complaint form, or in-person.

Investigation: CCRB investigators gather evidence and interview witnesses to prepare reports on misconduct allegations. An investigation ends when a closing report is prepared detailing the evidence and legal analysis, and the case is given to the Board for disposition.

Mediation: A complainant may mediate his or her case with the subject officer, in lieu of an investigation, with the CCRB providing a neutral, third-party mediator.

Unable to Investigate: A catch-all term, used for reporting purposes only, that refers to cases where the CCRB was unable to conduct an investigation, typically because no statement could be obtained from the complainant/alleged victim. "Unable to Investigate" incorporates the following CCRB dispositions: "Complainant/Alleged Victim Uncooperative", "Complainant/Alleged Victim Unavailable", "Witness Uncooperative", "Witness Unavailable", "Victim Unidentified", "OMB PEG Directive Closure", and "SRAD Closure."

Withdrawn: When the complainant/alleged victim asks that their complaint be withdrawn, the case is closed as "Withdrawn."

Closed Pending Litigation: When a complainant is involved in criminal or civil litigation, and declines to cooperate with an investigation on the advice of their attorney, the complaint disposition is "Closed Pending Litigation."

Complaints Received




Figure 1: Total Intake by Month (January 2024 - January 2025)







Figure 3: New CCRB Complaints by Year (YTD 2010 - YTD 2025)

The CCRB's Intake team processes misconduct complaints from the public and referrals from the NYPD. Under the New York City Charter, the CCRB's jurisdiction is limited to allegations of misconduct related to Force, Abuse of Authority, Discourtesy and Offensive Language. All other complaints are referred to the appropriate agency. Figure 1 refers to all complaints that the CCRB receives and Figures 2 and 3 refer to new cases that remain with the Agency. In January 2025, the CCRB initiated 482 new complaints.

Figure 4: CCRB Complaints Received By Borough of Occurrence (January 2025)




Figure 5: CCRB Complaints Received By Borough of Occurrence (YTD 2025)




Figure 6: CCRB Complaints Received By Precinct of Occurrence (January 2025)




Figure 7: CCRB Complaints Received By Type of Allegation (January 2024 vs. January 2025)




Figure 9: CCRB Complaints Received By Type of Allegation (YTD 2024 vs. YTD 2025)

Figure 15: Number of Active Investigations (January 2024 - January 2025)




Figure 16: Open Docket Analysis




Figure 17: Open Docket Analysis with % Change

Body Worn Camera Footage Requests

Since the widespread roll out of body worn cameras in 2018, the collection of footage from these cameras has become an integral part of CCRB investigations.

The timeliness of the response to BWC footage requests has a direct impact on the length of time it takes to complete an investigation. The longer it takes to fulfill BWC requests, the longer CCRB investigations remain on the open docket.

Figure 20: Percentage of Open Investigations Docket with Pending BWC Requests (January 2024 - January 2025)





Figure 21: Fulfilled BWC Requests (January 2024 - January 2025)

Dispositions

Cases fully investigated by the CCRB generally receive one of five outcomes:

- If the alleged misconduct is found to have occurred, based on the preponderance of the evidence, the allegation is closed as **substantiated**.
- If there is not enough evidence to determine whether or not the alleged misconduct occurred, the allegation is closed as **unable to determine**.*
- If the preponderance of the evidence suggests that the event or alleged act did not occur, the allegation is closed as **unfounded**.
- If the event did occur, but was not improper by a preponderance of evidence, the allegation is closed as within NYPD guidelines.**
- If the CCRB was unable to identify any of the officers accused of misconduct, the case is closed as **officer unidentified**.

Case Abstracts

The following case abstracts are taken from complaints closed this month and serve as examples of what the different CCRB dispositions mean in practice:

1. Substantiated

An individual was riding as a passenger on a scooter when the subject officers in an unmarked police vehicle attempted to pull over the scooter. The scooter driver took off while the two subject officers pursued them. The passenger closed her eyes because she was afraid and when next she opened them, she was in the hospital. Neither subject officer activated their BWC during the incident. The subject officers stated that they tried to pull over the scooter because the scooter did not have a license plate, and the occupants were not wearing helmets. They had their lights and sirens on. They stated that the scooter fled, and they pursued it, the scooter driving through a stop sign and crashing into a vehicle. The crash caused injury to both the driver and the individual. The driver and the individual were taken to the hospital. Subject officer 1 stated that his camera was having technical issues and that he did not inform a supervisor about the issue, he left his BWC at the precinct that day. Subject officer 2 stated that he forgot to turn his camera on because he had been focused on driving and then rendering aid. The investigation determined that the subject officer's pursuit created an unnecessary risk and was improperly conducted because they initiated a pursuit at 60 miles per hour over a traffic violation, placed pedestrians on a sidewalk in danger when the scooter drove on the sidewalk during the pursuit, failed to maintain contact with police dispatchers, and the pursuit resulting in injury to the driver and the individual. The investigation also found that subject officer 1 failed to notify supervision that his BWC was not working and that subject officer 2 failed to turn on his camera after he stopped driving; both actions are in violation of the BWC operating guidelines. The Board substantiated the Abuse of Authority allegations.

2. Unable to Determine

An individual stated that he was standing outside a building with a fanny pack across his body when subject officers 1 and 2 pulled up in an unmarked police vehicle and subject officer 1 rolled down the driver side window and asked the individual how he was doing. Subject officer 2 exited the vehicle and approached the individual. He asked the individual if he had any weapons in his bag; the individual said no and subject officer 2 asked him to keep his arms visible and grabbed the bag and squeezed it. He then returned to the vehicle and the subject officers left. The individual did not receive a business card. The investigation found that there were two additional officers (subject officers 3 and 4) assigned to the vehicle driven by subject officer 1. The investigation found that none of the subject officers recalled performing a stop at the individual's location even though vehicle records showed that their vehicle was near the incident location. The investigation finally found that there was no BWC information available.

Without any independent witnesses or additional video footage, the investigation could not determine if the subject officers stopped and questioned the individual, failed to give him a business card, or failed to activate their BWCs. The Board closed the Abuse of Authority allegations as Unable to Determine.

3. Unfounded

An individual stated that while at a protest she saw a female individual holding a megaphone behind her back as she was approached by the subject officer who reached around her to try to take the megaphone. The individual believed that the subject officer used his body to push the female individual to the ground and that both the female individual and the subject officer were "kicking each other". The incident was captured on BWC. It showed the subject officer trying to take away the megaphone from the female individual. As he got his hands on the megaphone, which was being held towards the female individual's back, she kicked at his legs, and he lost his balance and fell into the female individual. The investigation found that the subject officer did not kick the female individual or use his body to push her to the ground. The Board closed the Use of Force allegations as Unfounded.

4. Within NYPD Guidelines

An individual stated that she was at home when the subject officer accompanied by other officers dressed in tactical gear broke her front door, entered and searched her apartment, and seized her cellphone, her son's cellphone and his wallet. The investigation found that the subject officer was in possession of a valid no-knock warrant which authorized the entry and search of the individual's home and a valid no-knock search warrant to search for evidence relating to the reason for the entry into the individual's home. The Board closed the Abuse of Authority allegations as being Within NYPD Guidelines.

5. Officer Unidentified

An individual stated that he was in his school uniform as he exited a subway station. He was walking up the stairs that led out of the station when he was approached from behind by the two subject officers who asked to speak with him. They directed the individual to the top of the stairs and questioned him - they were joined by a third subject officer. They asked for his name and what he was doing, and he told them that he was on his way to school; they asked for his school ID which he did not have because he had lost it. The subject officers told the individual that they had stopped him because he fit the description of an individual accused of a crime. The individual asked for the subject officers' names and they either provided it verbally or pointed to their shields. The subject officers then left the area. The individual could not remember the names of the subject officers and only had a general description. The investigation reviewed footage from MTA surveillance cameras, and it did not capture any officers in the area where the incident occurred. There were also no stop reports from the local precinct concerning the individual. Officers matching the general description given by the individual were assigned to jobs not near the incident location. Without additional pertinent information, the investigation could not identify the subject officers who stopped and questioned the individual. The Board closed the Abuse of Authority allegations as Officer Unidentified.

^{*} Unable to determine is reported to the Commissioner as Unsubstantiated, meaning that there was insufficient evidence to establish whether or not there was an act of misconduct.

^{**} Within NYPD Guidelines is reported to the Commissioner as Exonerated, meaning there was a preponderance of the evidence that the acts alleged occurred but did not constitute misconduct.

Figure 23: Disposition Counts of Full Investigations (January 2025)





Figure 24: Disposition Counts of Full Investigations (YTD 2025)

Figure 33: Percentage of Cases Substantiated (January 2024 - January 2025)





Figure 34: Disposition of Substantiated Complaints* (2025)

Figure 35: Substantiation Rates for Full Investigations without Video (Jan 2024 - Jan 2025) (% substantiated shown)





Figure 36: Substantiation Rates for Full Investigations with Video (Jan 2024 - Jan 2025) (% substantiated shown)



Board Discipline Recommendations for Substantiated Officers

After a CCRB investigative team has completed its investigation, a panel of Board members determines whether to substantiate the allegation(s) and make a disciplinary recommendation against the officer(s).

- "Charges and Specifications" are the most severe form of discipline. A decision to assign
 Charges commences a process that may result in an administrative trial in the NYPD Trial
 Room. An officer may lose vacation days, be suspended, or be terminated if the officer is
 found guilty.
- "Command Discipline B" and "Command Discipline A" are recommended for misconduct that is moderately serious. An officer can lose up to ten vacation days as a result of Command Discipline B and up to five vacation days as a result of Command Discipline A.
- "Formalized Training" are the least severe discipline, often recommended for officers who misunderstand a policy. This determination results in training at the Police Academy or NYPD Legal Bureau (Formalized Training).
- When the Board has recommended Formalized Training or Command Discipline, the case is sent to the NYPD Commissioner to impose training and/or other penalties. Cases where the Board recommends charges are prosecuted by the CCRB's Administrative Prosecution Unit.
