THE TEST DATE: Multiple-choice testing is expected to begin on Wednesday, December 4, 2024.

## WHAT THE JOB INVOLVES:

Public Health Sanitarians, under close supervision, are trained in and perform professional work in public health inspection and environmental sanitation. They conduct environmental sanitation inspections and investigations to ensure compliance with health and safety regulations. All Public Health Sanitarians perform related work.

## **Special Working Conditions:**

Public Health Sanitarians may be required to work various shifts including nights, Saturdays, Sundays, and holidays.

Some of the physical activities performed by Public Health Sanitarians and environmental conditions experienced are: stooping, climbing and lifting actions in order to view pertinent areas or obtain samples from premises being inspected. Some inspections require the Public Health Sanitarian to work with instruments that operate with a sealed radioactive source; other inspections require personal protective equipment to be worn, i.e., face masks, respirators, coveralls, gloves, etc. Public Health Sanitarians carry their own equipment, which may be bulky, and normally travel from site to site by public transportation.

(This is a brief description of what you might do in this position and does not include all the duties of this position.)

## THE SALARY:

The current minimum salary is \$49,961 per annum. This rate is subject to change. Public Health Sanitarian has a two year probationary period. There are two assignment levels within this class of positions. At the end of one year of satisfactory service in Assignment Level I, and completion of any training required under the New York State Health Code, incumbents will be assigned to Assignment Level II subject to an additional one year probationary period. The salary will rise to \$59,418 per annum, when assigned to Level II

## **HOW TO QUALIFY:**

You may be given the test before we verify your qualifications. You are responsible for determining whether or not you meet the education and experience requirements for this examination prior to submitting your application. If you are found "Not Qualified," your application fee will not be refunded and you will not receive an Admission Notice or score. (For more information see Exam Site Admission section.)

You will **not** receive credit for education which you obtain after January 31, 2025 or experience which you obtain after the end of the Application Period (September 24, 2024).

## **EDUCATION AND EXPERIENCE REQUIREMENTS:**

1. A baccalaureate degree from an accredited college or university, **with** 30 semester credits in the physical and/or biological sciences, i.e., biology, botany, chemistry, geology, physics, physiology, and zoology; of which not more than 12 semester credits may be in the applied sciences, i.e., environmental technology, sanitation technology, medical technology, public health, infection control or food science; **or** 

2. An associate degree from an accredited college or university, **with** 15 semester credits in the physical and/or biological sciences, of which not more than 6 semester credits may be in the applied sciences, **and** five years of satisfactory, full-time experience as a public health technician assisting sanitarians and engineers in carrying out the various elements of prevention and control programs affecting the public's health **and** satisfactory completion of a public health training course approved by the New York State Health Department.

**Note**: All applicants must enter each college course completed in the physical and/or biological sciences and in the applied sciences (if applicable) on the online Education and Experience Exam. You must list each course for which you wish to be evaluated for credit on your Profile page in the Online Application System (OASys) by logging into your OASys account and navigating to your Dashboard, then your Profile tab at www.nyc.gov/examsforjobs.

The education requirement must be met by January 31, 2025. The experience requirement must be met by the last day of the Application Period (September 24, 2024).

The college or university must be accredited by regional, national, professional, or specialized agencies recognized as accrediting bodies by the U.S. Secretary of Education and by the Council for Higher Education Accreditation (CHEA).

If you were educated outside the United States, you must have your foreign education evaluated to determine its equivalence to education obtained in the United States. This is required only if you need credit for your foreign education in this examination. For more information see the Foreign Education Evaluation Guide in the Required Information section.

During the Education and Experience Exam (EEE), you may answer questions about your experience. If your experience was on a part-time basis working less than 35 hours per week, you will need to convert your part-time experience to full-time experience using the formula below. Once you have determined your full-time experience equivalent, use this amount to answer questions about your experience.

(number of hours worked per week/35) x (number of months worked)

For example, if you worked at a job for 21 hours per week for 12 months, you would make the following calculation:  $21/35 \times 12 = 7.2$  months.

You have until midnight Eastern time on the last day of the Application Period (September 24, 2024) to clearly specify in detail all of your relevant education and experience and Final Submit your Education and Experience Exam in the Online Application System (OASys). Once you Final Submit your Education and Experience Exam in OASys, you will not be permitted to submit new or additional information on your Education and Experience Exam online.

If you do not Final Submit your Education and Experience Exam in OASys by midnight Eastern time on the last day of the Application Period (September 24, 2024), your examination will be considered incomplete, you will not receive a score, you will not be invited to subsequent portions of this examination (if applicable), and your application fee will not be refunded.

You will not receive credit for education which you obtain after January 31, 2025 or experience which you obtain after the end of the Application Period (September 24, 2024).

**Medical Requirement:** Medical guidelines have been established for the position of Public Health Sanitarian. Candidates will be examined to determine whether they can perform the essential functions of the position of Public Health Sanitarian. Where appropriate, a reasonable accommodation will be provided for a person with a disability to enable him or her to take the examination, and/or to perform the essential functions of the job.

Drug Screening Requirement: You must pass a drug screening in order to be appointed.

## **Residency Requirement Advisory:**

Under New York City Administrative Code Section 12-120, you might need to be a resident of the City of New York within 90 days of the date you are appointed to this position. Since residency requirements vary by title, appointing agency and length of service, consult the appointing agency's personnel office at the time of the appointment interview to find out if City residency is required.

## **English Requirement:**

You must be able to understand and be understood in English.

## **Proof of Identity:**

Under the Immigration Reform and Control Act of 1986, you must be able to prove your identity and your right to obtain employment in the United States prior to employment with an agency under the jurisdiction of the Commissioner, Department of Citywide Administrative Services.

## **HOW TO APPLY:**

If you believe you meet the requirements in the "How to Qualify" section, apply using the Online Application System (OASys) at <a href="https://www.nyc.gov/examsforjobs">www.nyc.gov/examsforjobs</a>. Follow the onscreen application instructions for electronically submitting your application, payment, and completing any required information. A unique and valid email address is required to apply online. Several internet service providers, including but not limited to Google, Yahoo!, AOL, Outlook.com, and Mail.com offer free email addresses. All new OASys accounts require verification before a candidate can apply to ensure the accuracy of candidate information. Verification is instantaneous for most accounts and you will receive a confirmation email with instructions to activate your account. For any account creation issues, you will receive onscreen prompts to contact DCAS. This review may require up to two (2) business days to be reviewed and resolved. Please keep this information and the application period deadline in mind when creating your account.

The following methods of payment are acceptable: major credit card, bank card associated with a bank account, or a prepaid debit card with a credit card logo which you may purchase online or at various retail outlets. If you are receiving or participating in certain forms of public assistance/benefits/programs, or are a veteran, you may qualify to have the application fee waived. ## **REQUIRED INFORMATION:**

- 1. **Application for Examination:** Follow the online instructions, including those relating to the payment of fee and, if applicable, those found in the Special Circumstances Guide.
- 2. **Education and Experience Exam:** Fill out all the required sections displayed onscreen (if applicable). You will have until midnight Eastern time on the last day of the Application Period (September 24, 2024) to clearly specify in detail all of your relevant education and experience on your Education and Experience Exam and submit it in the Online Application System (OASys).

If you do not Final Submit your Education and Experience Exam in OASys by midnight Eastern time on the last day of the Application Period (September 24, 2024), your examination will be considered incomplete, you will not receive a score, you will not be invited to subsequent portions of this examination (if applicable), and your application fee will not be refunded.

3. Foreign Education Evaluation Guide: (Required only if you need credit for your foreign education to meet the education and experience requirements): If you were educated outside the United States, you must have your foreign education evaluated to determine its equivalence to education obtained in the United States. The services that are approved to make this evaluation are listed on the Foreign Education Evaluation Guide which is located on the DCAS website at <a href="https://www1.nyc.gov/assets/dcas/downloads/pdf/employment/foreigneducation.pdf">https://www1.nyc.gov/assets/dcas/downloads/pdf/employment/foreigneducation.pdf</a>. When you contact the evaluation service, ask for a "course-by-course" evaluation (which includes a "document-by-document" evaluation) of your foreign education. You must have one of these services submit its evaluation of your foreign education directly to the Department of Citywide Administrative Services no later than eight weeks from the last day of the Application Period (September 24, 2024).

## THE TEST:

The multiple-choice test will be given at a computer terminal. Your score on this test will be used to determine your place on an eligible list. You must achieve a score of at least 70% to pass the test. The multiple-choice test is designed to assess the extent to which candidates have certain abilities determined to be important to the performance of the tasks of a **Public Health Sanitarian**. Task areas to be tested are as follows: conducts inspections to protect public health, avoid imminent health hazards and to enforce pertinent laws, rules and regulations; investigates complaints regarding nuisances, unsafe and unsanitary conditions; investigates the status of permits and licenses for workers, contractors and establishments under jurisdiction of the NYC Health Code; instructs operators in establishments under permit or jurisdiction of the NYC Department of Health and the public in principles of sanitary practices, vermin control, and other areas of public health; collects samples of materials, such as water, food, dust and paint, for laboratory analysis; and writes reports to communicate findings of inspections.

The test may include questions on knowledge of behavioral, social, and cultural influences affecting public health inspection, customer and personal services, safe working practices and procedures, health codes of the City of New York, proper use of tools, summons issuance and violation issuance guidelines, written technical material, maintaining records, and other related areas.

The test may also include questions requiring the use of any of the following abilities:

**Deductive Reasoning -** The ability to apply general rules to specific problems to produce answers that make sense. **Example**: A Public Health Sanitarian may use this ability to apply a section of the Health Code to determine whether a particular observation is a violation.

**Inductive Reasoning** - The ability to combine separate pieces of information or specific answers to problems to form general rules or conclusions; to think of possible reasons for why things go together. **Example**: A Public Health Sanitarian may use this ability to determine the cause of certain conditions at inspection sites.

**Information Ordering** - The ability to correctly a rule or set of rules or actions in a certain order. The rule or set of rules used must be given. The things or actions to be put in order can include numbers, letters, words, pictures, procedures, sentences, and mathematical or logical operations. **Example**: A Public Health Sanitarian may use this ability to determine which order of steps to take when conducting inspections or issuing violations.

**Mathematical Reasoning** - The ability to understand & organize a problem then select a mathematical method or formula to solve the problem. It encompasses reasoning through mathematical problems to

determine appropriate operations that can be performed to solve problems. **Example**: A Public Health Sanitarian may use this ability to calculate the area of an irregularly shaped room during an inspection.

**Number Facility** - The ability to add, subtract, multiply, and divide quickly and correctly. **Example**: A Public Health Sanitarian may use this ability when computing inspection results.

**Problem Sensitivity** - The ability to tell when something is wrong or likely to go wrong. This includes being able to identify the whole problem, as well as elements of the problem. **Example**: A Public Health Sanitarian may use this ability when inspecting a facility with multiple violations.

**Spatial Orientation** - The ability to tell where you are in relation to the location of some objects or to tell where the object is in relation to you. **Example**: A Public Health Sanitarian may use this ability to determine which order to visit inspection sites based on where they are located to minimize the time spent commuting.

**Time Sharing** - The ability to shift back and forth between two or more sources of information. **Example**: A Public Health Sanitarian may use this ability to refer to two different sets of health codes discerned by the type of establishment being inspected while determining compliance with safety standards.

**Visualization** - The ability to imagine how something would look when it is moved around or when its parts are moved or rearranged. It requires the forming of mental images of how patterns or objects would look after certain changes, such as unfolding or rotation. One has to predict how an object, set of objects, or pattern will appear after the changes have been carried out. **Example**: A Public Health Sanitarian may use this ability to recall the room layout of an inspection site to determine which alteration is doable within the space to address a violation.

**Written Comprehension** - The ability to understand written sentences and paragraphs. **Example**: A Public Health Sanitarian may use this ability when interpreting a section of the NYC Health Code and other important written materials.

**Written Expression** - The ability to use English words or sentences in writing so that others will understand. **Example**: A Public Health Sanitarian may use this ability to prepare well-written official reports.

Certain questions may need to be answered on the basis of documents or other information supplied to the candidates on the date of the multiple-choice exam.

#### **EXAM SITE ADMISSION:**

Your Admission Notice will be available on your Dashboard in OASys 14 days before the first date on which testing is expected to begin. Test site assignments will take your address into consideration, but nearness to your address cannot be guaranteed.

**Warning**: The use of electronic devices at the test site is prohibited. This includes phones, smart watches, cameras, e-cigarettes, vape pens and/or other portable media or electronic devices. Any such items brought to the test site will be placed in a Yondr pouch and magnetically sealed until after the exam event (Examination, Protest Review Session, TVB session). The use of headphones and earbuds are also prohibited. Only basic, hand-held calculators with addition, subtraction, multiplication, and division functions are permitted—no additional features. Devices with keyboards, word processing, or data recording capabilities are banned and will be placed in a Yondr pouch if brought to the testing site. If you use any of these prohibited devices, or remove them from your Yondr pouch before being authorized to do so, whether in the testing area, restroom, hallway, or other location at the test site, at any time before, during or after the exam event, your test score will be nullified, you will be disqualified from taking any civil service tests for up to five years, and your application fee will not be refunded.

You are also not permitted to use on site any medical assistive devices, including those that give notifications or alerts, or that vibrate, without the prior express written authorization of DCAS. You can contact DCAS by email at: testingaccommodations@dcas.nyc.gov.

You may not have any other person, including children, present with you while you are being processed for or taking the test, and no one may wait for you inside of a Computer-based Testing & Application Center while you are taking the test.

Required Identification: You are required to bring one (1) form of valid (non-expired) signature and photo bearing identification to the test site. The name that was used to apply for the exam must match the first and last name on the photo ID. A list of acceptable identification documents is provided below. If you do not have an acceptable ID, you may be denied testing. Acceptable forms of identification (bring one) are as follows: State issued driver's license, City or State issued identification card, IDNYC, US Government issued Passport, US Government issued Military Identification Card, US Government issued Alien Registration Card, Employer ID with photo, or Student ID with photo.

**Leaving**: You must leave the test site once you finish the test. If you leave the test site after being fingerprinted but before finishing the test, you will not be permitted to re-enter. If you disregard this instruction and re-enter the test site, you may not receive your test results, your test score may be nullified, and your application fee will not be refunded.

## CHANGE OF MAILING ADDRESS, EMAIL ADDRESS, AND/OR TELEPHONE NUMBER:

It is critical that you promptly notify DCAS of any change to your mailing address, email address and/or phone number. #### THE TEST RESULTS:

If you meet the education and experience requirements and pass the multiple-choice test, your name will be placed in final score order on an eligible list, you will be given a list number and you will be notified by email of your test results. The eligible list determines the order by which candidates will be considered for appointment. If you meet all requirements and conditions, you will be considered for appointment if your name is reached on the eligible list. Once a list has been established, it will typically remain active for four years. If you believe that your test part was rated incorrectly, you may submit an appeal of your score to DCAS, Committee on Manifest Errors, through the Online Application System (OASys). Your appeal must give specific reasons why your score should be higher. Your appeal may result in a higher or lower rating.

## **SPECIAL ARRANGEMENTS:**

## Late Filing:

If you are currently provisionally employed by the City of New York, consult **your agency's Personnel Office/Human Resources** to determine the procedure for filing a late application if you meet one or more of the following conditions:

- You are provisionally employed in the title for which the examination is administered and were absent from work for at least one-half of the application period and cannot apply for reasons such as vacation, sick leave, or military duty; or
- You were appointed provisionally to the title for which the examination is administered after the application period closed but before the date on which testing is expected to begin.

## Make-up Test:

You may apply for a make-up test if you cannot take the test on the regular test date(s) for any of the following reasons:

- 1. being ordered to military duty; or
- 2. compulsory attendance before a court or other public body or official having the power to compel attendance; or
- 3. on-the-job injury or illness caused by municipal employment where you are an officer or employee of the City; or
- 4. absence from the test within one week after the death of a spouse, domestic partner, parent, parent-in-law, sibling, child or child of a domestic partner where you are an officer or employee of the City; or
- 5. a clear error for which the Department of Citywide Administrative Services or the examining agency is responsible; or
- 6. a temporary disability; or
- 7. pregnancy, childbirth or a related medical condition.

## **ADDITIONAL INFORMATION:**

Selective Certification for License, Special Education, and/or Special Experience: If you have the license, education, and/or experience listed in one or more areas below, you may be considered for appointment to positions requiring this license, education, and/or experience through a process called Selective Certification. If you qualify for Selective Certification, you may be given preferred consideration for positions requiring this license, education, and/or experience. Follow the instructions given to you on the day of the multiple-choice test to indicate your interest in such Selective Certification. Your license, education, and/or experience will be checked by the appointing agency at the time of appointment.

Selective Certification For Driver License (MVO): Possession of a motor vehicle Driver License that is valid in the State of New York. Your Driver License will be checked by the appointing agency at the time of appointment. If you are appointed through Selective Certification, you must maintain your motor vehicle Driver License for the duration of your employment.

Selective Certification for Positions Requiring Experience Inspecting Lead Paint and/or Lead Exposure (LEA): At least two (2) years of full-time satisfactory experience conducting lead paint inspections, hazard or clearance dust wipe collection and/or lead risk assessments to gather information on potential lead exposures.

Selective Certification for Municipal Government Experience (MGE): At least two (2) years of full-time satisfactory experience working within a municipal government in a similar position, which provides

services for a city with over 1 million in population.

Selective Certification for Positions Requiring Experience for Inspection in a School, Child Care, Day Camp or Youth Center Setting (ISE): At least two (2) years of full-time satisfactory experience conducting periodic inspections of schools, child care settings, day camps or youth center settings, involving visual inspection of premises, review of documents and records, field testing and sample collection.

Selective Certification for Positions Requiring Experience Inspecting Water Samples (LRA): At least two (2) years of full-time satisfactory experience inspecting and collecting drinking water samples and/or beach samples for laboratory analysis.

Selective Certification for Positions Requiring Experience Inspecting Pest Infestations (IPI): At least two (2) years of full-time satisfactory experience inspecting private properties, parks, green streets, business establishments, multi- family housing campuses, stores, schools, catch basins, sidewalks, tree pits and any other applicable city areas for pest infestations and/or environmental issues conducive to pest

Selective Certification for Positions Requiring Experience with Animals (AME): At least two (2) years of full-time satisfactory experience inspecting animal handling facilities, private residences and residential apartment buildings to ensure health and safety in regard to the presence and/or ownership of animals.

Selective Certification for Positions Requiring Experience Reviewing Food and Nutritional Information (QFO): At least two (2) years of full-time satisfactory experience reviewing menus, and menu boards and food and dining information to observe compliance with nutritional requirements aimed at reducing and combating chronic diseases and obesity.

Selective Certification for Foreign Language and/or American Sign Language: If you can speak Albanian "ALB", Arabic "ARA", Bengali "BEN", Bosnian/Serbo-Croatian "SRC", Chinese (Cantonese) "CAN", Chinese (Mandarin) "MAN", French "FRE", Greek "GRE", Haitian/Creole "CRE", Hindi "HIN", Italian "ITA", Japanese "JPN", Korean "KOR", Polish "POL", Portuguese "POR", Russian "RUS", Spanish "SPA", Tibetan "TIB", Urdu "URD", Vietnamese "VIE", West African Languages (e.g., Ibo "IBO", Swahili "SWA", Yoruba "YOR"), Yiddish "YDD" and/or you know American Sign Language "ASL", you may be considered for appointment to positions requiring this ability through a process called Selective Certification.
