

Custody Change On A Child Support Case

Is your child now living with you, but didn't before and a child support order exists?

Follow these easy steps:

1. File Two Petitions in The Family Court

- Modification petition
Terminates or suspends the child support order when a custody change is permanent or temporary.
- Order to Show Cause
Suspends your order while you wait for the hearing.

File immediately: The change only goes back to the petition filing date.

2. Prepare for Court

Provide proof to the Family Court documenting who the child lives with.

Bring as many documents as you can:

- Copy of lease showing the child(ren) lives with you
- A doctor's not showing a change in the primary parent
- Copy of your custody order
- Copy of school record

3. OCSS Will Receive Your New Court Order from Family Court and Update Your Child Support

Note: If your child was adopted tell OCSS and we will stop the child support order.
