## FIRST RENEWAL OF MEMORANDUM OF UNDERSTANDING BETWEEN THE NEW YORK CITY HUMAN RESOURCES ADMINISTRATION AND THE NEW YORK CITY DEPARTMENT OF PROBATION

## WITNESSETH:

WHEREAS, the Parties entered into a Memorandum of Understanding ("the MOU") whereby Contractor allowed the New York City Municipal Identification Card ("IDNYC") Program to operate from and engage with applicants at its Adult Operations sites in the Bronx, Brooklyn, Manhattan, Queens, and Staten Island; and

WHEREAS, the term of the MOU was from November 1, 2014 through December 31, 2016, with the option to renew for three (3) additional, one (1) year terms at HRA's option with the consent of DOP; and

WHEREAS, the Parties now wish to exercise their first option to renew the MOU under the same terms and conditions except as modified herein;

NOW, THEREFORE, the Parties have agreed and do agree as follows:

- Pursuant to the terms of the MOU, the Parties exercise their right and option to renew the MOU and hereby renew the MOU for the period from January 1, 2017, until December 31, 2017, unless sooner terminated pursuant to the terms of the MOU.
- 2. For purposes of this First Renewal, with respect to Municipal ID Program Intake Locations in Exhibit A of the MOU, only the following Municipal ID Program Intake Locations of Exhibit A will be renewed: Bronx Adult Operations- 198 E 161<sup>st</sup> St Bronx NY 10451 and Manhattan Adult Operations- amended herein pursuant to Article XI of the MOU to reflect an updated address of: 100 Centre Street, 14<sup>th</sup> Fl. New York, NY 10013.
- 3. Except as expressly amended by this First Renewal, the terms and conditions of the MOU and any modifications and Renewals thereto remain unchanged and in full force and effect.
