FIRST RENEWAL OF MEMORANDUM OF UNDERSTANDING BETWEEN THE NEW YORK CITY HUMAN RESOURCES ADMINISTRATION AND THE NEW YORK CITY DEPARTMENT OF HEALTH AND MENTAL HYGIENE

THIS FIRST RENEWAL ("First Renewal"), dated the 29th of December of 2016, between the City of New York acting through the Department of Social Services/Human Resources Administration ("HRA"), with offices located at 150 Greenwich Street, New York, New York 10007 and the New York City Department of Health and Mental Hygiene ("DOHMH" or "Contractor"), with offices at 42-09 28th Street, Long Island City, NY 11101 (hereinafter "the Parties").

WITNESSETH:

WHEREAS, the Parties entered into a Memorandum of Understanding ("the MOU") whereby Contractor allowed the New York City Municipal Identification Card ("IDNYC") Program to operate from and engage with applicants at its location at 34-33 Junction Boulevard, Jackson Heights, Queens 11372; and

WHEREAS, the term of the MOU was from March 1, 2015 through June 30, 2016, with the option to renew for three (3) additional, one (1) year terms; and

WHEREAS, the Parties now wish to exercise their first option to renew the MOU under the same terms and conditions except as modified herein;

NOW, THEREFORE, the Parties have agreed and do agree as follows:

- 1. Pursuant to the terms of the MOU, the Parties exercise their right and option to renew the MOU and hereby renew the MOU for the period from July 1, 2016, until June 30, 2017, unless sooner terminated pursuant to the terms of the MOU.
- 2. The total amount not-to-exceed under this First Renewal shall be \$85,000.00. The total costs shall be paid in accordance with the Budget Projection attached hereto as Exhibit A.
- 3. Except as expressly amended by this First Renewal, the terms and conditions of the MOU and any modifications and Renewals thereto remain unchanged and in full force and effect.
