Convene Commission to Review Reports and Advisory Boards and Produce Recommendations

Overview

- The Director of the Mayor's Office of Operations is required to convene a Report and Advisory Board Review Commission.
- The Commission will be composed of representatives from OMB, DoITT, City Council, and the Law Department.
- Existing lists of reports will be gathered and reviewed.
- Existing lists of advisory boards will be gathered and examined.
- The Commission will help to advise on reports and advisory boards during monthly meetings.
- Second round of agency engagement to be sought.
- The Commission is aiming to release its findings this Winter.

Considerations (Reports)

Commission members reviewed reporting requirements for the following attributes (required by the Charter):

- Usefulness Does it provide useful information in evaluating program results or other activities? Does it provide useful information for assessing effective management of City resources?
- Redundancy Does this information exist somewhere else? Is it wholly or partially duplicative of the subject matter of another mandated report?
- Relevance In light of changing circumstances, is this report still necessary?
- Benefit Is it worth the cost of production?

As well as (not required by the Charter):

Transparency – Is it easy to find? Does it promote public knowledge?

Goal of reports review by Commission is to solicit and understand perspective of members having a citywide purview, as a preliminary step in the process before engaging agencies.



Scoring Rubric

- A scoring rubric allows us to prioritize reports for in-depth review.
- All Commission members reviewed master list by answering questions below.
- Operations consolidated responses.


Findings

Short List

- From 834 total, 232 reports and other materials were flagged by Commission members as priorities for further review.
 - Uniqueness and relevance were top concerns.
 - Agencies with most flagged reports/materials:
 - DEP (22)
 - DOHMH (15)
 - HPD (15)
 - DOT (12)
 - DOE (8)
 - DSNY (8)
 - NYPD (7)
- Further review includes:
 - Agency feedback on all reports.
 - Information gathering.



Uniqueness and relevance were top concerns of reviewers

Agency	Report	Rationale	Ad. Code
DOT	Interagency Road Safety Plan	Required every five years. Material overlaps with annual Vision Zero reports.	Title 19, Section 184
DSNY	Borough Snow Plans	Not unique and possibly not relevant. Material covered in DSNY annual report or does not necessarily need annual updates.	Title 16, Section 124.1(b)
NYPD	Firearms Discharge Report	Now included in Use of Force Report.	Title 14, Section 150(b)
