Item #1: C 230307 ZMQ, N230308ZRQ 23-01 Steinway Rezoning
Applications filed on behalf of Efraim Realty, the applicant, to rezone R5D to
R6A/C1-4 the four-corner intersection at 23rd Avenue and Steinway Street and to

establish a Mandatory Inclusionary Housing (MIH) area with Options 1 and 2 across the project area. These actions will facilitate construction of a six-story residential

building with 22 units and ground floor commercial in Astoria.

Applications filed on behalf of 30-11 12th Street LLC, the applicant, to rezone portions of two blocks currently zoned R4-1, R5B and R6B to R6A and R6A/C2-3 that are located at the intersection of 30th Avenue and 12th Street and to establish a Mandatory Inclusionary Housing (MIH) area with Options 1 and 2 across the project area. These actions will facilitate construction of an eight-story mixed-use building with 86 dwelling units and ground floor retail.
