Item #1: The Department of Transportation (DOT) will provide an update and speak about Northern Boulevard Bus Safety Improvement Project. The project will compliment a suite of pedestrian safety improvements DOT previously installed along the corridor, including pedestrian islands, Lead Pedestrian Intervals, and painted curb extensions. The benefits of this design will:

- Improve bus speeds and travel times
- Prioritize public transit, a sustainable transportation mode
- The offset bus lane allows bus priority while preserving curbside uses:
 - Parking
 - Commercial loading
 - Traffic calming, pedestrian refuge (i.e. curb extensions)
 - Allows buses to pass a stopped bus in the stop
 - Maintain outdoor dining setups
