## II. REPORT OF THE CHAIRPERSON

 Mr. Mark Holmes Chief Officer of Operations Planning for MTA presented at the Queens Borough Cabinet Meeting. The Queens Bus Network Redesign: The Metropolitan Transit Authority (MTA) have a fast forward plan.

Priorities: Transform the subway

Reimagine the bus network

Accelerate Accessibility
Engage and empower employees

Foundations: Agility & accountability

Safety, security & resilience

Customer service & communication

 The Queens Bus networks is being reimagined because the Queens Bus Network has not substantially changed in decades; many follow old trolley routes. As the customers' needs change, MTA must change with them. Queens' local bus ridership has declined 2.5% between 2016 and 2017. Queens' express bus ridership is down 1% between 2016 and 2017. Bus speeds continue to decline at 3% slower since 2015 at 8.9 MPH.

# Elected Officials and their Representatives were acknowledged by the Chairperson.

## Commanding Officer Fortune, 103rd Precinct

- There has been an increase in overall crime by 15%, felony assaults, stolen cars, and domestic violence is what is driving the numbers up. Rapes up 5 vs. 2; 4 of the 5 incidences are domestic violence related; 2 of the 5 are closed by arrests and the remaining cases that are open are being handled by their Special Victims Unit. Felony assaults are also during the crime rate up significantly 20 vs 22, an even 2% increase 55% more than half of the incidences are domestic violence related, 25 of those 40 are closed due to arrests, continue through the domestic violence office to provide outreach to continually follow up with the victims of these crimes. Robberies down 41%, 19 vs. 32., Burglaries 10 vs. 10; 2 incidents burglary patterns in the vicinity of 165 Street and Hillside; both incidents re closed due to arrests. Stolen cars and GLA are up 11 vs. 4; 5 of the incidents all involved vehicles with keys either left in the ignition, door lock, or just running; please secure your vehicles and take your keys with you. Grand larcenies are down 3%; try to drop off your mail as close to pick up time as possible and deliver directly to your post office.
- There was a homicide on Saturday, April 13, 2019 approximately 6:04 a.m. at 108-49 Guy R. Brewer Blvd.; male black 48 years old shot numerous times while sitting in a car. Pronounced deceased at Jamaica Hospital; incident is narcotics related. Looking for help in identifying the perpetrator; looking for a white 2014 Infiniti, unknown model with a sunroof. Pictures of the vehicle have been posted on their Facebook and Twitter pages. #### <u>PRESENTATION</u>

Roy Koshee, Education and Engagement Specialist, NYC Conflict of Interest Board

- We are city agency responsible for the Conflict of Interest law; these laws applies to all city employees. Under the law, as per the City Charter, Community Board members are considered to be employees. This training is mandatory, not only for Community Board members, but for anyone who is considered employed by the City of New York.
- The Conflict of Interest Law is set forth in Chapter 16 of the New York City Charter, it deals with
  the intersection between a public City job and our private interest. Board Members were
  appointed to the board because they are an important member of the community, and have a
  private interest in the community. This law ensures that Community Board members are not
  misusing their position as a Community Board member to benefit their personal, private interest.

- The rule about voting in general, is that Community Board members cannot vote on anything that may net a direct financial benefit to them. Community Board members that are employed at a City agency cannot vote on matters that involve their city agency.
- Former Community Board members cannot represent a private financial interest in their own community for an entire year.

# Ed Palmer, Manager/Director for MCR Properties at the TWA Hotel

- We are restoring this amazing property, TWA Flight Center at JFK at Terminal 5, looking to hire almost 800 individuals. We want the Queens community to be involved in this project, want to employ individuals who are local in the community.
- It has been about 3 years since we first put the shovel in the ground, it took a lot of effort and support, and I thank you. We are the first in airport property at JFK; attached to Terminal 5 which is JetBlue. JFK is the 5<sup>th</sup> largest operating Airport in the United States; there are 170,000 people that go through the airport a day. We are hiring positions in all sorts of facets, sales, revenue management, finance, culinary, housekeeping, rooms, front desk, etc. The website to apply is, TWAhotel.com/careers; someone will call you in no more than 48 hours.
- They will be supporting some of the local parks in the community, reached out and had some of the local parks come and do a tour of the hotel. His management is looking to give back to the community.

#### III COMMITTEE REPORTS

# Economic Development Committee: Represented by Glenn Greenidge, Chairperson

- There was a presentation on Jamaica Center Bid and small business services concerning the community development needs assessment. The boundaries consist of Jamaica Ave, between Sutphin Blvd. and 170; Hillside Ave, between 144<sup>th</sup> and 169<sup>th</sup>; and 165<sup>th</sup> Street between Archer Ae and Hillside, and Sutphin Blvd. between 94<sup>th</sup> Ave and Hillside Ave. There are over 1,000 businesses, over 800 active store fronts, and 535 consumers, and 474 property owners. The most common businesses, the top 5 reported from the survey were clothing and shoe stores, profession and medical services, spas, salons, and beauty supply; limited services restaurants, pharmacies, optical, and health stores. 89% of businesses surveyed were renters, if you don't own the property in your commercial area, you cannot dictate who comes in. It is important for everyone to look at owning property on commercial strips in their neighborhoods. Many of the individuals surveyed said they would like to see department stores and chain stores, healthier food options, more restaurants and eating options, art, entertainment, and community centers.
- Every Thursday from 5:00 to 7:00 p.m. at the Air Train Terminal we have live jazz; please come out and enjoy. The Sutphin Blvd. Bid is having an event on May 9, 2019, where we are honoring some mothers from the community.

## Education Committee, Represented by Geri-Taylor Brown

- Congratulated Ms. Aracelia Cook, who will be graduating with her Master's Degree,
- The Committee decided that they will not be meeting on a monthly basis, however, they will meet every other month. If there is an urgency that they need to meet, they will do a telephone conference (conference calls are not permitted per Borough Hall, because public cannot attend)).
- Report from CDC 29, which is sponsoring their 50<sup>th</sup> annual Science Fair for children on June 1, 2019 at the I.S. 192 building from 9:30 a.m. to 1:00 p.m.
- They did have a discussion about Charter Schools, and about a concern that maybe they need to offer some other options in the community; at the June 18, 2019 they will be inviting the Director of Charter Schools to attend the meeting to discuss the possibility of having a Charter School, the Committee will write a proposal for in a grass roots way for their community.
