### II. REPORT OF THE CHAIRPERSON

#### III. DISTRICT MANAGER REPORT

- The United States Census 2020 is approaching. As soon as you receive your application please respond as soon as possible. We must do better than 2010. Remember it's our community that will be affected if we don't respond to the application once we receive it.
- NYC Department of Sanitation is on Winter Schedule known as "Night Flow", the winter schedule enables the Department to have pre-scheduled staff on hand to respond to snow and ice condition around the clock. You may notice your trash and recycling collected at a slightly different time during the season. This scheduled shift will last through mid-April.
- Who is responsible for cleaning snow and ice from the sidewalk? Owners, lessees, tenants, or other occupants are responsible for cleaning snow and ice from sidewalks. Snow and ice should not be pushed into a street or crosswalk.
- When to clear your sidewalk if the snow stops falling between:
  - 7:00am 4:59pm you have 4 hours to shovel
  - 5:00pm 8:59pm you have 14 hours to shovel
  - 9:00pm 6:59am you have until 11:00am the next day to shovel

Fines begin at \$100 for the first offense. By the third offense you'll have a \$250 penalty

# Elected Officials and their Representatives were acknowledged by the Chairperson.

### Deputy Inspector Bohannon, 113th Precinct

- Spent the last 7 years in Jamaica, at the 103<sup>rd</sup>, 113<sup>th</sup>, and 106<sup>th</sup> Precincts. He realizes that there are many issues in the community, and he is willing to work with the community to progress forward with what the Former Inspector (Inspector O'Sullivan) had put in place. - There were a couple acts of violence over the last month, a homicide that occurred at the Baisley
  Houses and a stabbing death over by 166<sup>th</sup> and Foch Blvd. Both incidences are ongoing
  investigations. There was an arrest made on the second stabbing that occurred at 166<sup>th</sup> and Foch
  Blvd.
- The precinct has been experiencing a lot of shootings in the precinct, since July 12, 2019 there have been 15 shooting incidences. We have noticed a lot of gang violence. The Inspector will make it his mission, pairing up with what Inspector O'Sullivan put in place, in regards to getting those gang members. That .001% of the population that is responsible for 99% violence; we will make sure these individuals are placed into custody for the crimes they are committing. Six of our recent shootings have been gang related. The Precinct will keep the NCO's in place, the school post will remain, and you will see officers at school dismissal. Officers will remain at other areas throughout the command where there is some loitering and other issues. The Precinct will be getting 11 new officers on December 27, 2019.
- There will be a Gun Buy back at New Jerusalem Church on December 21, 2019.

### Deputy Inspector Tavalaro, 103rd Precinct

- I have worked hand in hand with Deputy Inspector Bohannon since we were both Lieutenants. Spent about 4 years in the gang division prior to going back to the 101st Precinct, where he took over as the Commanding Officer. Spent 2 ½ years at the 101st precinct; there are similar issues in relation to the 103rd Precinct; a lot of gang violence. There was a total of 9 gangs in the Far Rockaway area. There are 12 gangs in the 103rd Precinct. The Deputy Inspector can be reached at 917-692-8874 or at Vincent.tavalaro@nypd.org.
- In the three weeks that he has been at the 103<sup>rd</sup> Precinct, there was the non-fatal shooting of a 16 year old female in front of the New Dawn High School. Fortunately, they were able to make two arrests on that incident. One was the shooter, who was charged with attempted murder; the second was an assault charge that led up to the shooting.
- There is a lot of crossover between the two precincts and, it works well from the standpoint of
  policing that he and Inspector Bohannon do have a very good working relationship because of
  the overlap.
- Attended the Town Hall meeting last week some of the issues that came up were Jamaica Ave
  and the surrounding blocks, over the course of the 3 weeks at the Precinct that has been
  predominantly the biggest issue for them. Dedicate a lot of resources, whether it is a school
  dismissal time or the overtime post that is allotted to them through the overhead commands,
  where they always dedicate additional posts to the vicinity of Jamaica Ave., Sutphin Blvd., Archer
  Ave, and the train stations.

#### **PRESENTATION**

- BSA Application #122-95-BZ. Submitted by Capell, Barnett, Matalon & Schoenfeld LLC. (152-65 Rockaway Blvd., 132<sup>nd</sup> Ave.; 134<sup>th</sup> Avenue Block: 12278, Lot: 60). The application to reopen and amend BSA Resolution 122-95-BZ to permit 24 hours/7 days a week operating schedule of a warehouse to accommodate the storage needs of JFK deliveries. Waiver of Rules to extend the term that expired on 6/11/16.
- 2. BSA Application #523-58-BZ. Submitted by Glen V. Cutrona AIA. (117-30 Farmers Blvd., SWC Baisley Blvd. Block: 12448, Lot: 31). This application is filed to obtain an extension of term and to continue the existing gasoline service station with accessory uses as previously approved under the BSA calendar number referenced above. There are no new improvements proposed to the existing premises. The application is being sought to obtain an extension of term for a period of (10) years. The waiver of rules of practice and procedure is necessary because the tenant was unaware of his obligation to obtain a new Certificate of Occupancy.

CERT is the Community Emergency Response Team, they are trained by NY City Fire Department, NYC Police Department, and Office of Emergency Management to help out neighbors in case of an emergency.
