A Word from CB8...

Dear Resident,

If you are a homeowner, you will receive a Notice of Property Value (NOPV) from the Department of Finance.

This notice breaks down the estimate of your property taxes for the upcoming 2026 Fiscal Year that starts on July 1, 2025. This includes any exemptions that are or will be applied to the property such as: Senior Citizen's Homeowner's Exemption (SCHE), Disabled Homeowner's Exemption (DHE), School Tax Relief (STAR) and Enhanced STAR. Please review it and make sure that it is accurate.

If you notice any missing exemption (s) that you had previously or exemptions that you recently applied for but not received, please contact us for assistance. There is a limited time to make the corrections before you receive your property tax bill for the next fiscal year.

He informed everyone that the New York City Council passed the "City of Yes" bill. This was not the outcome many had hoped for. He stated he voted no.

New York City is undoubtedly facing a housing crisis, and he agrees that we must find solutions to meet the growing demand. However, his first responsibility is to represent our voice. Over the past year, he heard from hundreds, if not thousands, of constituents who expressed serious concerns about how this bill would dramatically change the character of our communities.

He briefly discussed some of the changes that will occur. He thanked those who have contacted his office and made their voices heard throughout this process. Health Minutes with Dr. Penny Stern

December is a month of many celebrations but it is also National Impaired Driving Prevention Month. Impaired driving is a leading cause of traffic accident, injuries and deaths. In general, impaired driving is especially prevalent on holidays and on weekends. New Year's Eve is the deadliest day of the year in terms of being on the road. Statistics indicate that driving under the influence spikes 129% over the average on New Year's Eve. During December, you can expect more in the way of sobriety checkpoints and law enforcement efforts to identify those driving impaired. Alcohol and drugs are the elements most commonly associated with impairment at the wheel but fatigue and stress have also been found to play significant roles. If you plan on celebrating away from home, plan ahead.

- Be sure to have plans to get a safe way home, in terms of transportation.
- If alcohol is being consumed by you or by others who may need a ride, call for a taxi or consider public transportation.
- If you are not consuming alcohol, volunteer to be the designated driver for others.
- If you're hosting a celebration that involves alcohol, check with your guests to make sure how they will be getting home.



All of NYC was designated a Tow Away Zone under the State's Vehicle & Traffic law in 1959. This means that any vehicle parked or operated illegally, or with missing or expired registration or inspection stickers may be towed.

On MAJOR LEGAL HOLIDAYS, stopping, standing and parking are permitted except in areas where stopping, standing and parking rules are in effect seven days a week (for example, "No Standing Anytime"). Accordingly, parking meters will not be in effect on major legal holidays.

Double-parking of passenger vehicles is illegal at all times, including street cleaning days, regardless of location, purpose or duration.

It is illegal to park within 15 feet of either side of a fire hydrant. Painted curbs at hydrant locations **DO NOT** indicate where you can park.

An occupied, illegally parked vehicle causes the same safety hazard and congestion as an unoccupied vehicle. Be responsible and park legally.

Grand Central Parkway

Traffic Pattern:

- The New York State Department of Transportation (NYSDOT) is advising motorists that there will be a change in the traffic pattern on eastbound Grand Central Parkway between **Exit 23** (Cross Island Parkway) and **Exit 24** (Little Neck Parkway) through approximately <u>December 2025</u>.
- Motorists will continue to have access to three eastbound travel lanes. The new traffic pattern will shift two eastbound traffic lanes to the left. The rightmost eastbound traffic lane on Grand Central Parkway (GCP) will be shifted right along the service road and rejoins the Grand Central Parkway (GCP) east of Cross Island Parkway (CIP) exit ramps. Motorists will continue to have access to all existing ramps connecting GCP to CIP.

Grand Central Parkway bet. Union Turnpike and Commonwealth Boulevard

Single-lane Grand Central Parkway eastbound will be closed Monday to Thursday from 10 a.m. to 2 p.m. and 10 p.m. to 5 a.m. next morning, Friday from 10 a.m. to 2 p.m. and from 11p.m. to 7 a.m. next morning, and Saturday from 10 a.m. to 3 p.m. and 11p.m. to 3 p.m. Sunday. Double-lane Grand Central Parkway eastbound will be closed Monday to Friday from 1 a.m. to 5 a.m., Saturday from 1 a.m. to 7 a.m., and Sunday from 2 a.m. to 9 a.m.. Single-lane Grand Central Parkway westbound will be closed Monday to Thursday from 10 a.m. to 3 p.m. and 10 p.m. to 5 a.m. next morning, Friday from 10 a.m. to 3 p.m. and from 11p.m. to 6 a.m. next morning, and Saturday from 10 a.m. to 3 p.m. and 10 p.m. to 3.p.m. Sunday. Double-lane Grand Central Parkway westbound will be closed Monday to Friday from 1a.m. to 5 a.m., Saturday from 1 a.m. to 6 a.m., and Sunday from 2 a.m. to 9 a.m.. Single-lane in both directions on the Cross Island Parkway in the vicinity of the Grand Central Parkway interchange will be closed Monday to Thursday from 10 a.m. to 3 p.m. and 10 p.m. to 5 a.m. next morning, Friday from 10 a.m. to 3 p.m. and 10 p.m. to 6 a.m. next morning, and Saturday from 10 p.m. to 11a.m. next morning. Double-lane in both directions on the Cross Island Parkway in the vicinity of the Grand Central Parkway interchange will be closed Monday to Friday from 1 a.m. to 5 am., Saturday from 1am to 6am, and Sunday from 2 a.m. to 9 a.m. Single or double-lane closures on the Cross Island Parkway northbound exit ramp to Grand Central Parkway westbound and Cross Island Parkway southbound exit ramp to Grand Central Parkway eastbound will also occur during these times. These closures are necessary to facilitate bridge rehabilitation and will continue through December 21, 2025.

Van Wyck Expressway

• Single-lane in both directions will be closed Monday to Friday from 10 a.m. to 2 p.m., Monday to Thursday from 10 p.m. to 6 a.m., Friday from 11:59 p.m. to 8am, Saturday from 11 p.m. to 10 a.m., and Sunday from 10 p.m. to 6 a.m.. Double-lane in both directions will be closed Monday to Thursday from 11 p.m. to 4 a.m. and Sunday from 1 a.m. to 7 a.m.. Double-lane will be closed Friday from 11p.m. to 7 a.m. for northbound and from 11 p.m. to 5 a.m. for southbound. The exit and entrance ramps along the north and southbound of the expressway may also be closed. These closures are necessary to facilitate roadway widening and will continue through July 14, 2025.

Mayor's Office of Contract Services

Starting December 30, 2024, contractors and subcontractors in New York City who are submitting bids or performing construction work on public projects must provide a copy of their Certificate of Registration from the New York State Department of Labor (DOL). This new mandate ensures compliance with the recently enacted New York State legislation, Section 220-I of the Labor Law.

How to Register:

- Compile all required materials for registration.
- Submit your application via the DOL's Contractor Registry portal.
- Acquire your Certificate of Registration.

DOL encourages all contractors and subcontractors to register as soon as possible to obtain a Certificate of Registration to avoid negatively impacting a bidding period or project schedule.
